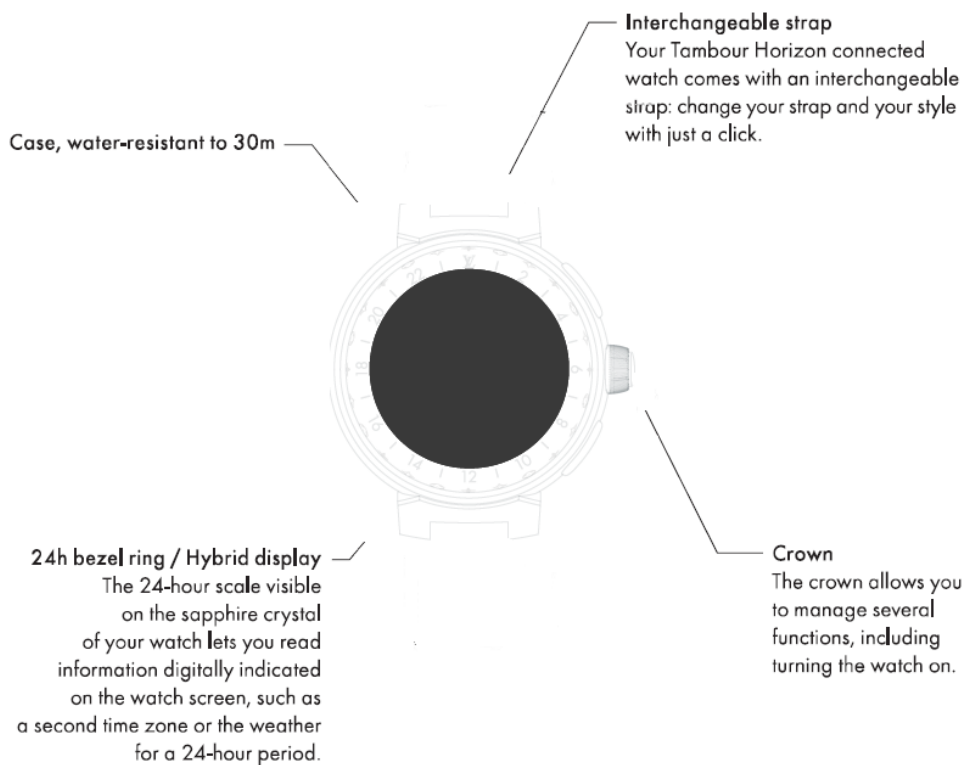

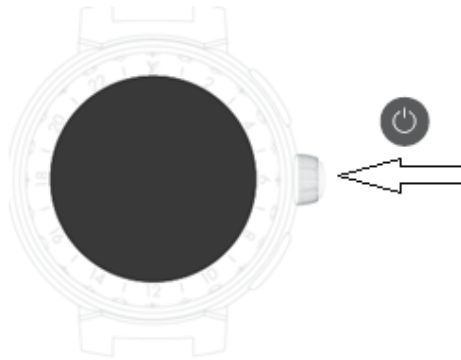

QUICK START USER GUIDE



Turning your watch on and off

To turn on your watch, press and hold the crown for three seconds.



Download the Louis Vuitton App application

Download and launch the Louis Vuitton App application to access exclusive content (dials, features, Louis Vuitton applications, and more).

This application is available:

- on the App Store or Google Play Store for most users
- or, for users who have configured their watch in Simplified Chinese, on Tencent App Gem.

Recharge the battery

Connect the cable's USB port to the charging cradle and plug the cradle onto a power source.

Position the cradle on the back of your watch, on the side with charging pins

The charger's internal magnets ensure that it is correctly positioned under the watch.

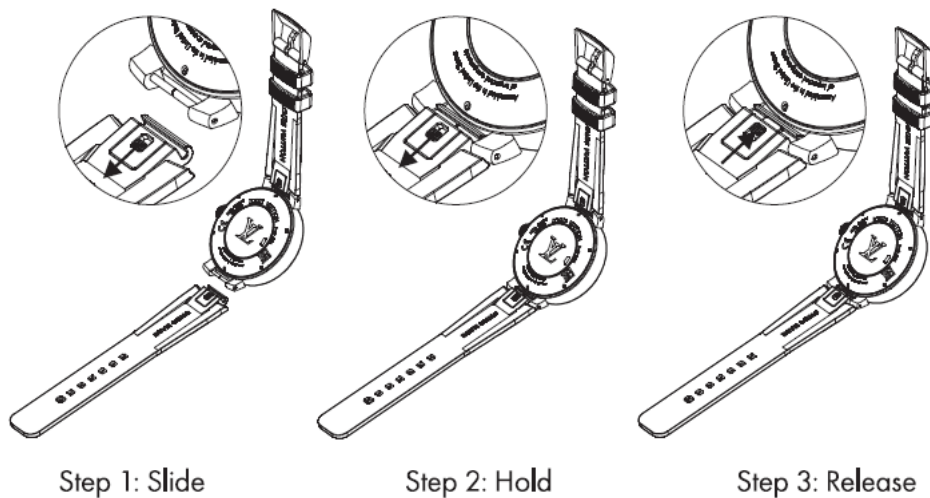
When properly positioned, the charger should be perfectly flush with the watch.

The charging screen appears on the watch once charging begins. Once the watch is sufficiently charged, it will turn on automatically.

Changing the strap

Slide the button that detaches the strap, then remove the strap.

Holding the new strap, slide the button down and hold it there while positioning the strap at the level of the lug, then release the button to lock the new strap in place.



Before wearing your watch, check to ensure that your new strap is securely in place by pulling gently on it. Louis Vuitton cannot be held responsible for any concerns that may arise from improper or incomplete steps taken while changing the strap.

Accessories supplied with the watch

Your watch comes with a number of accessories to ensure you fully enjoy its many features:

- A cable, a charging cradle and a universal adopter for charging your watch.
- Two interchangeable protective key holders in Louis Vuitton canvas, to protect your cradle when not in use.
- A leather cable tie, for adjusting the length of your cable.
- Two pouches to protect your accessories and easily carry them anywhere.
- A cleaning cloth to keep your watch screen clean.
- Your user manual, containing all the information you need about how to use and operate your watch.
- Your international guarantee.

PART I : Safety & Handling and legal information

Caution! Before you begin to use the Louis Vuitton Tambour Horizon, please read the following instructions which contain important safety and regulatory information. Please keep these instructions in a safe place so that you can refer to them when needed.

To enjoy the full benefit of your Louis Vuitton Tambour Horizon as well as the full set of applications available, we highly recommend that you use your Louis Vuitton Tambour Horizon in conjunction with the Louis Vuitton App.

The Louis Vuitton App is available for free via Apple App Store or Google Play Store, except for China where it is available for free via Apple App Store or Tencent App Gem.

Although your Louis Vuitton Tambour Horizon can operate without the Louis Vuitton App, some features of your Louis Vuitton Tambour Horizon will be available only once you download the Louis Vuitton App (exclusive watch faces, ...).

I. Safety and handling instructions

I.1. Main characteristics of your Louis Vuitton Tambour Horizon

The Louis Vuitton Tambour Horizon is a luxury watch which includes Wi-Fi, Bluetooth[®], near frequency communications (NFC[°]) and contactless payment functions. It also includes a heart rate sensor and a step counter. The Louis Vuitton Tambour Horizon **is not intended to be used as a medical device**

The Louis Vuitton Tambour Horizon requires a phone running Android 4.4+ or iOS 9+. Supported features may vary between platforms.

The Louis Vuitton Tambour Horizon requires the use of the charging accessories provided with it. The accessories provided with your Louis Vuitton Tambour Horizon contain a USB C cable, a charging cradle, and a universal adaptor. You will find further details on electrical safety recommendations concerning the use of the charging accessories below.

Performance and handling: for optimal performance of the heart rate sensor, your watch and strap must be snugly fitted to the wrist. If you want to measure your heart rate while practicing sports, wearing your watch with a steel bracelet may not be an optimal choice as it can be difficult to tighten properly.

You can disable the watch Bluetooth[®], Wi-Fi, contactless payment, heart rate sensor and step counter functions by following the steps below:

if your screen is dim, touch the screen to wake up the watch;

- swipe down from the top of the screen;
- find the Settings icon (⚙️), then touch to select;
- go to "Connectivity", touch Wi-Fi/Bluetooth[®]/NFC settings depending on which you want to turn off;
- if Wi-Fi/Bluetooth[®]/NFC is set to Automatic, tap the toggle switch next to either Wi-Fi/Bluetooth[®]/NFC to turn it off or disable.

I.2. Important safety precautions

Please note that failure to comply with the following guidelines may cause malfunctions or be hazardous to the user and/or exclude, void or reduce the benefit from the International Limited Guarantee and/or US Limited Warranty.

Some tutorials are available in the Louis Vuitton App to guide you through using your Louis Vuitton Tambour Horizon in the most appropriate manner.

I. 2.1 Using the Louis Vuitton Tambour Horizon and its accessories safely

Keeping your Louis Vuitton Tambour Horizon safe

General

Do not use or store the Louis Vuitton Tambour Horizon and its accessories in dusty, dirty areas as its components may be damaged.

Do not store the Louis Vuitton Tambour Horizon and its accessories in warm areas or under direct sunlight. High temperatures can shorten the life of electronic devices, damage batteries, cause them to become inoperative, and warp or melt certain plastics.

Do not store the Louis Vuitton Tambour Horizon and its accessories in cold areas. When the Louis Vuitton Tambour Horizon afterwards warms up to its normal temperature, moisture can form inside the Louis Vuitton Tambour Horizon, which may damage the electronic circuits.

Do not attempt to open the Louis Vuitton Tambour Horizon's casing. Non-expert handling of the Louis Vuitton Tambour Horizon may cause damage to your Louis Vuitton Tambour Horizon and may void the International Limited Guarantee and/or US Limited Warranty.

Do not drop or knock the Louis Vuitton Tambour Horizon.

Do not place heavy objects on it.

Do not use sharp objects on the screen.

Do not use excessive force on the screen. Rough handling may damage the internal circuits.

Do not use harsh chemicals, cleaning solvents or strong detergents to clean the Louis Vuitton Tambour Horizon.

While listening to your device with headphones, make sure you have set the volume to a reasonable level in order to avoid damage to your ears.

If the Louis Vuitton Tambour Horizon or any of its accessories are not working properly, take them to your nearest Louis Vuitton store. The personnel there will assist you, and if necessary and possible, arrange for the Louis Vuitton Tambour Horizon to be repaired.

In addition to the above, please refer to your instructions and guarantee section for information on cables, charging cradle, wall plugs and battery electrical safety.

Exposure to liquid

The Louis Vuitton Tambour Horizon is 30-meter water-resistant.

Try to minimize exposing the Louis Vuitton Tambour Horizon to these substances: soap, detergent, acids or acidic foods, and any liquids other than fresh water, such as salt water, soapy water, pool water, perfume, insect repellent, lotions, sunscreen, oil, adhesive remover, hair dye, or solvents.

The Louis Vuitton Tambour Horizon has a water resistance rating of IP68 under IEC standard 60529.

If your Louis Vuitton Tambour Horizon has a leather bracelet, be aware that leather bands are not water resistant.

The following may affect the water resistance of the Louis Vuitton Tambour Horizon and should be avoided:

- submerging the Louis Vuitton Tambour Horizon Watch in water for long periods of time;
- dropping the Louis Vuitton Tambour Horizon or subjecting it to impacts;
- exposing the Louis Vuitton Tambour Horizon to pressurized water or high velocity water, for example, water skiing, wake boarding, surfing, jet skiing, etc;
- wearing the Louis Vuitton Tambour Horizon in a hot or humid environment, such as a sauna or steam room.

Be sure to carefully follow those instructions when using your Louis Vuitton Tambour Horizon, as any use in contradiction with those instructions would void the International Limited Guarantee.

Using buttons, Digital Crown, connectors, and ports

Never apply excessive pressure to a button on the Louis Vuitton Tambour Horizon, or force a charging connector into a port, because this may cause damage that is not covered under the guarantee and/or US Limited Warranty. If the connector and port do not join with reasonable ease, they probably do not match. Check for obstructions and make sure that the connector matches the port and that you have positioned the connector correctly in relation to the port.

Certain usage patterns can contribute to the fraying or breaking of cables. The cable attached to a charging unit, like any other metal wire or cable, is subject to becoming weak or brittle if repeatedly bent in the same spot. Aim for gentle curves instead of angles in the cable. Regularly inspect the cable and connector for any kinks, breaks, bends, or other damage. Should you find any such damage, discontinue use of the cable.

Discoloration of the accessories (cable, plugs) after regular use is normal. Dirt, debris, and exposure to moisture may cause discoloration. If your accessories become warm during use or if the Louis Vuitton Tambour Horizon does not charge or sync, disconnect the cable from the power adapter and clean the accessories with a nonabrasive, dry, lint-free cloth. Do not use liquids or cleaning products when cleaning the accessories.

Discoloration of the charging surface of the Louis Vuitton Tambour Horizon charging accessories may occur after regular use. Cleaning the charging surface may reduce, or prevent, such discoloration, and will help to prevent damage to your charger and the Louis Vuitton Tambour Horizon. To clean the charging surface, disconnect the charger from both the Louis Vuitton Tambour Horizon and the power adapter and wipe with a damp, nonabrasive cloth. Dry with a nonabrasive, lint-free cloth before resuming charging. Do not use cleaning products when cleaning the charging surface.

Protection of the user's health

As a general recommendation, the Louis Vuitton Tambour Horizon is not intended for use where the failure of the device could lead to death, personal injury, or severe environmental damage.

If you have any questions concerning your Louis Vuitton Tambour Horizon, its batteries and/or accessories' chemical contents, do not hesitate to contact us through our website www.louisvuitton.com or to call our Customer Service Centers at the phone numbers that can be found on the website.

The Louis Vuitton Tambour Horizon and the included Louis Vuitton Tambour Horizon apps are not medical devices. They are not designed or intended for use in the diagnosis of disease or other conditions, or in the cure, mitigation, treatment, or prevention of disease.

Before starting or modifying any exercise program using the Louis Vuitton Tambour Horizon, consult your physician. Be careful and attentive while exercising. Stop exercising immediately if you feel pain, faint, dizzy, exhausted, or short of breath. By exercising, you assume all associated inherent risks including any injury that may result from such activity. If you have any medical condition that you believe could be affected by the Louis Vuitton Tambour Horizon (for example, seizures, blackouts, eyestrain, or headaches), consult your physician prior to using the Louis Vuitton Tambour Horizon.

Some people may experience reactions to certain materials used in jewelry, watches, and other wearable items that are in prolonged contact with their skin. This can be due to allergies, environmental factors, extended exposure to irritants like soap, sweat, or other causes. You may be more likely to experience irritation from any wearable device if you have allergies or other sensitivities. If you have known skin sensitivities, please take special care when wearing the Louis Vuitton Tambour Horizon. You may be more likely to experience irritation from the Louis Vuitton Tambour Horizon if you wear it too tightly.

Remove the Louis Vuitton Tambour Horizon periodically to allow your skin to breathe. Keeping the Louis Vuitton Tambour Horizon bands clean and dry will reduce the possibility of skin irritation. If you experience redness, swelling, itchiness, or any other irritation or discomfort on your skin around, or beneath, your Louis Vuitton Tambour Horizon, please remove the Louis Vuitton Tambour Horizon and consult your physician before resuming wear. Continued use, even after symptoms subside, may result in renewed or increased irritation. Prolonged contact of the skin with abnormally warm surfaces may cause injury or discomfort. Remove your Louis Vuitton Tambour Horizon from your wrist if it becomes uncomfortably warm. You should pay specific attention if you have a medical condition that reduces your ability to detect heat on your skin.

The materials used in the Louis Vuitton Tambour Horizon and the Louis Vuitton Tambour Horizon bands meet the standards set for jewelry by the U.S. Consumer Product Safety Commission, applicable European regulations, and other international standards.

During software updates and other limited circumstances, the Louis Vuitton Tambour Horizon may overheat, causing the exterior portions of the watch to feel warmer than usual to the touch. In such event, do not hesitate to remove the Louis Vuitton Tambour Horizon from your wrist for a brief moment to avoid irritation.

The Louis Vuitton Tambour Horizon contains components which may interfere with electronic medical devices. If you use an electronic medical device, please refer to section "Interaction with the environment" below.

Integrity of people around

Protection of children

Keep the Louis Vuitton Tambour Horizon and its accessories out of the reach of children. In particular, some Louis Vuitton Tambour Horizon bands, or other components or accessories may present a choking hazard to small children. Keep these bands away from small children.

Walking and driving safely

Do not use your Louis Vuitton Tambour Horizon while driving.

The Louis Vuitton Tambour Horizon generates, uses, and can radiate radio frequency signals. Radio frequency signals might affect improperly installed or inadequately shielded electronic systems in motor vehicles. Check with the manufacturer or its representative regarding your vehicle. If any equipment has been added to your vehicle, you should also consult the manufacturer of that equipment for information on radio frequency signals.

Do not use your Louis Vuitton Tambour Horizon while walking or engaging in any activity that requires your full attention. Inattention to vehicular traffic or other pedestrian hazards could result in serious injury, death or property loss. In general, always use common sense when using your Louis Vuitton Tambour Horizon.

I.2.2. Electrical Safety

Accessories

Use only those accessories approved by Louis Vuitton. Using any accessories not approved by Louis Vuitton for use with your Louis Vuitton Tambour Horizon might invalidate any approval or guarantee and/or US Limited Warranty (including the International Limited Guarantee) applicable to your device and or might result in the Louis Vuitton Tambour Horizon becoming inoperative and/or dangerous.

Charging accessories

Use only approved charging accessories Your Louis Vuitton Tambour Horizon is provided with the following charging accessories: USB C cable, charging cradle and a universal adaptor. use only charging accessories approved by Louis Vuitton. Some tutorials are available in Louis Vuitton App with respect to charging handling.

When a charger is not in use, disconnect it from the power source.

It is important to keep the Louis Vuitton Tambour Horizon and the accessories provided therewith in a well-ventilated area when charging.

Use the charging accessories provided with the Louis Vuitton Tambour Horizon or any other Louis Vuitton approved charging accessories only from the type of power source indicated on the marking label. Before you use any power supply, charging accessories, verify that the mains (AC) voltage of the power source is in accordance with the voltage of the approved charging accessories, printed on the power supply.

Do not overload power outlet, extension cords or convenience receptacles because this might result in a risk of fire or electric shock. To reduce the risk of damage to the cord or the wall charger, pull the wall

charger rather than the cord when you disconnect the charging accessory from the power outlet or power source.

Using damaged Louis Vuitton Tambour Horizon charging accessories, or charging when moisture is present, or handling accessories with wet hands can cause fire, electric shock, injury, or damage to the user or the Louis Vuitton Tambour Horizon or other property. Be sure the Louis Vuitton Tambour Horizon and the charging accessories are dry before charging. When you use the charging accessories to charge the Louis Vuitton Tambour Horizon, make sure that the USB plug is fully inserted into the adapter before you plug the adapter into a power outlet. Avoid charging the Louis Vuitton Tambour Horizon in direct sunlight. Do not wear the Louis Vuitton Tambour Horizon while it is charging. The Louis Vuitton Tambour Horizon should not be charged next to certain pieces of furniture that could easily catch fire in case of an overheated battery (e.g. sofas, bookshelves, etc).

Avoid prolonged skin contact with the connector when the cable is plugged into a power source because it may cause discomfort or injury. Sleeping or sitting on the connector should be avoided.

In addition to the above:

- do not expose the charger to water while in use; this may cause the charger and the Louis Vuitton Tambour Horizon to fail;
- carefully insert the USB cable into the charger base, forcing the cable in the wrong direction will damage the charger;
- it is recommended to charge the Louis Vuitton Tambour Horizon in a cool place, in order to prevent overheating of the Louis Vuitton Tambour Horizon;
- it is not recommended to charge the watch in a place where there is direct sunlight on the Louis Vuitton Tambour Horizon, as this may cause overheating;
- when the Louis Vuitton Tambour Horizon is placed on the charger, and the charger is plugged into a wall, a charging screen will be displayed on the face of the Louis Vuitton Tambour Horizon, indicating the percentage of battery already charged;
- it is recommended to remove the Louis Vuitton Tambour Horizon from the charger once it is fully-charged;
- if the Louis Vuitton Tambour Horizon fails to charge, check that the wall plug is fully inserted into the wall outlet, the USB cable is firmly attached to the charger, and the watch is properly placed on the charger;
- if the Louis Vuitton Tambour Horizon still does not charge, make sure that the watch is accurately oriented on the charger and make sure the back of the Louis Vuitton Tambour Horizon is clean;
- the charger contains a small magnet to ensure proper alignment and attachment of the Louis Vuitton Tambour Horizon to the charger. Please keep the charger away from metal.

Battery safety

Your Louis Vuitton Tambour Horizon contains a built-in battery that is not replaceable. Do not attempt to replace your product's battery (for information on the recycling of the battery, please refer to section "Maintenance and disposal" below).

In any event:

- do not expose the battery to fire or other external heat sources, such as hot plates, stove tops, space heaters or ovens, as this could cause fire or explosion;

- do not dispose of batteries in a fire;
- never use any charger or battery that is damaged in any way. Use the battery only for intended purposes. Do not short-circuit the battery;
- do not leave the battery in hot or cold places.

I.2.3. Interaction with the environment

Interference with electronic equipment and magnetic characteristics

Your Louis Vuitton Tambour Horizon, as any radio-transmitting equipment, may interfere with other electronic devices.

Switch off your device on airplanes or any place where it is requested (hospitals, gas station, etc.).

In any case, make sure you are using your device where it is authorized for use and in an authorized manner.

In particular, your Louis Vuitton Tambour Horizon may interfere with pacemakers, defibrillators, or other medical devices. Maintain a safe distance of separation between your medical device and the Louis Vuitton Tambour Horizon and accessories. Consult your physician and medical device manufacturer for information specific to your medical device. Stop using the Louis Vuitton Tambour Horizon and its accessories if you suspect they are interfering with your pacemaker, defibrillator, or any other medical device.

Keep key cards and credit cards away from the Louis Vuitton Tambour Horizon and its accessories.

Dangerous areas

Charging or using the Louis Vuitton Tambour Horizon in any area with a potentially explosive atmosphere, such as in areas where the air contains high levels of flammable chemicals, vapors, or particles (such as grain, dust, or metal powders), may be hazardous. Obey all signs and instructions.

Operating and storage temperatures

The normal operating temperature of the Louis Vuitton Tambour Horizon is from 0 to 40° C (32 to 104° F).

The Louis Vuitton Tambour Horizon can be damaged and battery life shortened if stored or operated outside of these temperature ranges. Avoid exposing the Louis Vuitton Tambour Horizon to dramatic changes in temperature or humidity. If the interior temperature of the Louis Vuitton Tambour Horizon exceeds normal operating temperatures (for example, in a hot car or in direct sunlight for extended periods of time), you may experience the following as it attempts to regulate its temperature:

- charging may slow or stop;
- the display may dim;
- some data transfer may be paused or delayed.

The Louis Vuitton Tambour Horizon and its accessories comply with applicable surface temperature standards and limits. However, even within these limits, sustained contact with warm surfaces for long periods of time may cause discomfort or injury. The Louis Vuitton Tambour Horizon and its accessories will become warm when plugged into a power source. Use common sense to avoid situations where your skin is in contact with the Louis Vuitton Tambour Horizon and/or its accessories for long periods of

time when they are plugged in. For example, while the Louis Vuitton Tambour Horizon is charging or while its accessories are plugged into a power source, do not sleep on them or place them under a blanket, pillow, or your body. Take special care if you have a physical condition that affects your ability to detect heat against the body. Remove the Louis Vuitton Tambour Horizon if it becomes uncomfortably warm.

I.3. Maintenance and disposal

I.3.1. Cleaning and repair

Keep the Louis Vuitton Tambour Horizon clean and dry. Dry the Louis Vuitton Tambour Horizon thoroughly if exposed to fresh water. Clean the Louis Vuitton Tambour Horizon if it comes in contact with anything that may cause stains, or other damage, such as dirt or sand, makeup, ink, soap, detergent, acids or acidic foods, or comes in contact with liquids other than fresh water, including those that may lead to skin irritation such as: sweat, salt water, soapy water, pool water, perfume, insect repellent, lotions, sunscreen, oil, adhesive remover, hair dye, or solvents. The Louis Vuitton Tambour Horizon may vary or fade over time.

The following things are not recommended in the care of your Louis Vuitton Tambour Horizon:

- do not clean the Louis Vuitton Tambour Horizon while it is charging;
- do not dry the Louis Vuitton Tambour Horizon or the bands using any external heat source (for example, a hair dryer);
- do not use cleaning products or compressed air when cleaning your Louis Vuitton Tambour Horizon.

Do not attempt to repair the Louis Vuitton Tambour Horizon by yourself.

I.3.2. Built-in battery precautions and information:

- your Louis Vuitton Tambour Horizon features a built-in rechargeable battery, which is not replaceable or removable by the user;
- do not attempt to replace or remove your Louis Vuitton Tambour Horizon's battery by yourself;
- tampering with your product, or attempting to open it, will void the guarantee and/or US Limited Warranty and may result in a safety hazard;
- for any handling of the battery please contact your Louis Vuitton store or to call our Customer Service Centers at the phone numbers that can be found at the end of this booklet.

I.3.3. Electronic or electric equipment and battery disposal



Your Louis Vuitton Tambour Horizon, its accessories and its battery contain hazardous substances. They must not be disposed of as unsorted household waste.

They are subject to specific local regulations. In particular, as the Louis Vuitton Tambour Horizon and its accessories were placed on the market after 13 August 2005, they are subject, in the European Union, to Directive 2012/19/EU on waste electrical and electronic equipment (WEEE);

In addition, the battery contained in your Louis Vuitton Tambour Horizon is subject to Directive 2006/66/EC on batteries and accumulators and waste batteries and accumulators. The above-mentioned crossed out wheeled bin symbols indicate that the Louis Vuitton Tambour Horizon, its battery and its accessories are subject to these regulations.

The above-mentioned equipment and battery must be collected separately. The correct disposal of your old equipment, batteries or accumulators will help to prevent potential negative consequences for the environment, animal and human health. By recycling, reusing the materials or other forms of utilizing old devices, you are making an important contribution to protecting our environment.

Do not dispose of the above-mentioned equipment in a fire.
