





### CHARGE THE BATTERY

The device is built-in Lithiumion battery. Look at the battery status indicator (red) and status indicator (blue) at the upper-right corner of the screen. The device battery capacity is 250 mAh, about 2 to 3 hours per charge. After charging full, the endurance of device can support more than 600 times transaction.

### SET UP

Press and hold power button for 1 second to turn your device on, after the screen lights on, it displays self-checking information and main interface. 30 seconds (user set) without operation, the system to be in the sleep state, you can wake up the device by pressing power button or mobile client has relevant orders issued ,the device will wake up automatically. 30 minutes (user set) without operation, the device will be shutdown automatically.
