



■ Kev Function

To turn on the Speaker, Connect AC adaptor to the charging port. Switch the Power ON/OFF button. Activate the Bluetooth feature on your phone, and set the phone to search for wireless devices (See the User Manual for device). The speaker will show on your devices as BB-BT-SP. (if the passcode is requested enter 0000) A chime sound will tell you if the pairing is successful.

- (1) Long press Power ON/OFF, Short press pause/play
- Long press night light Power ON/OFF, Short press change colorful light.
- Long press Volume down, Short press go to the last song. Double click light brightness adjustment.
- + Long press Volume up, Short press go to the next song. Double click mode change.
- Short press rotating ON/OFF.

Note: This device can also be operated using the included 3.5 mm AUX cable. When the cable is plugged into the AUX port, all Bluetooth functions will shut off automatically.
