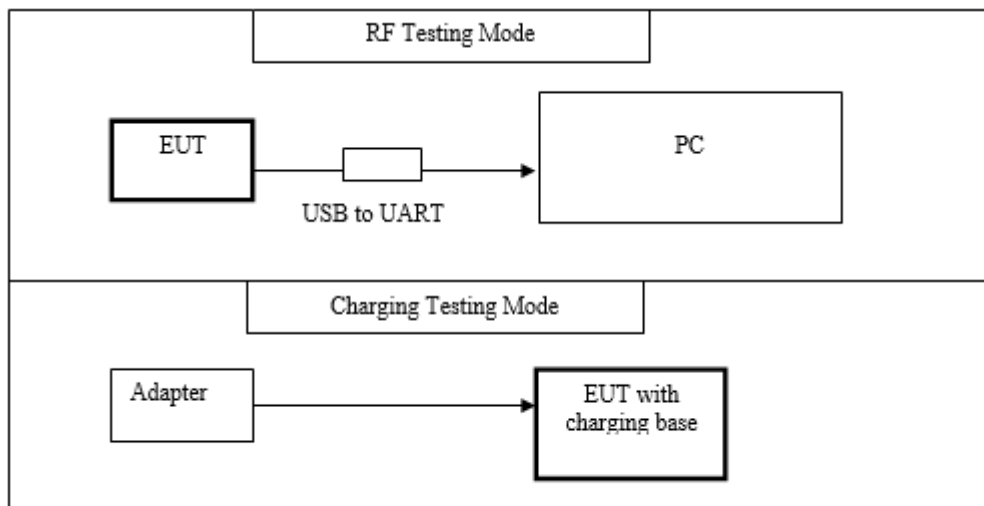

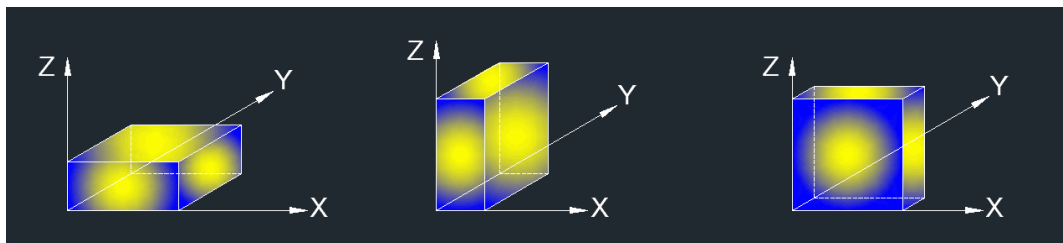

## 10. ANTENNA REQUIREMENTS

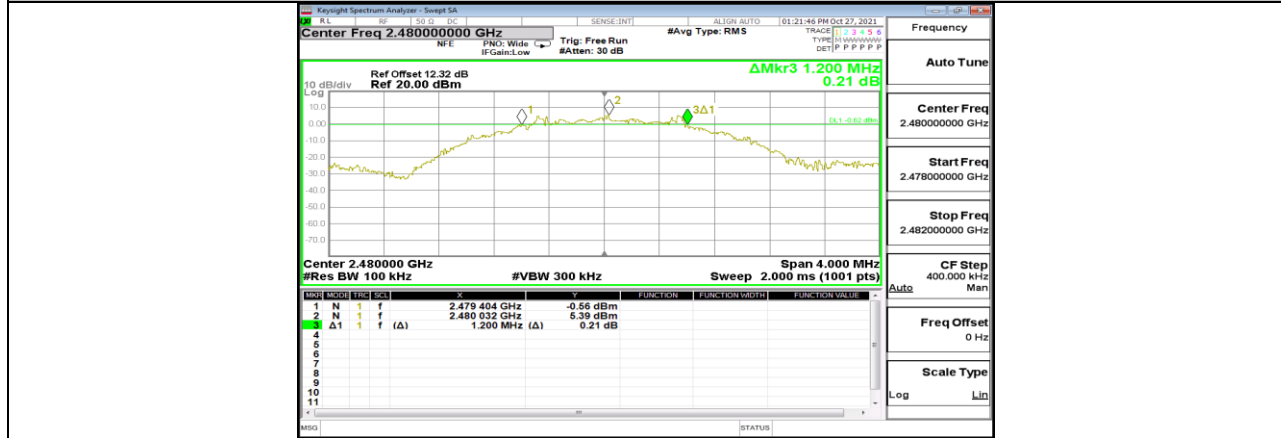
