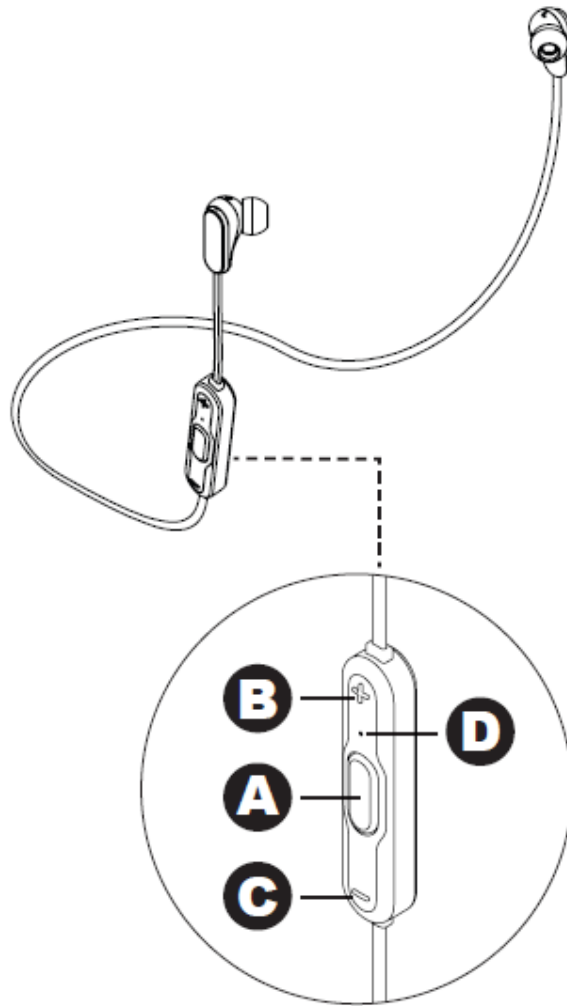


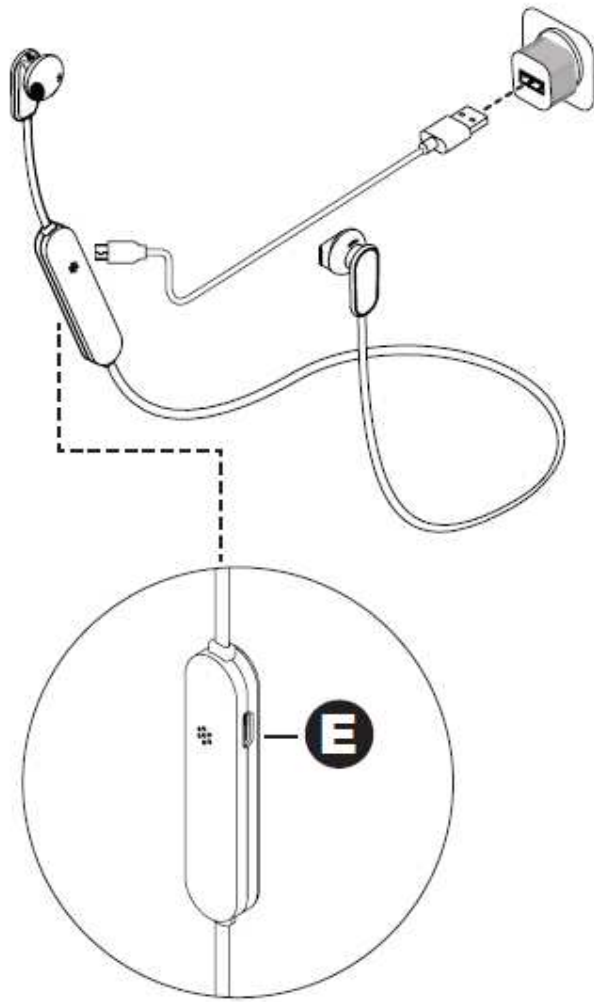

- A** Hold for 3 seconds: Power On/Off. Single press: Play/pause/answer & end call. Double press: Skip track. Triple press: Previous track.
- B** Increase volume.
- C** Decrease volume.
- D** Blue LED: On and paired. Constant red: Powering off. Flashing blue/red: Pairing mode*.
- E** Charge earphones via input (Micro-B USB 5V/50mA).

*To Pair: Enable Bluetooth® on your device, select Earphones on the device Bluetooth® menu.

Safety and Compliance Information:

- Do not attempt to disassemble the product or insert items into the product as this may cause short circuits resulting in electrical shock or fire.
- The product contains no user replaceable parts. Only authorised service engineers may open the product.
- This product is not waterproof or water resistant. Exposing the product to rain, moisture or other liquids may damage the product and may result in injury to the user. Do not touch or use with wet hands.
- Do not use in areas where there is the risk of explosion.
