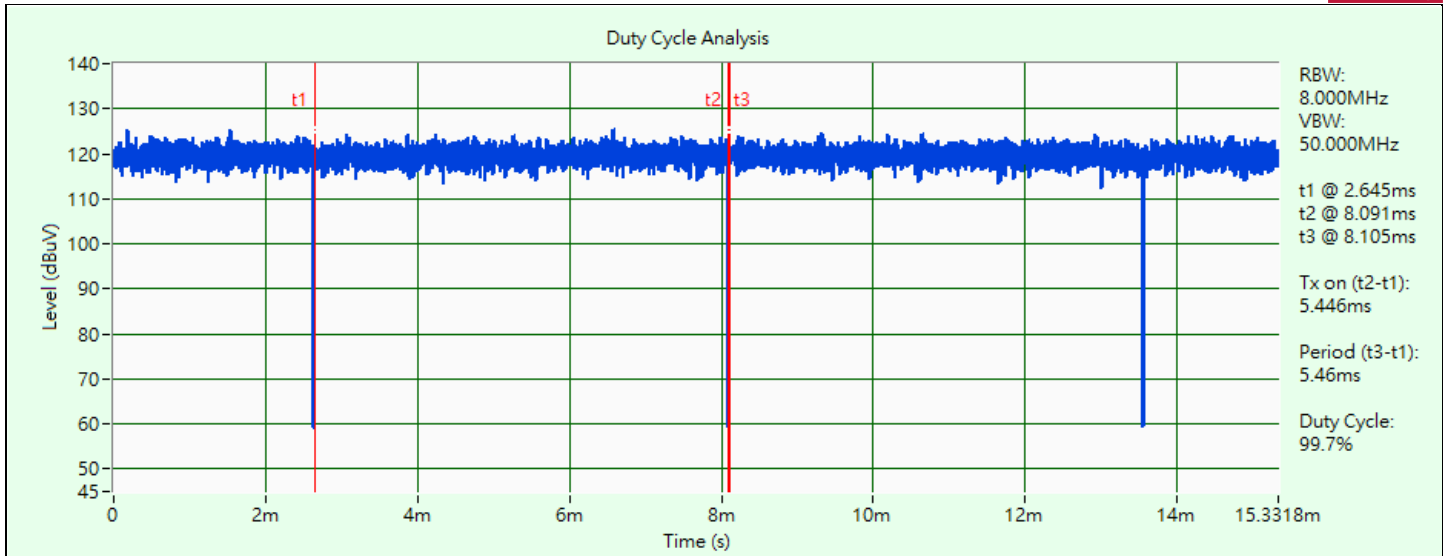

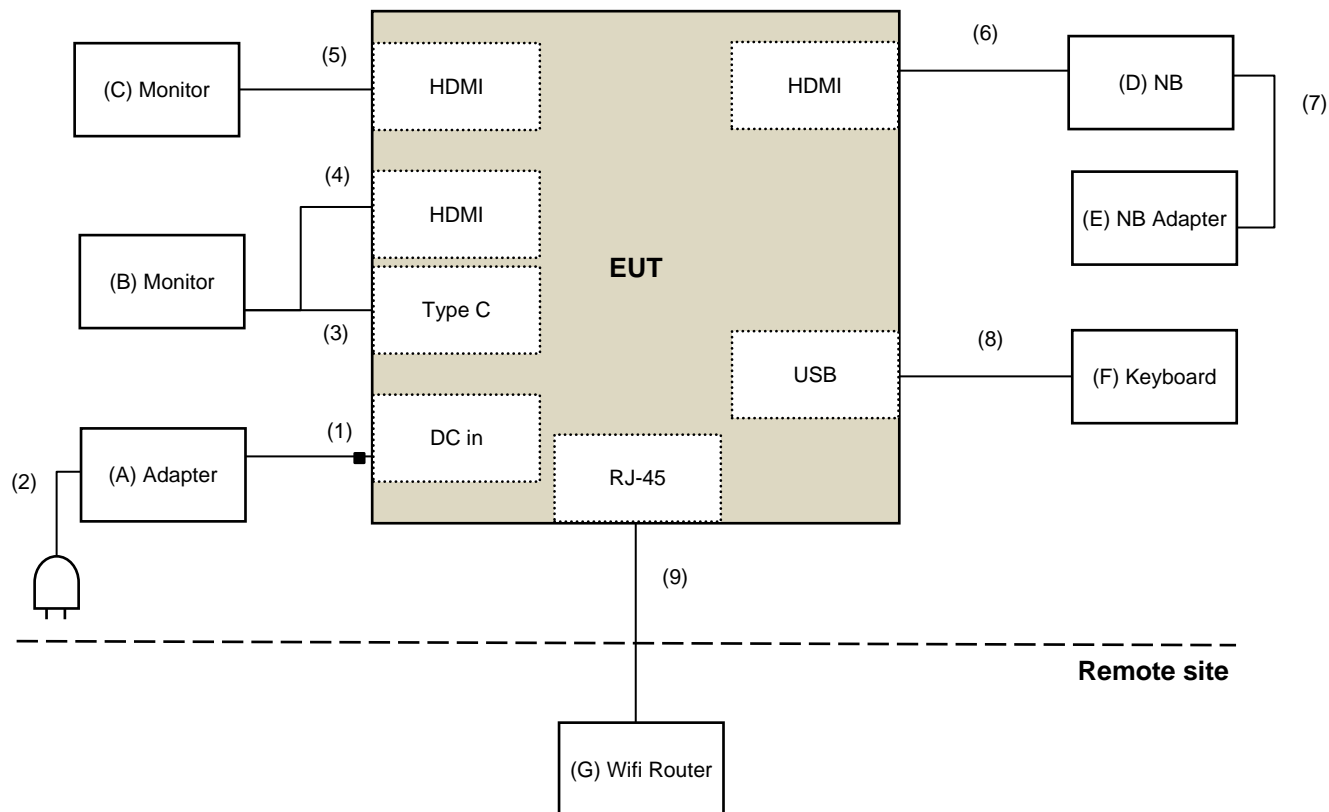

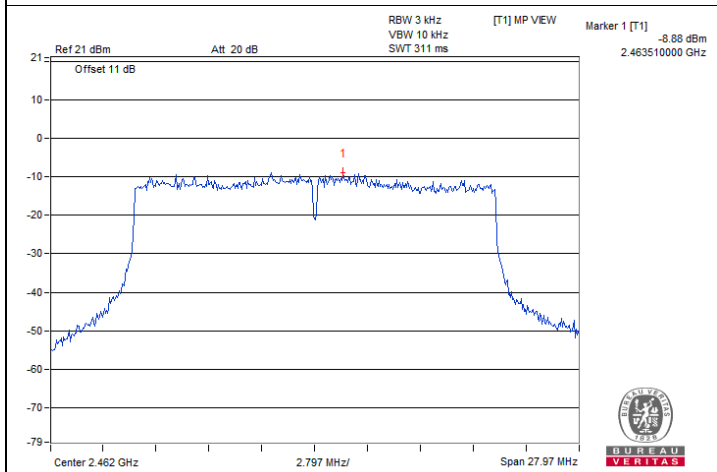
Spectrum Plot of Maximum Value



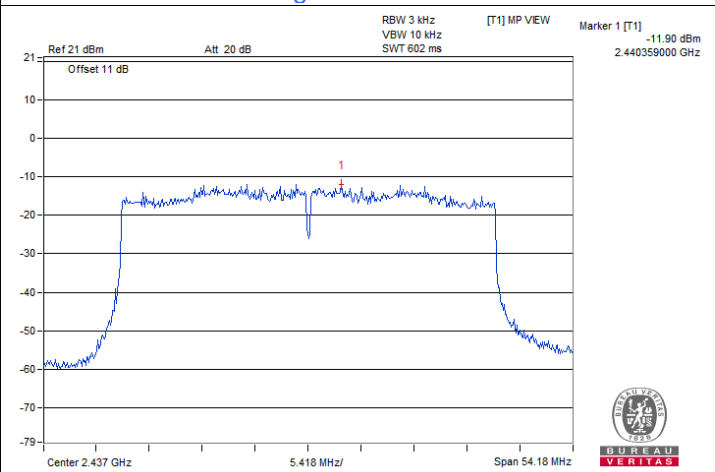

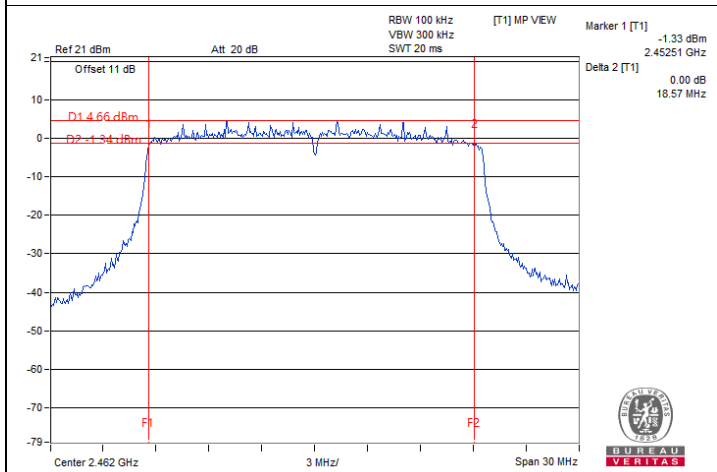
Spectrum Plot of Minimum Value



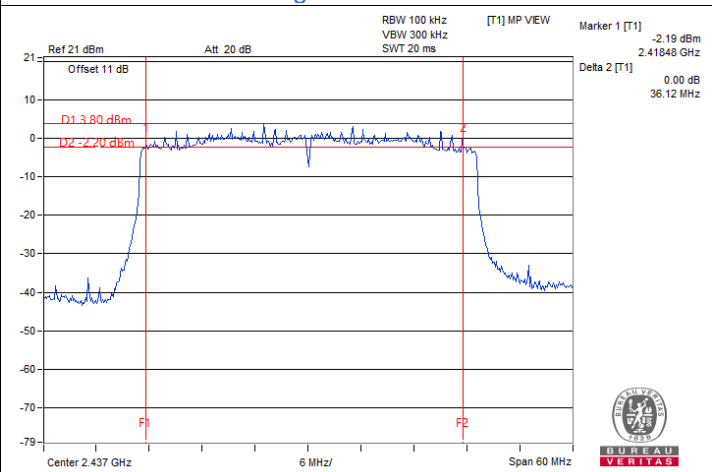

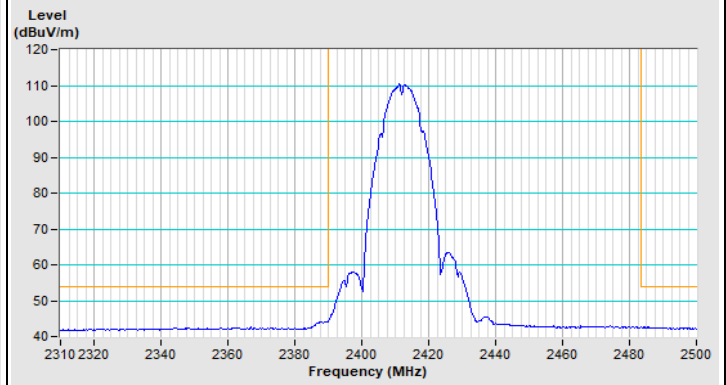


Plot of Band Edge

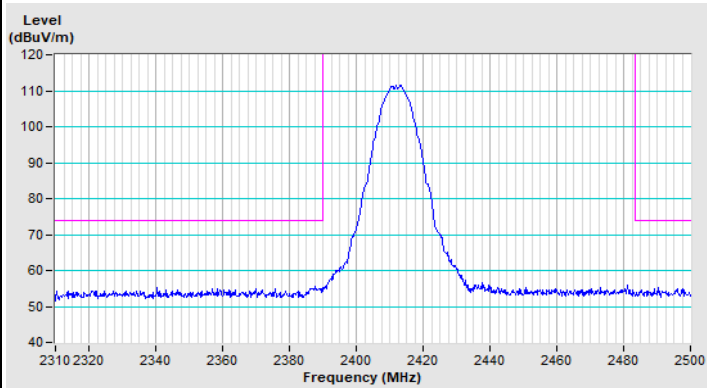
