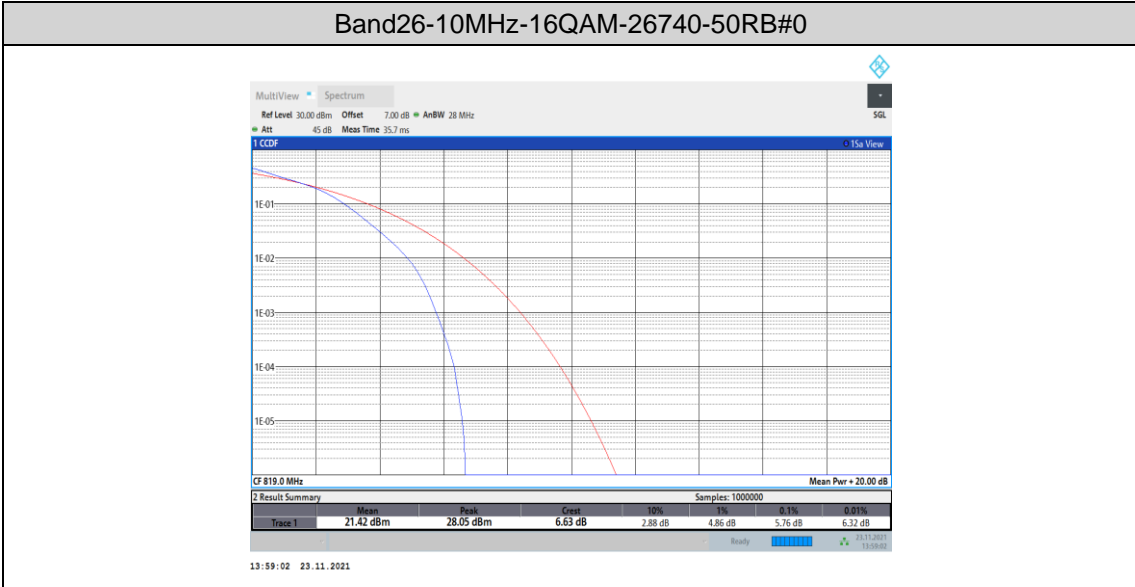

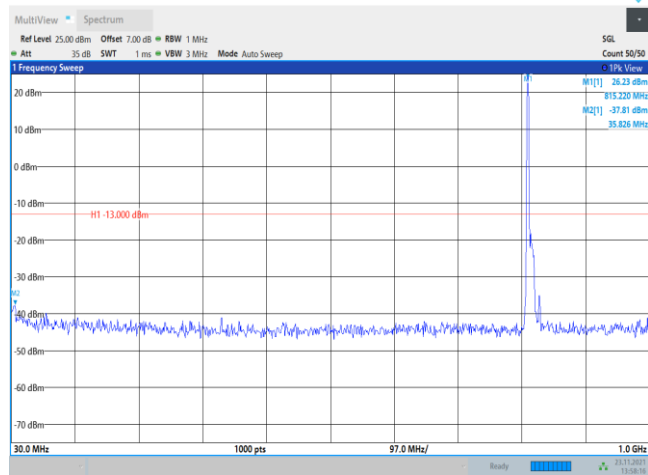

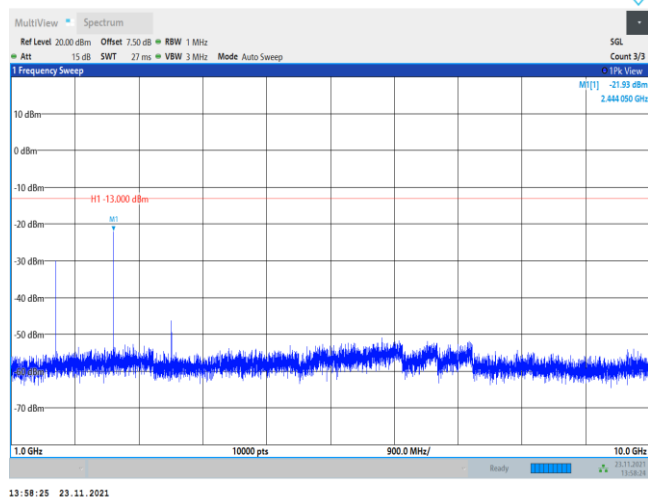

Band26-10MHz-QPSK-26740-1RB#0-Range1:30~1000MHz

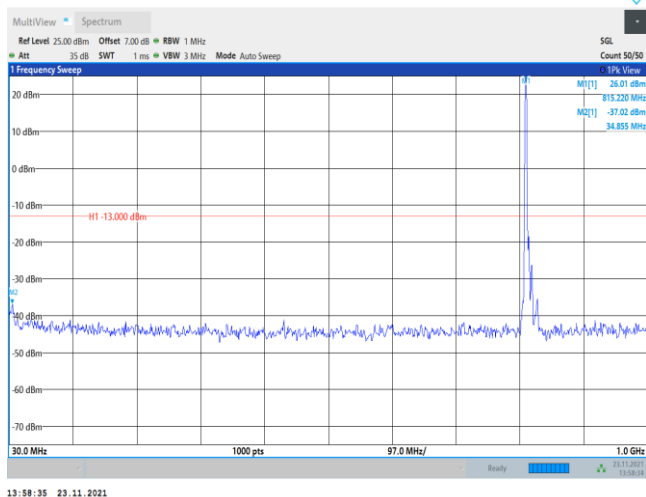


Band26-10MHz-QPSK-26740-1RB#0-Range2:1000~10000MHz

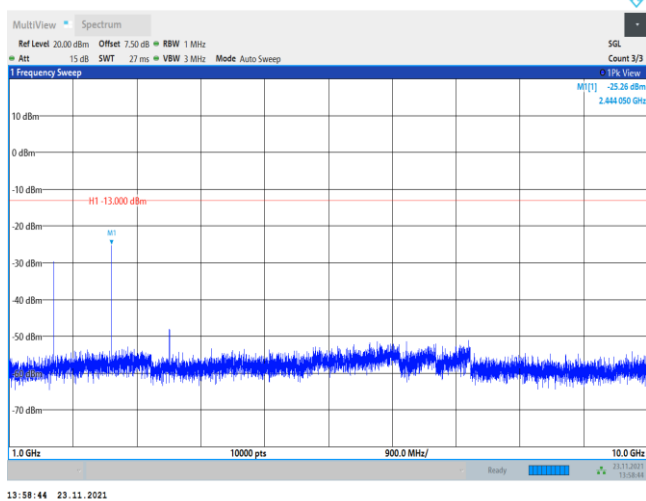
