

### 6.1.Block Diagram of Test Setup

### 6.2. The Requirement For Section 15.247(a)(1)

Section 15.247(a)(1): Frequency hopping systems shall have hopping channel carrier frequencies separated by a minimum of 25 kHz or the 20 dB bandwidth of the hopping channel, whichever is greater. Alternatively, frequency hopping systems operating in the 2400-2483.5 MHz band may have hopping channel carrier frequencies that are separated by 25 kHz or two-thirds of the 20 dB bandwidth of the hopping channel, whichever is greater, provided the systems operate with an output power no greater than 125 mW. The system shall hop to channel frequencies that are selected at the system hopping rate from a pseudorandomly ordered list of hopping frequencies. Each frequency must be used equally on the average by each transmitter. The system receivers shall have input bandwidths that match the hopping channel bandwidths of their corresponding transmitters and shall shift frequencies in synchronization with the transmitted signals.

Section 15.247(a)(1)(iii): Frequency hopping systems in the 2400-2483.5 MHz band shall use at least 15 channels. The average time of occupancy on any channel shall not be greater than 0.4 seconds within a period of 0.4 seconds multiplied by the number of hopping channels employed. 










#### 10.1.1.Block diagram of connection between the EUT and peripherals




#### 10.1.2.Semi-Anechoic Chamber Test Setup Diagram




#### (B)Radiated Emission Test Set-Up. Frequency 30MHz-1GHz

#### 10.2. The Limit For Section 15.247(d)

Section 15.247(d): In any 100 kHz bandwidth outside the frequency band in which the spread spectrum or digitally modulated intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20 dB below that in the 100 kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement, provided the transmitter demonstrates compliance with the peak conducted power limits. EUT is set 3.0 meters away from the receiving antenna, which is mounted on an antenna tower. The antenna can be moved up and down between 1.0 meter and 4 meters to find out the maximum emission level. Broadband antenna (calibrated bi-log antenna) is used as receiving antenna. Both horizontal and vertical polarizations of the antenna are set on measurement. In order to find the maximum emission levels, all of the EUT location must be manipulated according to ANSI C63.10:2013 on radiated emission measurement. This EUT was tested in 3 orthogonal positions and the worst case position data was reported.

During the radiated emission test, the spectrum analyzer was set with the following configurations:

- 1. The resolution bandwidth and video bandwidth of test receiver/spectrum analyzer is 120kHz for Quasi-peak at frequency below 1GHz.
- 2. The resolution bandwidth of test receiver/spectrum analyzer is 1MHz and video bandwidth is 3MHz for peak measurement with peak detector at frequency above 1GHz.
- 3. The resolution bandwidth of test receiver/spectrum analyzer is 1MHz and video bandwidth is 10Hz for Average measurement with peak detection at frequency above 1GHz.
- 4. All modes of operation were investigated and the worst-case emissions are reported.

#### **Radiated Band Edge Result**

#### Test Procedure:

The EUT and its simulators are placed on a turntable, which is 1.5 meter high above ground(Above 1GHz). The turntable can rotate 360 degrees to determine the position of the maximum emission level. EUT is set 3.0 meters away from the receiving antenna, which is mounted on an antenna tower. The antenna can be moved up and down between 1.0 meter and 4 meters to find out the maximum emission level. Broadband antenna (calibrated bi-log antenna) is used as receiving antenna. Both horizontal and vertical polarizations of the antenna are set on measurement. In order to find the maximum emission levels, all of the EUT location must be manipulated according to ANSI C63.10:2013 on radiated emission measurement. The EUT was tested in 3 orthogonal planes.

Let the EUT work in TX (Hopping off, Hopping on) modes measure it. We select 2402MHz, 2480MHz TX frequency to transmit(Hopping off mode). We select 2402-2480MHz TX frequency to transmit(Hopping on mode).

During the radiated emission test, the spectrum analyzer was set with the following configurations:

- 1.The resolution bandwidth of test receiver/spectrum analyzer is 1MHz and video bandwidth is 3MHz for peak measurement with peak detector at frequency above 1GHz.
- 2. The resolution bandwidth of test receiver/spectrum analyzer is 1MHz and video bandwidth is 10Hz for Average measurement with peak detection at frequency above 1GHz.
- 3.All modes of operation were investigated and the worst-case emissions are reported.







According to Section 15.203, an intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device.


### 13.2.Antenna Construction







14.2.Photograph of set-up for Radiation Measurement Below 1GHz







# 14.3.Photograph of set-up for Radiation Measurement Above 1GHz




