Battery installation</p> <p>(1). Open the top housing by using the crowbar from the rope hole.</p> <p>(2). Insert the battery and close top housing</p> <p>(3). Press the button once to open Z-Cuky before first use</p>	<div style="text-align: center;">  </div> <p>2. Z-Cuky functions introduce</p> <p>(1). Sound Hole: This side must point to zipper outside.</p> <p>(2). Button ① press 2s to active or close the zipper alarm function, or exit the flight mode.</p> <p>②press 2 times to active the finding phone function</p>	<p>(3). The indicator light 1</p> <p>① Red indicate alarm function off</p> <p>② Green indicate alarm function on.</p> <p>③ orange indicate exit the flight mode</p> <div style="text-align: right;">  </div> <p>3. Z-Cuky Installations guide</p> <p>(1). put the Z-Cuky into the pouch, the sound hole in the open side.</p> <p>(2). paste the pouch to bag following the installation card.</p> <div style="text-align: right;">  </div>
<p>Note: the above instruction card to the upper right corner at the top of the zipper open end</p> <p>4. Magnet Install guide</p> <p>(1). Remove 3M Release paper of the magnet</p> <p>(2). The magnets attached to the parallel, following below</p> <div style="text-align: center;">  </div>	<p>Note:</p> <p>Suggest the user stick magnet to zipper bottom by AB glue, confirm the stick strongly.</p> <p>5. Opened by ourself</p> <p>Unzip at the position of alarm, hear one sound "beep", then close zipper quickly, and unzip again in 2 seconds without alarm. This action is to avoid the trouble of self unzipping alarm.</p>	<p>6. APP download</p> <p>(1). Scan the QR code to download the APP from the browser, then install.</p> <p>(2). Search "CUKY" in Apple store , Google play, or other application market to download and install.</p> <div style="text-align: center;">  </div>	<p>7. Use the app</p> <p>(1). Open the APP</p> <p>(2). Click the "sign up" to create a new account</p> <p>(3). select the current country code</p> <p>(4). input the phone number</p> <p>(5). click "Get code" to input the identifying code</p> <p>(6). create and input the password</p> <p>(7). click "sign up" to complete the creation.</p>
