
IMPORTANT SAFETY PRECAUTIONS






CHARGING YOUR SPEAKER




4. The LED Indicator Light turns red while the speaker is charging then turns off once charging is complete.

BLUETOOTH PAIRING




1. Slide the power switch to the ON poisition to power on your speaker.



2. Once powered on, you speaker will emit an audio tone to indicate that it is in pairing mode.




3. Go to the Bluetooth settings menu on your phone. Make sure that Bluetooth is turned on. Connect to the device listed as 'MUZ6OO2.'

USING YOUR SPEAKER




1. Slide the power switch to the ON position to power on your speaker. Slide the power switch to the off position to power off your speaker.
