## **Overview**

### 1.1 The FlatMesh System

A FlatMesh network consists of a number of nodes connecting to one gateway device. In some situations multiple networks may be required on a single site, for example a site in which the number of nodes exceeds the number supported by a single Gateway, or a site where there are a set of separate measurement zones.

A FlatMesh Node is a sensing unit with an integrated wireless mesh radio and battery. It participates in a FlatMesh wireless network, forwarding messages as required by the system, and also takes samples from onboard and/or external sensors. Sampling is done on a periodic schedule which may be either fixed or variable. In addition, a sample may be manually requested via the Gateway.

### 1.2 FlatMesh Optical Displacement Node (ODS)

The FlatMesh Optical Displacement Node provides the ability to measure distance between the node and a target. It also provides temperature and onboard battery voltage. The unit can optionally be configured with an internal tilt meter.



Readings can be scheduled anywhere between 15 seconds to twelve hours with a time increment of one second.

## Installation

The node will be delivered to you pre-configured. Simply affix the node to a structure within the range of the rest of the network.

### 2.1 Mounting

The node must be securely mounted to a structure with the laser aperture pointing towards the object you wish to monitor. There are several mounting options available for accurately positioning Node.

### Warning

The Optical Displacement Node with brackets could have a mass of up to 1.5kg. Please ensure that the object you are fixing to can handle this load.

Ensure that appropriate methods and materials are used when affixing equipment to a wall.

### 2.2 Targeting

With the laser aperture pointing in the desired direction, hold a magnet (supplied with unit) near the bottom of the lens. After 2 to 5 seconds, the targeting laser will activate. This laser will stay on until the magnet is removed. Make any required adjustments to the mounting position until the targeting laser is accurately pointing at the object you wish to monitor. Once the node is accurately positioned, remove the magnet and the node will return to its normal operating mode.

# **Data Readings**

### 3.1 Optical Displacement

The Optical Displacement node does not require any additional physical connections and will report displacement readings as soon as it connects to the FlatMesh network. The node reports the absolute displacement between the node the reference target in millimeters.

### 3.2 Tilt Readings

If a triaxial tilt sensor is fitted, the node will report tilt readings in the same manner as a standard FlatMesh tilt meter. Please see the FM3N-IX user guide for more information on the tilt functionality of the device.

# **Maintenance**

The product should not require any maintenance after installation. If the need to clean the product should arise, use only a damp cloth and mild detergent. Do not use any solvents as this may damage the enclosure.



Only service personnel authorised by the manufacturer may open the enclosure.

No user serviceable parts are located inside.

# **Support**

### 5.1 Troubleshooting - General

FlatMesh Nodes are sealed units so checking of devices is confided to visual inspection, checking of connections and measurement of basic device parameters.

#### 5.1.1 No new data from node

#### Check if other nodes on the same gateway have been updating

The FlatMesh Gateway operates a store-and-forward system. It collects data from nodes on its network all the time, and then periodically establishes a connection to the Web Monitor to transfer data.

Check the other nodes on the same gateway for similar problems to rule out a gateway problem. Check that the gateway battery has been charged correctly in the last two weeks. If the problem is being seen on a number of gateways on the same site, there could a problem with the backhaul (cellular network or other network connection.)

#### Check for physical damage

Check to ensure that the node's enclosure is whole and undamaged.

The network relies on neighbouring nodes to pass messages along to the gateway. There is no reliance on any one node, but if all nodes in a large stretch of the network are not in working order, this is likely to impact other nodes' ability to communicate with the gateway.

#### Check that the antenna is tight

The antenna connects to the node through a threaded SMA connection. This should be tightened by hand against the connector on the enclosure. If this connector is loose, the node's signal strength and therefore its ability to connect to the network will be significantly impaired.

#### Check that the antenna is correctly oriented

The antenna's orientation can also impact its ability to connect to other nodes. Typically, the correct orientation for the antenna is vertical (perpendicular to the ground.) In tunnels or when monitoring a wall, it may be more appropriate to orient the antenna to be perpendicular to the wall surface. Check with Senceive to ascertain the best arrangement for your site.

with the compiled program. The purpose of this Exception is to allow compilation of non-GPL (including proprietary) programs to use, in this way, the header files and runtime libraries covered by this Exception.

Definitions

A file is an "Independent Module" if it either requires the Runtime Library for execution after a Compilation Process,

or makes use of an interface provided by the Runtime Library, but is not otherwise based on the Runtime Library.
"GCC" means a version of the GNU Compiler Collection, with or without modifications, governed by version 3 (or a specified later version) of the GNU General Public License (GPL) with the option of using any subsequent versions published

"GPL-compatible Software" is software whose conditions of propagation, modification and use would permit combination with GCC in accord with the license of GCC.

'Target Code" refers to output from any compiler for a real or virtual target processor architecture, in executable form or suitable for input to an assembler, loader, linker and/or execution phase. Notwithstanding that, Target Code does not include data in any format that is used as a compiler intermediate representation, or used for producing a compiler intermediate representation.

Preamble

The GNU General Public License is a free, copyleft license for software and other kinds of works.

The licenses for most software and other practical works are designed to take away your freedom to share and change the works. By contrast, the GNU General Public License is intended to guarantee your freedom to share and change all versions of a program-to make sure it remains free software for all its users. We, the Free Software Foundation, use the GNU General Public License for most of our software; it applies also to any other work released this way by its authors.
