#### Instruction guide

1: Plug the USB end of the charging cable into a viable power source (power source not included)



2: Plug the Micro-B end of the charging cable into the wireless charger



3: Place wirelessly charging compatible phone, face up, on the wireless charging pad and leave there to charge



The wireless charger has an LED indicator light. When the charger is plugged in and in standby mode, the LED will show red. When it is charging your device, it will show blue.

Note: If your phone is not charging your phone may not be wireless charging compatible or you may have to remove your phone case to properly use the product

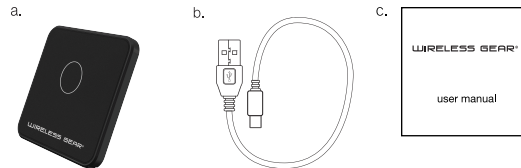
