



# **Device Safety**

- Your True Wireless Earbuds have internal rechargeable batteries. Improper usage may result in the Earbuds becoming hot, ignite or burst and cause injury if exposed to conditions of abuse.
- Do not disassemble, throw away or damage the True Wireless Earbuds.

# **Charging The Battery**

- 1. Plug the charger cable into the base of each earbud. Plugged in earbuds will automatically power down.
- Connect the charger to a USB power source. The red indicator lights will display during charging. If charging does not start, disconnect the charger plug it in again,
- and retry. Charging the batteries fully may take hours.

  3. When the battery is fully charged, the red indicator light will turn blue. Disconnect the charger from the USB power source and the Earbuds. The fully charged batteries have power for up to 4 hours of music time or up to 100 hours of standby time. However, the talk and standby times may vary when used with different devices, settings, and environments.



#### Pairing One Earbud

CHARGING TIPS

- 1. Long press the multifunction button on the chosen earbud until the indicator flashes red & blue
- 2. Activate the Bluetooth™ feature on your phone, and set the phone to search for wireless devices. (See the User Manual for your device)
- 3. Tap the Earbuds on your device displayed as BB-BT-EB.
- (if pass code is requested enter 0000) 4. When it isn't paired, the earbud will turn off automatically after 5 minutes.

#### Pairing Two Earbuds

- 1. Long press the multifunction button on both of the earbuds until the indicator lights flash red & blue
- 2. Two earbuds will paired automatically. If the pairing is successful The Master of earbud will blink blue and red, the slave earbud will flash blue every 4 seconds.
- 3. Activate the Bluetooth™ feature on your device, and set the device to discovery mode to search for wireless devices. (See the User Manual for your device)
- If you've previously paired a single earbud, the paired set
- should be paired as a new device with the name below.

  4. Tap the Earbuds on your device displayed as BB-BT-EB.
  (if pass code is requested enter 0000)

  \* Once the Earbuds have been paired, they will automatically pair with each other and your device, when they are powered on and Bluetooth™ is activated on your device.
- 5. When they arn't paired, the earbuds will turn off automatically after 5 minutes.

### **Playing Music**

- 1. Once the Earbuds are paired, press play on your device.
- 2. Short press the Multifunction button to pause playback, and again to resume.

# Answering Calls

- . When there is a phone call, you can just hear the ringing from the master of the earbud, the other slave earbud is silent.
- Answer an incomming call by short pressing the Multifunction button on
- · Refuse an incoming call by long press the Multifunction button on either side.
- · Redial the last number used by the device by double-clicking the Multifunction button on either side during playback.

#### Power Off

Press the Multifunction button on either side until the LED flashes red.

#### **Battery Information**

Your earbuds are powered by a rechargeable batteries. The full performance of new batteries is achieved only after two to three complete charge and discharge cycles. The batteries can be charged and discharged hundreds of times, but it will eventually wear out.

- Do not leave a fully charged earbuds connected to a charger, overcharging may shorten their lifetime. If left unused, fully charged earbud batteries will lose their
