**Battery information**  
Your device is powered by a rechargeable battery. The full performance of a new battery is achieved only after two to three complete charge and discharge cycles. The battery can be charged and discharged hundreds of times, but it will eventually wear out.

Do not leave a fully charged battery connected to a charger, overcharging may shorten its lifetime. If left unused, a fully charged battery will lose its charge over time.

Never use any charger that is damaged. Leaving the device in hot or cold places will reduce the capacity and lifetime of the battery. Optimal temperature for the battery is between 15°C and 25°C (59°F and 77°F). A device with a hot or cold battery may not work temporarily, even when the battery is fully charged. Do not dispose of batteries in a fire as they may explode. Batteries may also explode if damaged. Always dispose of batteries according to local regulations. Please recycle. Your Wireless Earhooks has an internal rechargeable battery. Improper usage may result in the Wireless Earhooks becoming hot, ignite or burst and cause injury if exposed to conditions of abuse. Be sure to follow the safety warnings listed below:  
1. Do not disassemble, throw away or damage the Wireless Earhooks.  
2. Store the Wireless Earhooks in a dry place, keeping it away from damp corrosive materials and environments such as salt air.  
3. Keep the Wireless Earhooks away from direct sunlight, fire and high voltage equipment. Do not store the Wireless Earhooks inside a car during hot weather. Remember a closed car acts as a green house allowing the inside temperature to possibly reach over 200F.  
4. The Wireless Earhooks is not a toy. Please keep it out of the reach of young children.  
5. Please do not discard the Wireless Earhooks. Consult your local waste collection agency for proper disposal or recycling methods. You may also contact "Call2Recycle" at 877-273-2925 or online at "call2recycle.org" for a battery recycling drop off location near you.

**Charging the battery**  
This device has an internal, rechargeable battery.  
1. Plug the charger cable into the earhooks.  
2. Connect the charger to a USB power source. The red indicator light will display during charging. If charging does not start, disconnect the charger plug it in again, and retry. Charging the battery fully may take up to 1-2 hours.  
3. When the battery is fully charged, the red indicator light will turn off. Disconnect the charger from the USB power source and the earhooks. The fully charged battery has power for up to 3 hours of talk-time or up to 120 hours of standby time. However, the talk and standby times may vary when used with different devices, settings, and environments.

**2. Instruction**  
■ Key Function

<b>Power switch</b>	To turn the power on, hold the Multifunction Button for 2 seconds until the LED light flashes blue and red. To turn the power off, hold the Multifunction Button for 2 seconds until LED light flashes blue twice.
<b>Pairing to Device</b>	Power on the wireless earhooks, hold Multifunction Button on control bar 2 seconds, earhooks will enter pairing mode. Activate the Bluetooth® feature on your device, and set the device to search for wireless devices. (See the User Manual for your device) The earhooks will show on your device as EV6944, (if pass code is requested enter 0000) If the pair is successful, the earhooks's LED indicator will flash blue every 4 seconds. Once the earhooks has paired with your device, no password will be need to reconnect. If not paired, the earhooks will turn off automatically after 3 minutes.
<b>Receive Hang up phone call</b>	Press Multifunction Button to receive phone call, press again to end phone call, Press twice to re-dial the last phone number, Press and hold for 2 seconds to decline phone call.
<b>Play Pause</b>	In music mode, press once to pause, and again to play, (music will automatically when device receives phone call and will continue once call ends)
<b>Next Song</b>	In music mode, press the + button to play next track
<b>Previous song</b>	In music mode, press the - button press to play previous track
<b>Volume Increase</b>	Press and hold the + button to increase volume
<b>Volume Decrease</b>	Press and hold the - button to decrease volume
