The LED Interior Strip Kit 48" is an interior auxiliary light designed to provide auxiliary or mood lighting while driving off road or while the vehicle is parked and stationary. The LED Interior Strip Kit 48" has a distinct amperage draw noted in the installation instructions. If you are not confident in your ability to install the LED Interior Strip Kit 48" please consult a licensed mechanic.

The LED Interior Strip Kit 48" has specific voltage and amperage ratings for power input and amperage draw.

ENSURE THESE RATINGS ARE FOLLOWED. The LED Interior Strip Kit 48" must be installed in a properly functioning electrical system. Do not install this product in a malfunctioning electrical system.

Select a mounting location that will not obstruct the operation of instruments or any vehicle functions

Clean mounting surfaces with isopropyl alcohol (70%) and wait for the surface to dry before proceeding.

Before permanently mounting to vehicle, test fit to ensure wiring is long enough to be safely installed and does not obstruct any operating functions of the vehicle. These lights should not be installed where their operation hinders the visibility of the driver or other drivers

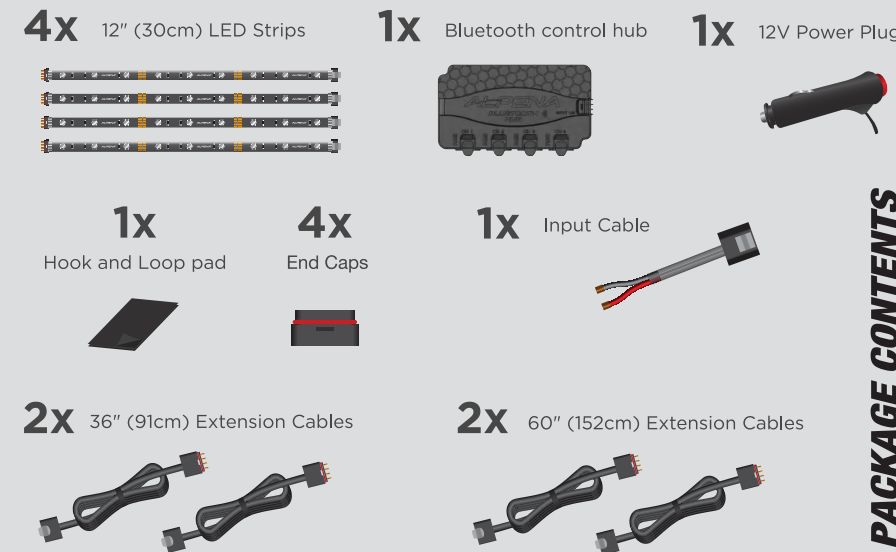

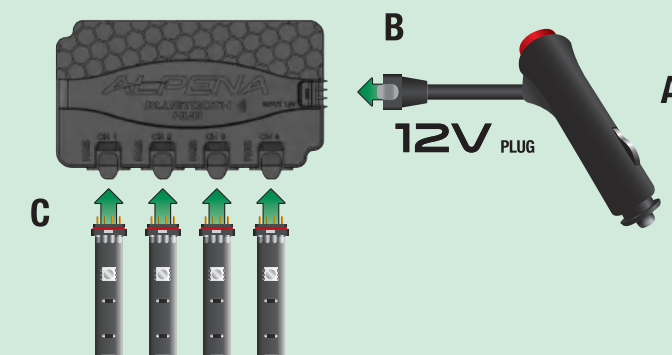

12V ADAPTER INSTRUCTIONS



THE ALPENALINK™ POWER ADAPTER CAN BE USED ON ANY 12V DC POWER OUTLET OR CIGARETTE LIGHTER SOCKET ENSURE THE OUTLET IS PROPERLY FUNCTIONING BEFORE INSTALLING OR USING THIS ADAPTER

- PLUG THE POWER ADAPTER INTO THE DESIRED POWER SOCKET, MAKING SURE THE RED BUTTON IS NOT ON POWER IS NOT TOGGLED 'ON'
- CAREFULLY PLUG THE FEMALE ALPENALINK™ CONNECTOR ON THE END OF THE ADAPTER INTO THE MALE ALPENALINK™ CONNECTOR ON THE BLUETOOTH HUB MARKED 'INPUT 12V' - EXTENSIONS MAY BE USED BETWEEN THE POWER ADAPTER AND THE BLUETOOTH HUB.
- CONNECT A SINGLE OR BOTH FLOGLO STRIPS TO AN OUTPUT CHANNEL (MARKED CH1, CH2, CH3, CH4) ON THE BLUETOOTH HUB. TAKING CARE TO SECURE THE CLIPS WITHOUT DAMAGE TO THE PINS. NOTE - SEE STRIP COMPATIBILITY CHART TO FIND OUT HOW MANY STRIPS AND WHAT EXTENSION STRIPS ARE COMPATIBLE WITH THIS PRODUCT - THE INCLUDED EXTENSIONS AND COMPATIBLE ALPENALINK™ EXTENSIONS MAY BE USED BETWEEN FLOGLO STRIPS OR BETWEEN THE BLUETOOTH HUB AND FLOGLO STRIPS
- CHECK TO MAKE SURE ALL ALPENALINK™ CONNECTIONS ARE SECURE.
- SWITCH POWER ON BY PRESSING DOWN ON THE RED BUTTON ON THE POWER ADAPTER, AND BY PRESSING THE POWER BUTTON ON THE REMOTE - THE STRIPS SHOULD NOW FLASH IN A DEMONSTRATION SEQUENCE

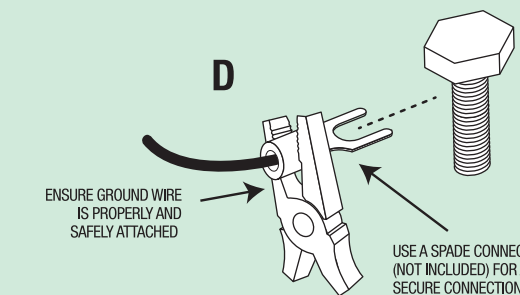
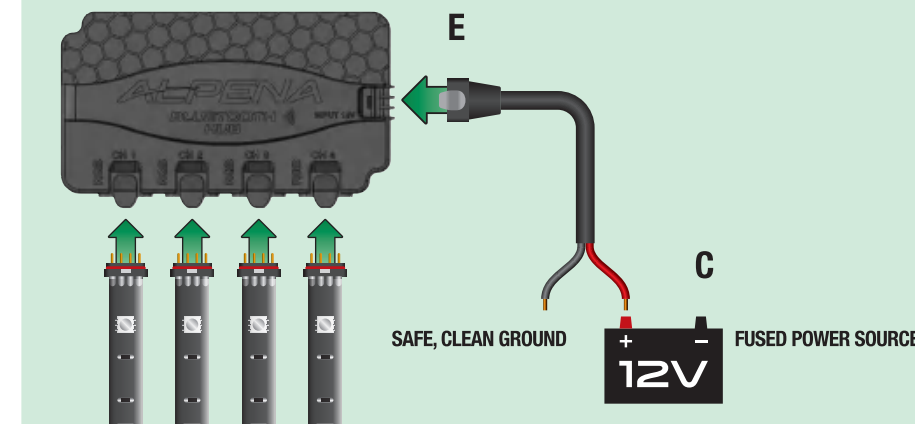

HARDWIRE INSTRUCTIONS

- PREPARE YOUR VEHICLE BY DISCONNECTING THE BATTERY OR POWER SOURCE. FOLLOW THE PROCEDURE IN YOUR OWNER'S MANUAL AND ALWAYS DISCONNECT THE GROUND (BLACK OR '-') FIRST, FOLLOWED BY THE POSITIVE (RED OR '+') WIRE
- STRIP AWAY THE PROTECTIVE SHIELD ON THE RED AND BLACK LEADS ON THE PIGTAIL (COMING FROM THE ALPENALINK™ CONNECTOR WHICH IS CONNECTED TO THE CONTROL BOX)
- CONNECT THE POSITIVE OR RED WIRE FROM THE CONTROL BOX TO THE POSITIVE OR RED BATTERY TERMINAL OR A SAFE, FUSED 12V DC POWER SOURCE
- CONNECT THE NEGATIVE OR BLACK WIRE FROM THE CONTROL BOX TO A SAFE, CLEAN CHASSIS GROUND LOCATION
- CONNECT THE ALPENALINK™ END OF THE HARDWIRE PIGTAIL TO THE ALPENALINK™ MARKED '12V INPUT' ON THE BLUETOOTH HUB



3. MOUNTING

FOR BEST RESULTS, TEMPERATURE AT INSTALLATION SHOULD BE BETWEEN 65-90°F (18-32°C)

- ENSURE MOUNTING SURFACE IS PROPERLY CLEANED AND IS ABSENT OF WATER, OILS, WAX, SEALANT AND OTHER SURFACE COATINGS. SURFACE MUST BE COMPLETELY CLEAN AND DRY DURING INSTALLATION FOR ADHESIVE TO FUNCTION
- TO ATTACH THE ADHESIVE BACKING ON EACH LED STRIP, GENTLY PEEL THE RED BACKING AWAY FROM THE ADHESIVE PAD AND FIRMLY BUT GENTLY PRESS THE GREY SIDE ON TO THE MOUNTING SURFACE - DO NOT APPLY PRESSURE DIRECTLY TO THE LED CHIPS.
- WHEN EACH STRIP IS ATTACHED, SAFELY SECURE THE WIRING TO MAKE SURE IT DOES NOT COME INTO CONTACT WITH ANY ROTATING ASSEMBLIES, DOES NOT COME LOOSE AND CATCH FOREIGN OBJECTS, AND DOES NOT INTERFERE WITH ANY VEHICLE FUNCTIONS
- HARDWIRE INSTALL ONLY** - RECONNECT THE BATTERY TERMINALS OR POWER SOURCE. NEGATIVE (BLACK OR '-') FIRST, FOLLOWED BY POSITIVE (RED OR '+') MAKING SURE ALL CONNECTIONS ARE SAFE AND SECURE

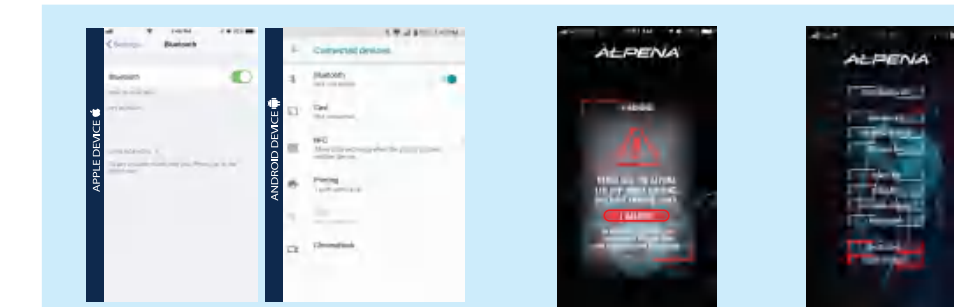
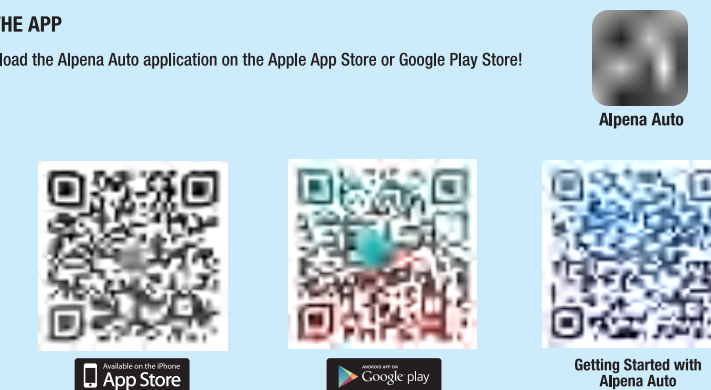
4. OPERATION

THE LED LIGHTING SYSTEM SHOULD BE IN 'DEMO' MODE, DISPLAYING COLOR. IF YOUR KIT IS TURNED OFF, CHECK:

- POWER SOURCE TO SEE IF THERE IS CURRENT FLOW
 - THE MASTER POWER SWITCH
 - WIRING CONNECTIONS BETWEEN THE HUB AND STRIPS
