This intended purpose of this device is to monitor equipment performance, equipment up-time statistics, and inventory management. So all features monitored are non-consumer specific needs.

Since our equipment is used to monitor machines, such as kiosks, vending machines, industrial freezers, industrial pumps and other such equipment it would be impossible for a non-professional to install this device into the larger system without specific equipment knowledge.

The product will be distributed through controlled distribution channel which has special trained professional to install this product.


(2) Installed by licensed professionals.
