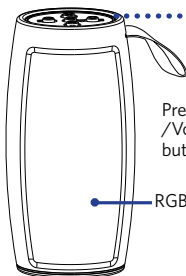

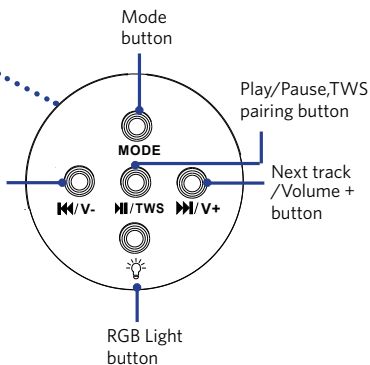
## Buttons and Parts

### Top Control Panel

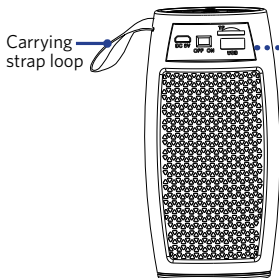

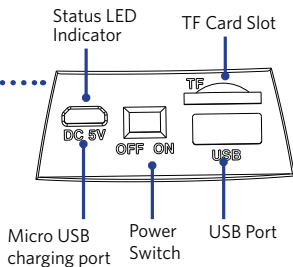
RGB Light



### Back Control Panel

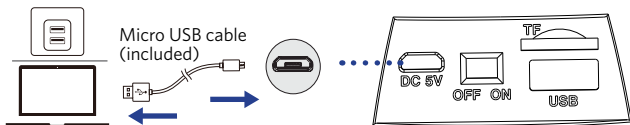


Carrying strap loop





## Charging



Charging	● Steady red (Status LED indicator)
Fully charged	Off (Status LED indicator)
Charging time	2 hours

**Note:** When the battery power level is low, the RGB light may not work, and the volume will turn lower, indicating that it requires charging. When the speaker's battery power gets used up, it will automatically power off.



## Powering on/off

- Slide the **Power Switch** to the "ON" position to turn on the speaker. Once the speaker is on, it will default to Bluetooth mode, and the RGB light will be on,
- To turn off the speaker, slide the **Power Switch** to the "OFF" position, and the RGB light will be off.



## Bluetooth Mode

### Bluetooth connection with your device

When the speaker is on, it will automatically enter Bluetooth pairing mode (If the speaker is in other playback modes, repeatedly press the **Mode button** until the status LED indicator quickly flashes blue to enter Bluetooth mode.). Turn on Bluetooth in your device's settings and search for "CSTW52FD", then tap "CSTW52FD" to connect.

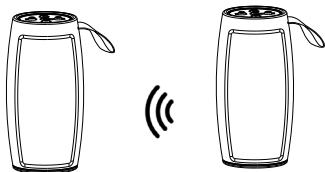

**NOTES:** The speaker will automatically be paired with your last successfully connected media device the next time it is turned on.

## True Wireless Stereo connection

The CSTW52FD supports True Wireless Pairing, which lets you stream your music from your device to two CSTW52FD speakers acting as left and right audio channels for definitive and immersive stereo sound quality. To pair two speakers together, follow the steps below:

1. Bring the two speakers next to each other and turn them on. Make sure neither speaker is connected to any other Bluetooth devices, such as your phone, tablet, or laptop.
2. Press the **Play/Pause button** twice on either speaker until you hear a tone notification,
3. Turn on your Bluetooth in your device's settings and search for "**CSTW52FD**", then tap "**CSTW52FD**" to connect. After they are successfully connected, you can stream music from your phone to both speakers.



### NOTES:

- Both speakers will reconnect automatically the next time they are both on, in range and pairing mode.
- To unpair speakers, press twice on the **Play/Pause button** on either speaker; to pair again, press the **Play/Pause button** twice again.

## For Music Playback

Play / Pause	Press the <b>Play/Pause button</b> <b>⏮</b> once
Next track	Press the <b>Next Track/Volume+</b> <b>⏭</b> button once
Previous track	Press the <b>Previous Track/Volume -</b> <b>⏪</b> button once
Volume up	Press and hold the <b>Next Track/Volume+</b> <b>⏭</b> button
Volume down	Press and hold the <b>Previous Track/Volume -</b> <b>⏪</b> button

**Note:** When you receive or make a call, you can press the **Play/Pause button** once to answer the call. And the music that is playing will automatically pause. But the person's voice on the other end of the line can only be heard through your phone. You can press and hold the **Play/Pause button** to end the call. Press and hold the **Play/Pause button** to reject a call, then the music will resume.



## FM Radio mode

Repeatedly press the **Mode button** to switch to the FM Radio mode. Insert the included Micro USB charging cable into the charging port as an antenna to adjust for better signals.

Press the **Play / Pause button** to automatically search for the radio stations, then all available radio stations will be stored by the preset channel number in order, and the first preset radio station will broadcast automatically.

While searching for the radio stations, press the **Play / Pause button** again to stop searching and broadcast the current frequency radio.

Next radio station	Press the <b>Next Track/Volume+ button</b> once
Previous radio station	Press the <b>Previous Track/Volume - button</b> once
Volume up	Press and hold the <b>Next Track/Volume+ button</b>
Volume down	Press and hold the <b>Previous Track/Volume - button</b>

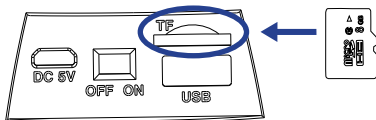


## Playing from external device

### USB / TF card

Under any mode, insert a TF card/USB disk into the TF card slot/USB port of your speaker, it will immediately play the music files in the TF card, USB disk.

The music playback controls are the same as the Bluetooth mode.



The speaker will take the newly connected USB disk or TF card as the first priority for the music playback. If the USB disk and TF card are connected to the speaker at the same time, you can repeatedly press the **Mode button** to toggle these playback modes, and the playback mode will change as follows:



## RGB Light Mode

There are 6 light modes available, under any playback mode, repeatedly press the **RGB Light button** to toggle between the 6 light modes. Press and hold the **RGB Light button** to turn off the RGB light. In light off mode, press the **RGB Light button** once to turn on the light again.
