TOP VIEW OF CARVAAN GO

3.5 mm audio jack for connecting external speakers using Aux cable or to plug in headphones

Power

Power: press for 3 - 4 seconds to power on/off GO; press for a second or less to lock/ unlock GO. If your GO hangs or becomes slower, press for 7-8 seconds to reboot

USB to Micro USB Cable
Voltage: 220V
Frequency: 50 Hz for input and 5V 1A for output

LEFT SIDE VIEW OF CARVAAN GO

- SD***: In this mode, enjoy your personal collection of songs stored on your personal micro SD card, SD card mode can also be used as Data Transfer Mode. Here you can transfer your personal collection of song, files etc to and from your Laptop/PC.
- FM/AM****: Press the mode button to switch between FM & AM. Your earphones act as signal to FM/AM. To use FM (on internal speakers of GO or your own Bluetooth speakers), you will need to plug your earphones into GO
To auto tune FM/AM stations, follow the steps:
Step 1: Press play/pause button for 5 seconds
Step 2: Searching for all FM/AM signals will start. You will hear a searching sound & each FM/AM station will play for approx. 3-4 seconds till all stations are tuned
Step 3: Press next/previous button to go to next/previous station
FM frequency: 87.5 to 108 MHz
AM frequency: 520 to 1710 KHZ
Note: It is recommended that you do not put the unit on charge while listening to FM/AM as it will interrupt the signal
- SD SLOT**: open the flap to insert your personal micro SD card
** support for micro SD card capacity less than or equal to 32GB*
*** AM station will play as per broadcast timings*

ARTISTES: 25+ artiste based stations like Lata Mangeshkar, Kishore Kumar & others; this is the default mode on first power on/reset

RESET: Press Artistes & Playlists together for 8 to 10 seconds

SAREGAMA CARVAAN APP

Download the Saregama Carvaan app from the Apple / Android store to enjoy a host of free and subscription based services.

Free services - Use the app to find a song, create playlists to play out on your Carvaan unit.

Note: To use the app, press the 'Saregama mode' button on Carvaan GO. Connect the app & Carvaan GO using Bluetooth on your phone/tablet

Subscription services - Subscribe to the app and listen to the songs on your phone/tablet without being connected to the Carvaan GO

BATTERY

Full battery charge time: Approximately 2 hours
Battery usage: Approximately 7 hours once the battery is fully charged

CONNECTING GO TO BLUETOOTH SPEAKERS

Step 1: power on your Bluetooth speakers
Step 2: press the Bluetooth mode button for 3-4 seconds to turn on Bluetooth on GO
Step 3: turn the dial left/right or press previous/next button to select the speaker
Step 4: press Play/Pause to connect GO to the selected speaker
Step 5: once connection is established, the song plays on the selected Bluetooth speaker
Step 6: to disconnect, press the Bluetooth mode button & press play/pause button on the connected speaker
Step 7: press the Bluetooth mode button for 3-4 seconds to turn off Bluetooth on GO

CONNECTING GO TO CAR SPEAKERS: Follow all the steps above.

If prompted for a pin / passkey, follow the steps below

- Press the Bluetooth mode button
- Use rotary dial and go to 'Change passkey of GO'. Press play/pause to change the pin / passkey of GO
- The default passkey of GO is 0000. To change, use rotary dial to change digits from 0-9 and <- to move digits
- Once all the digits are entered, press play/pause to submit this passkey
- Follow the steps and reconnect to the car Bluetooth speakers from the list of available devices on GO

Remember: If you turn on Bluetooth on GO, do not connect or play out for more than 30 minutes. GO will automatically turn off Bluetooth to help conserve battery

WARRANTY TERMS

Warranty is provided only on Product(s) which is purchased from Saregama, Saregama Authorized Dealer, Authorized Reseller or Authorized Online Resellers.

To claim the Warranty Customer will have to mail their request to help@saregama.com

The Customer will receive as reply to his/ her email an address on which said Customer may send the defective unit of the Product ("said address").

The defective unit of the Product & Accessories must be sent to the said address (with the original packaging when purchased or similar packaging) at the cost of the Customer. Once the said defective unit of the Product & Accessories is received at the said address, Saregama will dispatch a fresh unit of the Product & Accessories to Customer's address. In the event on receipt, Saregama finds that the allegedly defective unit of Product does not have any defects, Saregama will dispatch the same unit of the Product & Accessories received from Customer, back to the Customer's address.

To avail the Warranty, customer will have to provide the invoice of the unit of the Product purchased by customer to Saregama, either by dispatching it along with the defective unit or by emailing at the email address provided for the same purpose a scanned copy of the said invoice. The replaced unit of the Product & Accessories shall become the property of Saregama.
