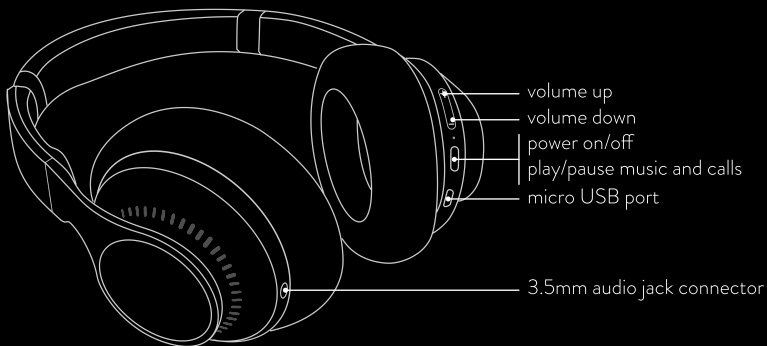
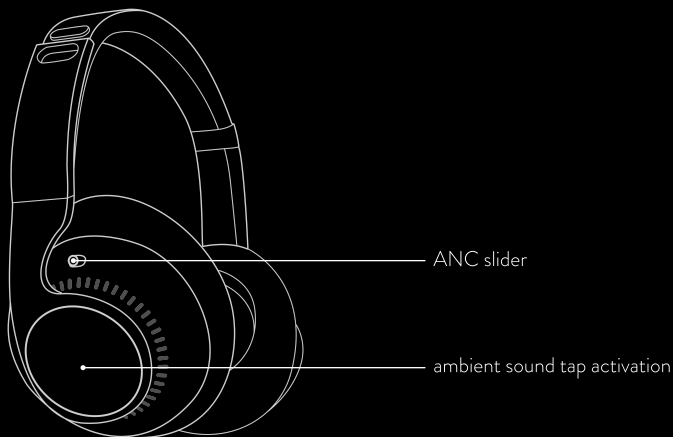

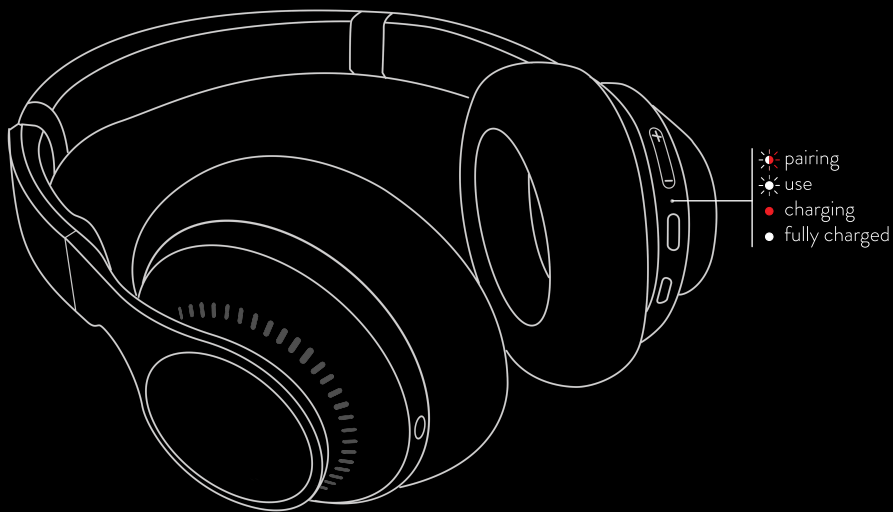

## **blackbox limited warranty (United States only)**

Blackbox Limited warrants this product against defects in material or workmanship for (1) year as set forth below when purchased directly from Blackbox Limited or a Blackbox Limited retailer. If Blackbox Limited elects to replace the product after this Labor Warranty has expired but while the parts warranty is still in effect, it will do so for the applicable labor charge.

**Parts:** For a period of (1) year from the original date of purchase of the product (“Parts Warranty”), Blackbox Limited will supply new or refurbished replacement parts in exchange for parts determined to be defective.
