



## 使用说明

- 1. 接通电源后,蓝色呼吸灯连续呼吸3次后熄灭;
- 2. 将手机放在感应区内进入充电状态,蓝色呼吸灯连续呼吸8次后熄灭;
- 3. 感应到金属异物时,蓝色呼吸灯会不停的闪烁,并开启充电保护功能。
- 注:被充电设备必须符合Qi标准才能使用。


