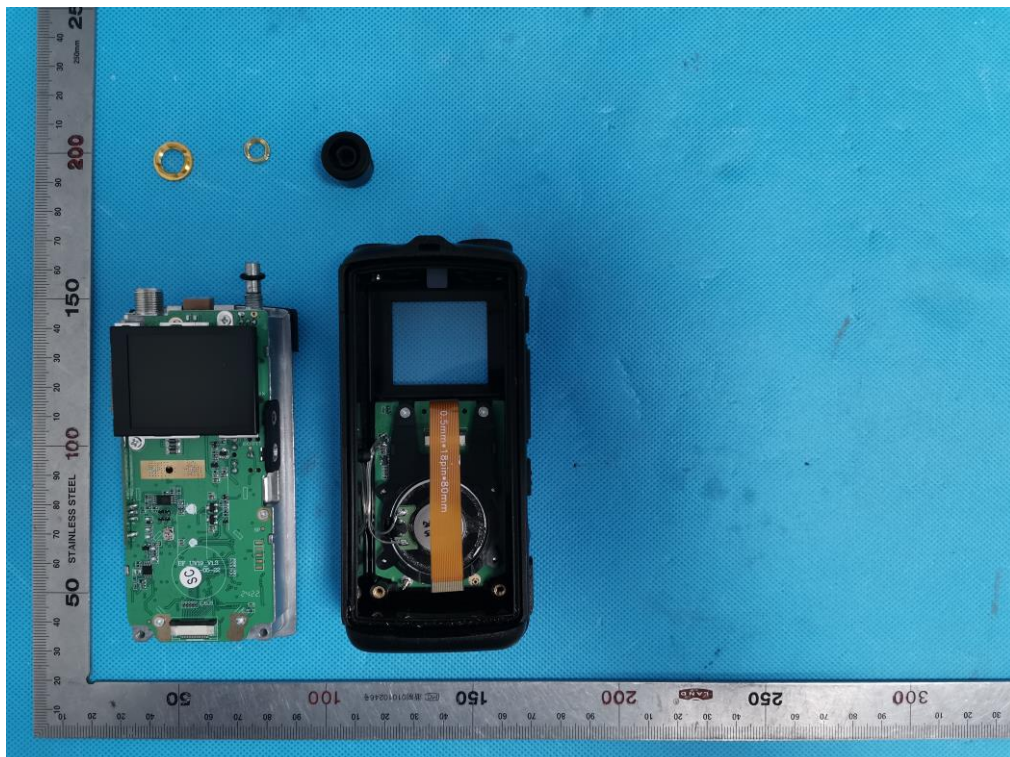


### INTERNAL PHOTOS OPEN VIEW OF EUT (FIGURE 1)

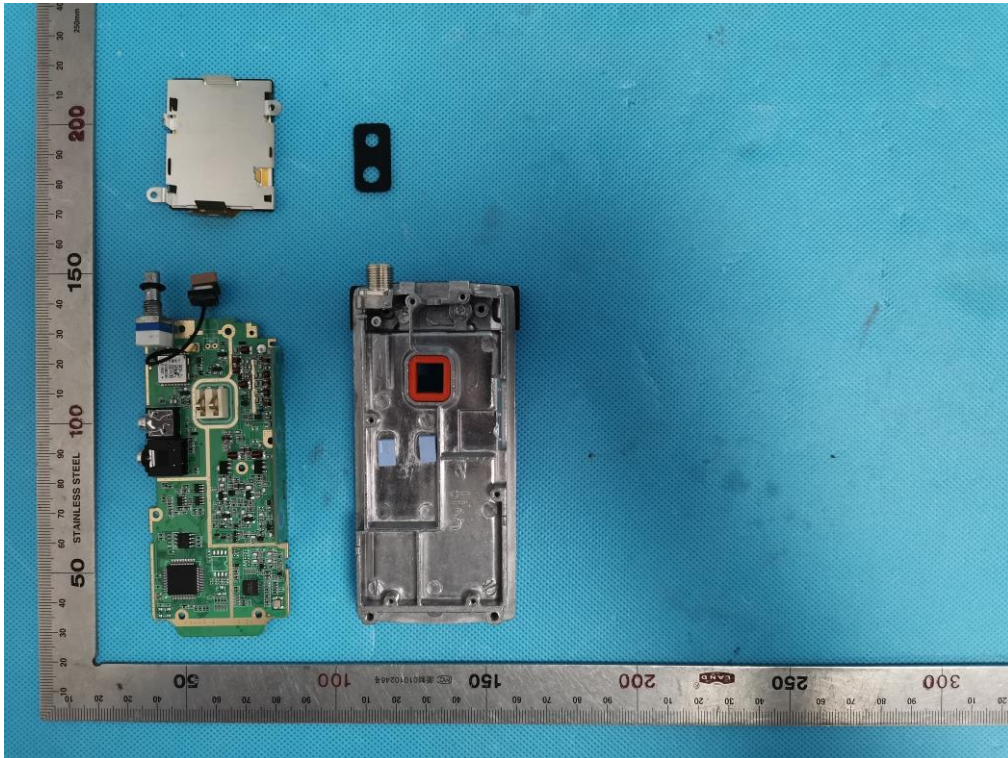


### OPEN VIEW OF EUT (FIGURE 2)

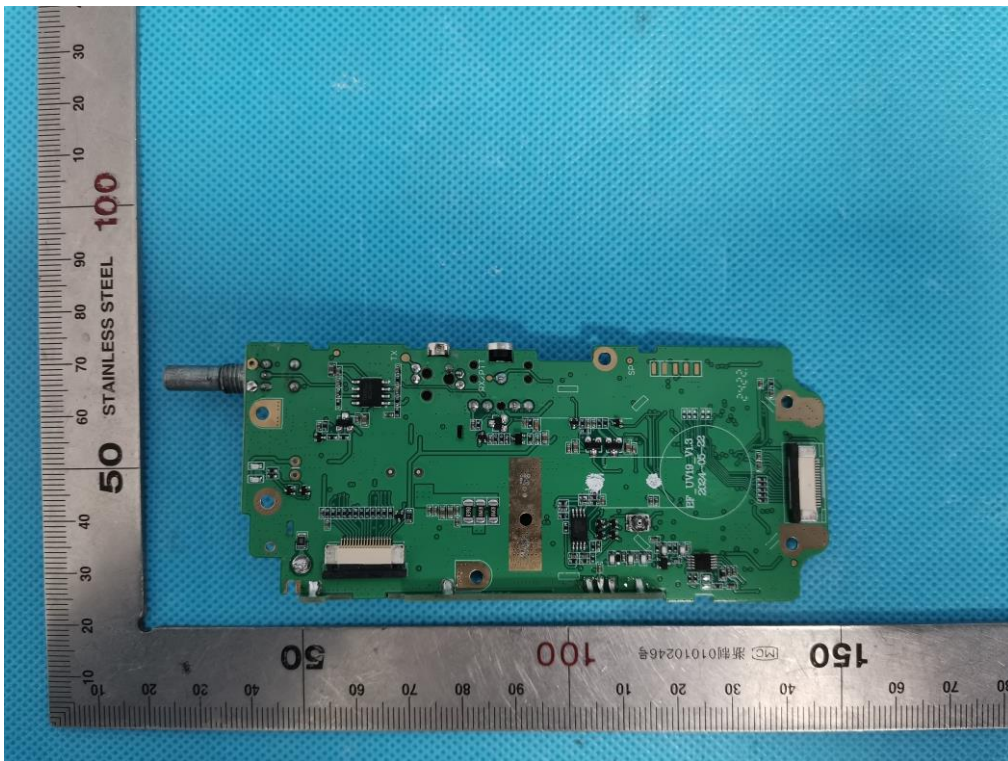

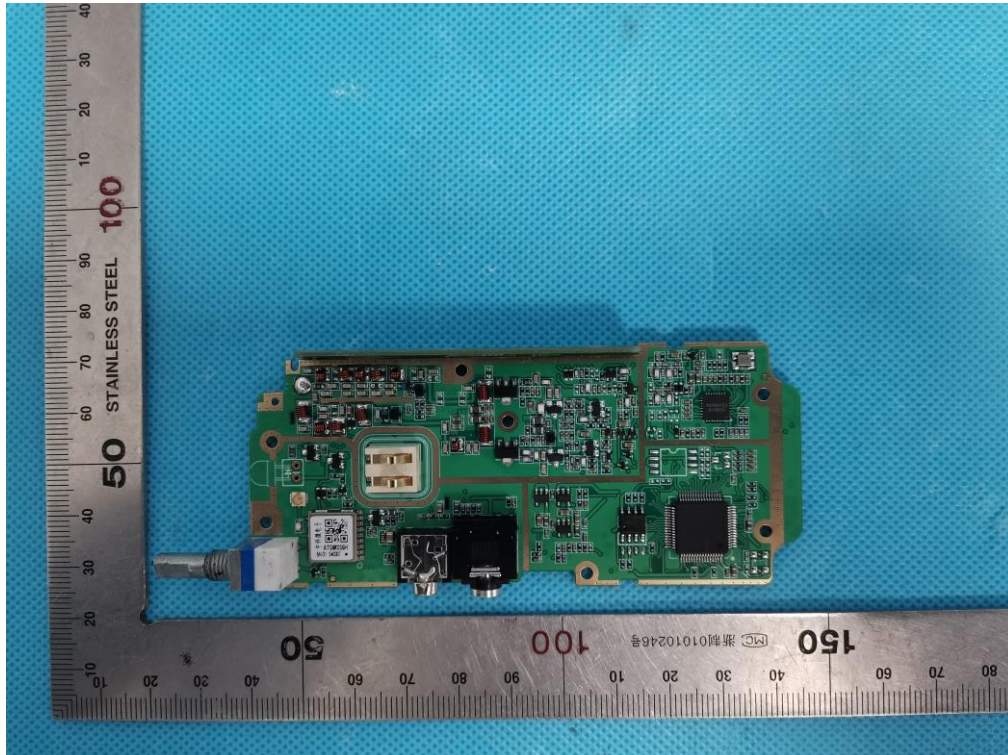

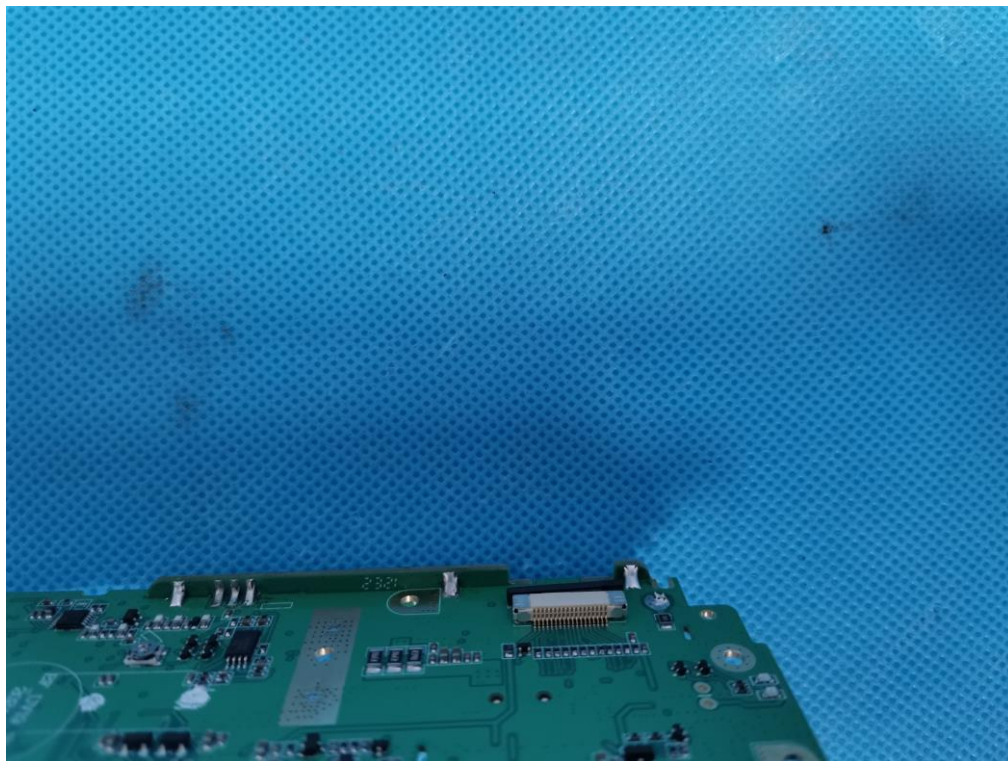

INTERNAL VIEW OF EUT (FIGURE 2)

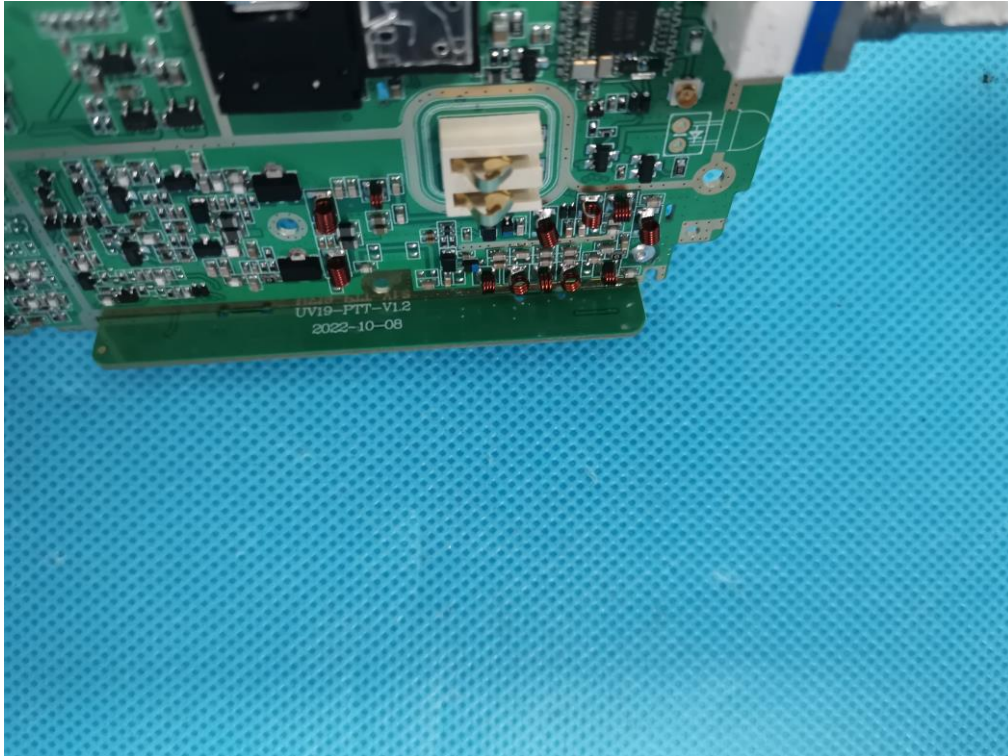

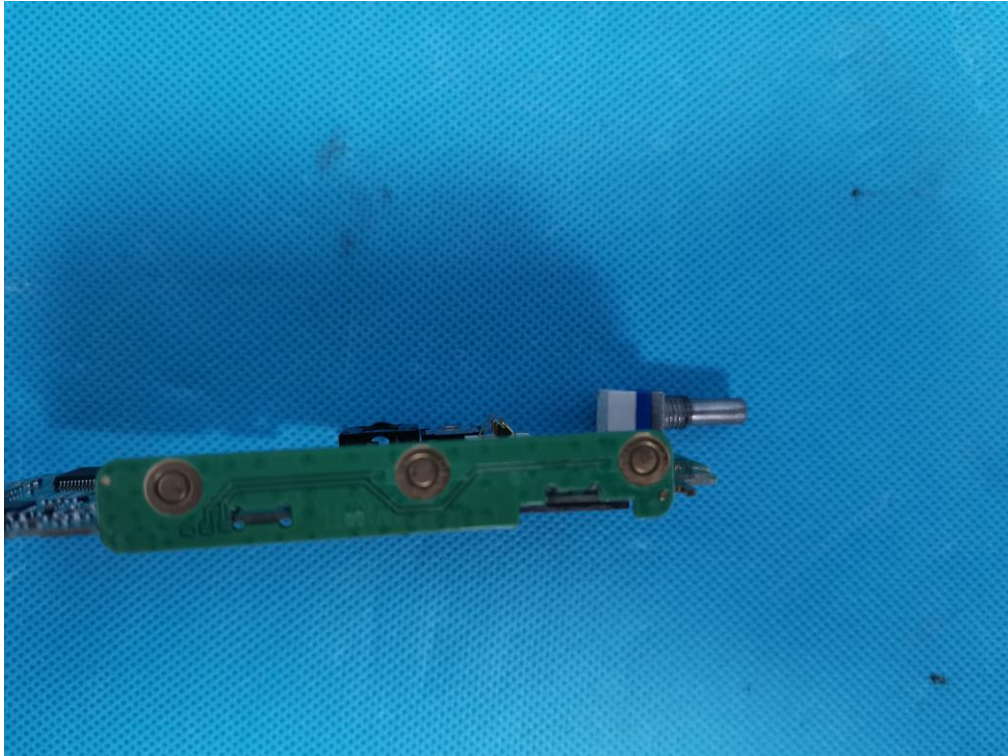

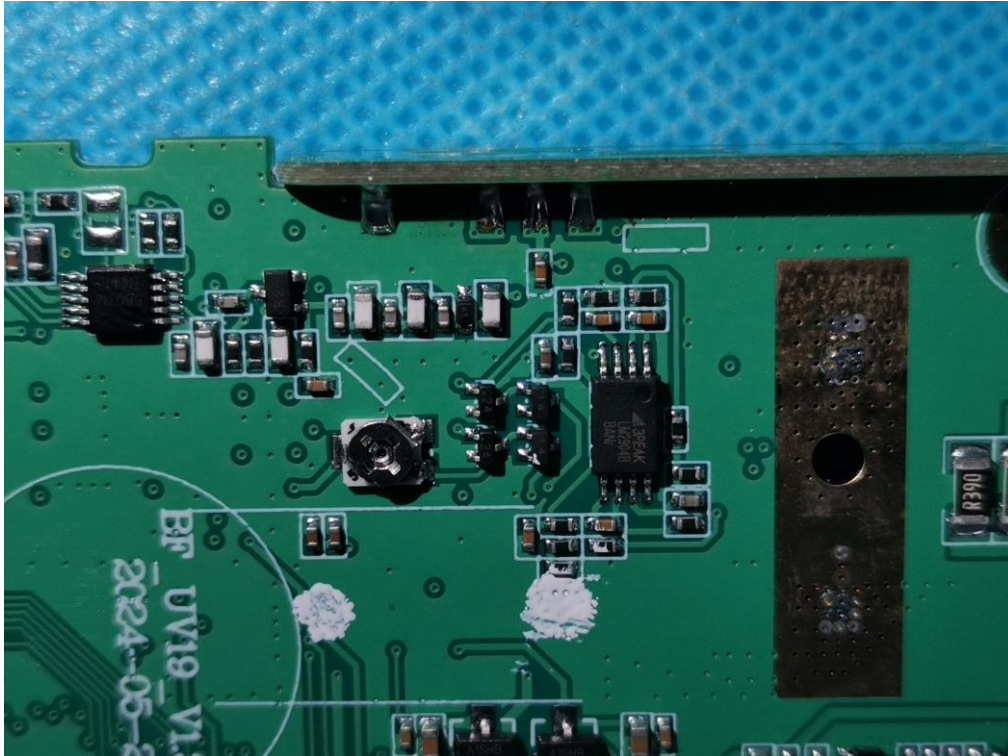


INTERNAL VIEW OF EUT (FIGURE 7)

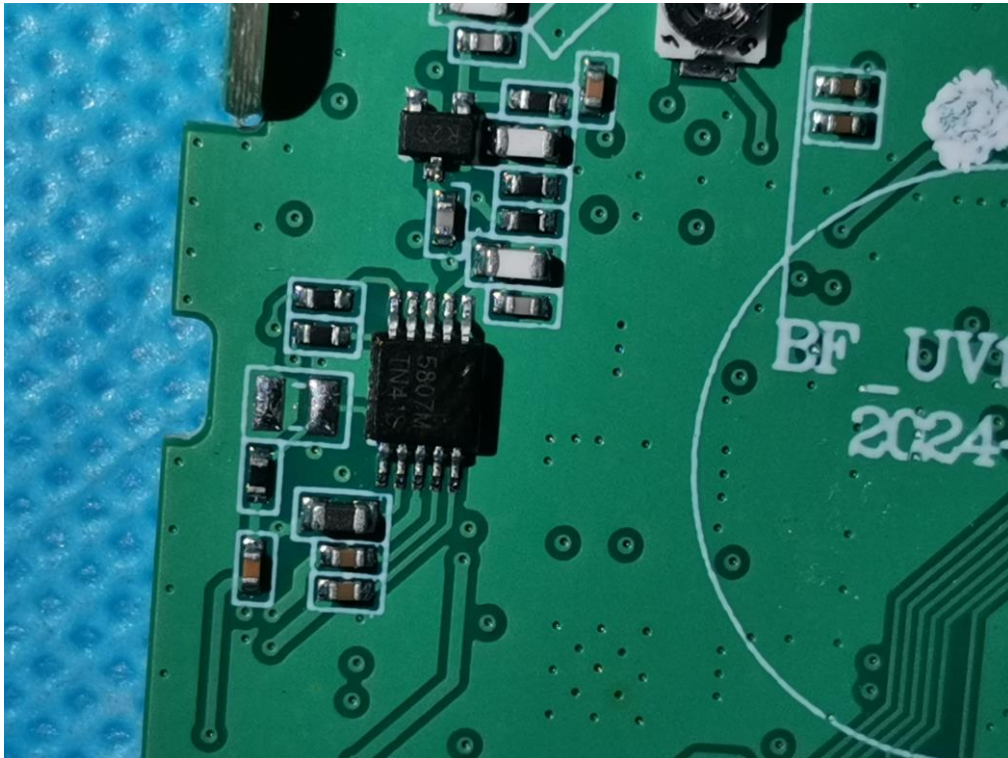

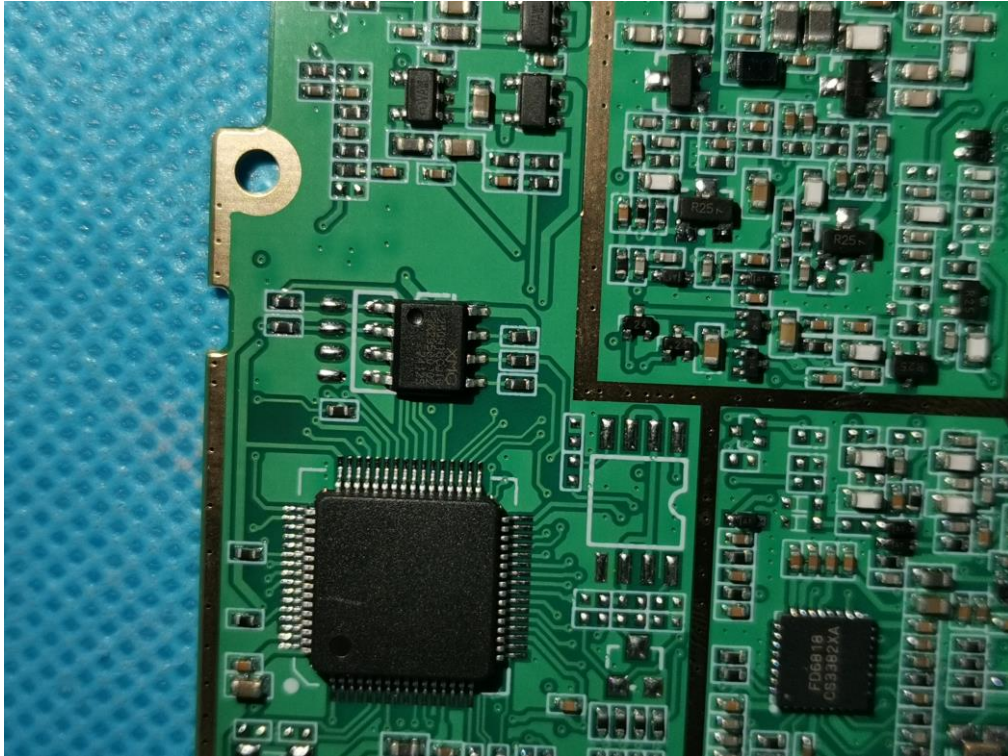


INTERNAL VIEW OF EUT (FIGURE 9)

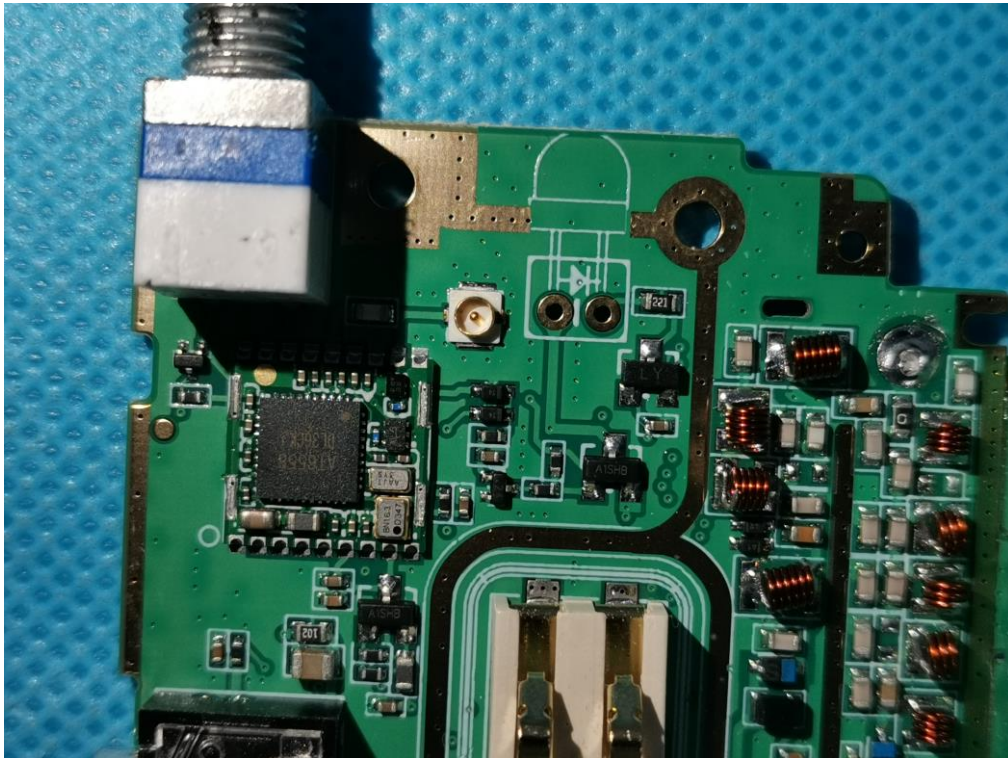

INTERNAL VIEW OF EUT (FIGURE 10)

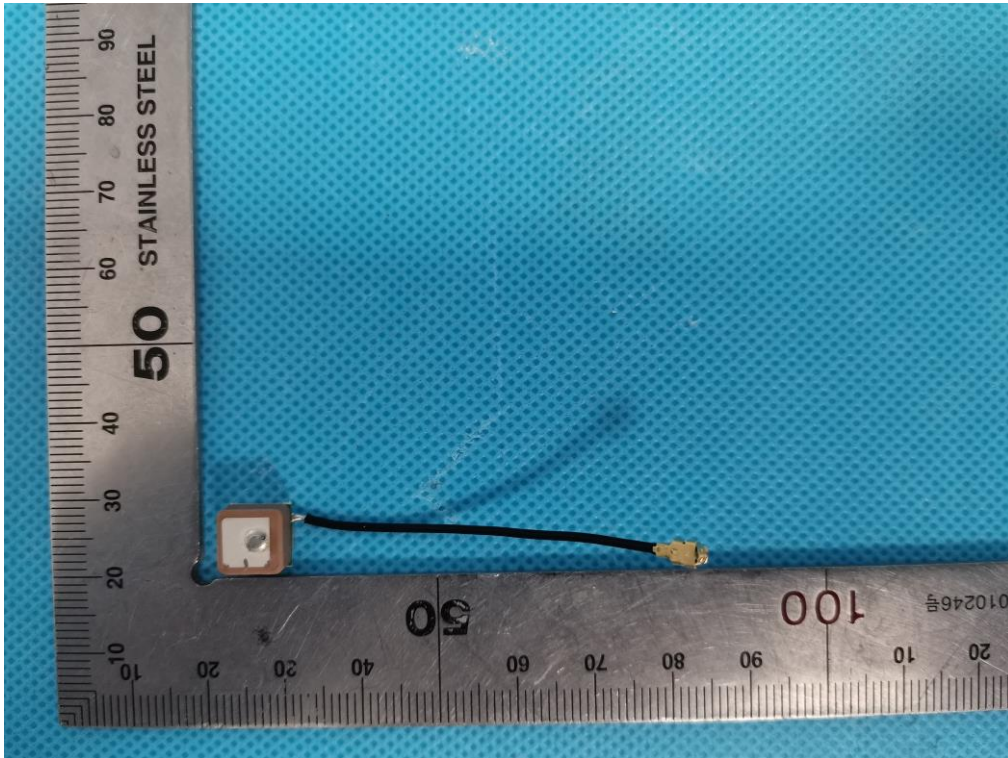


INTERNAL VIEW OF EUT (FIGURE 11)

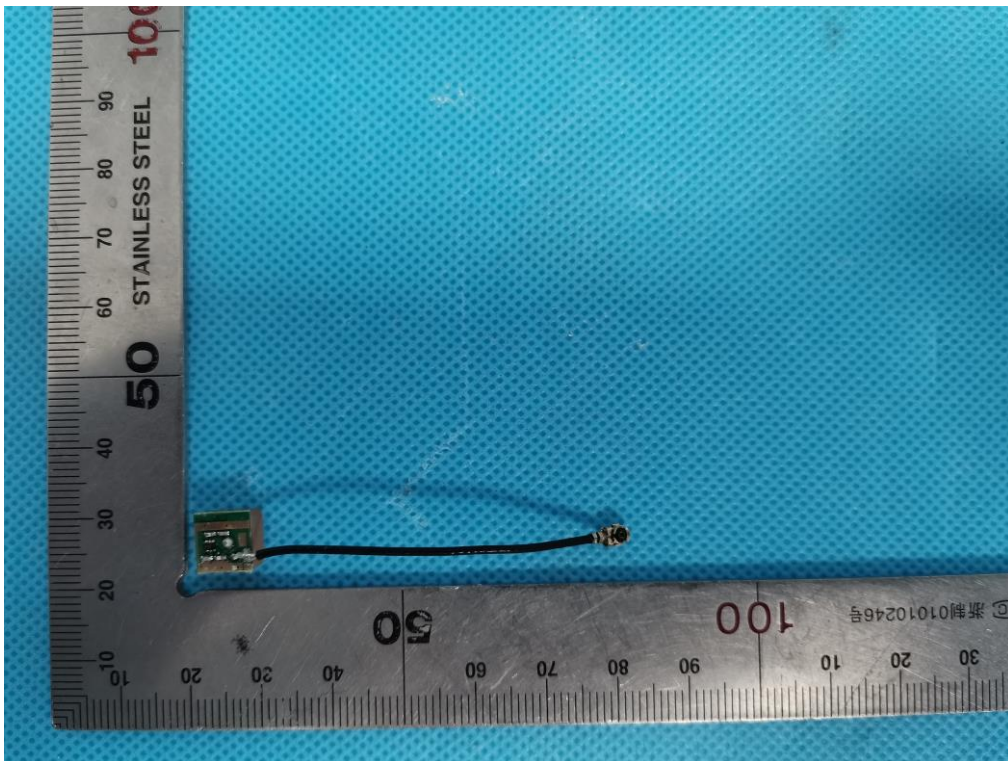

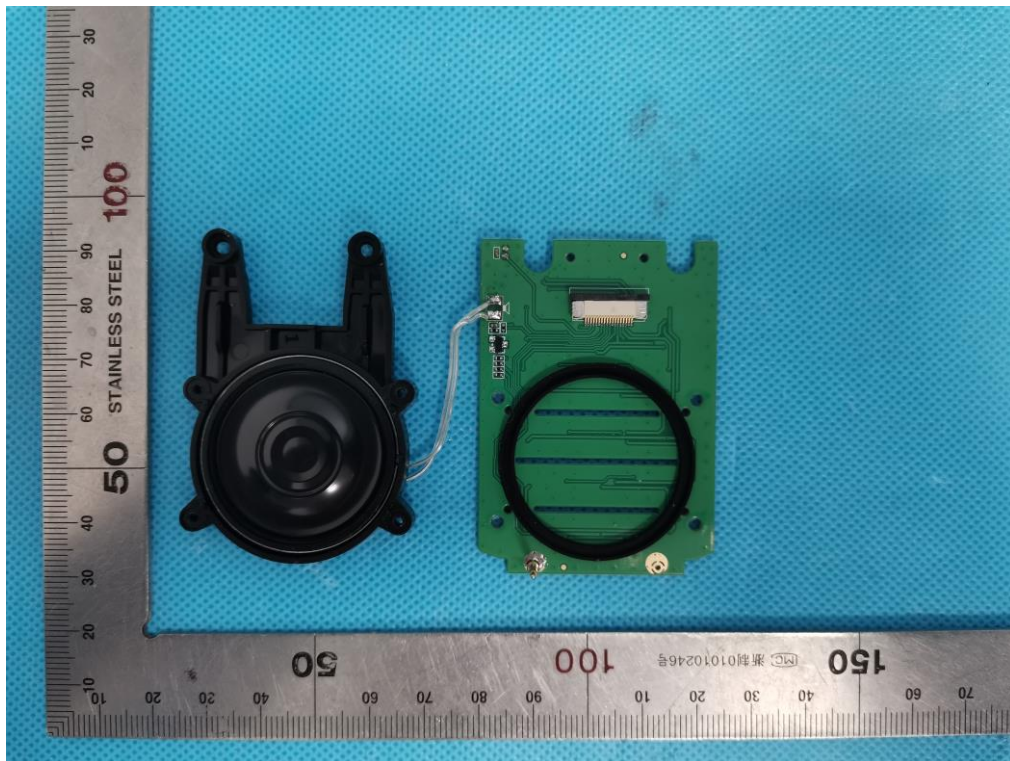

INTERNAL VIEW OF EUT (FIGURE 14)

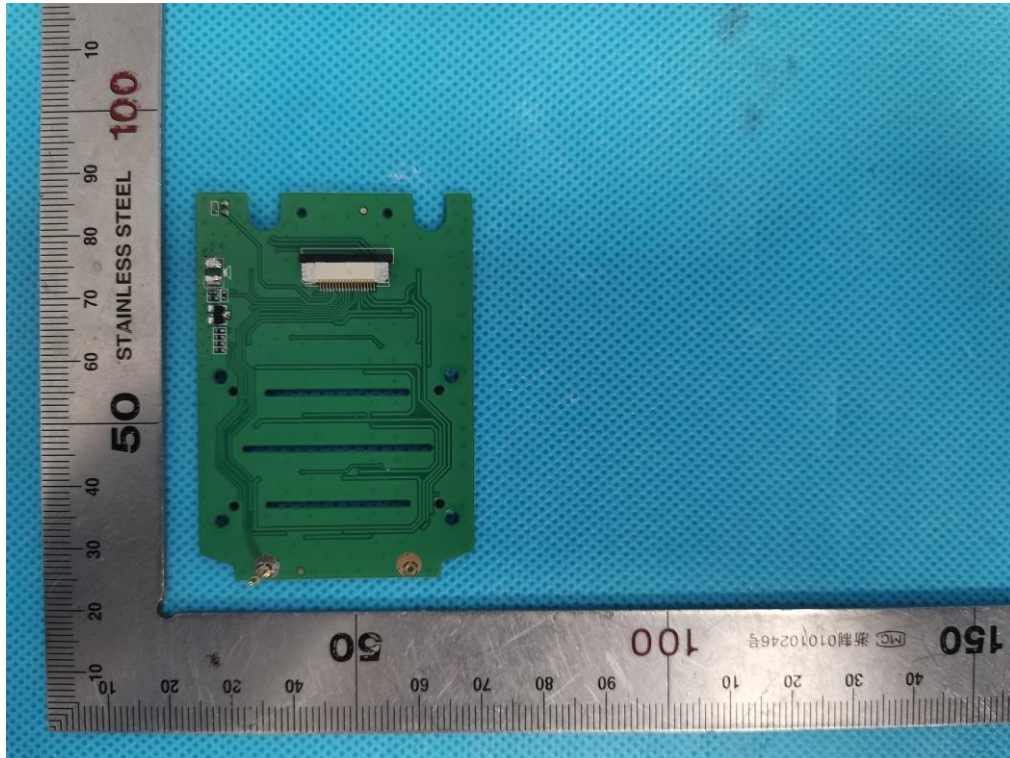

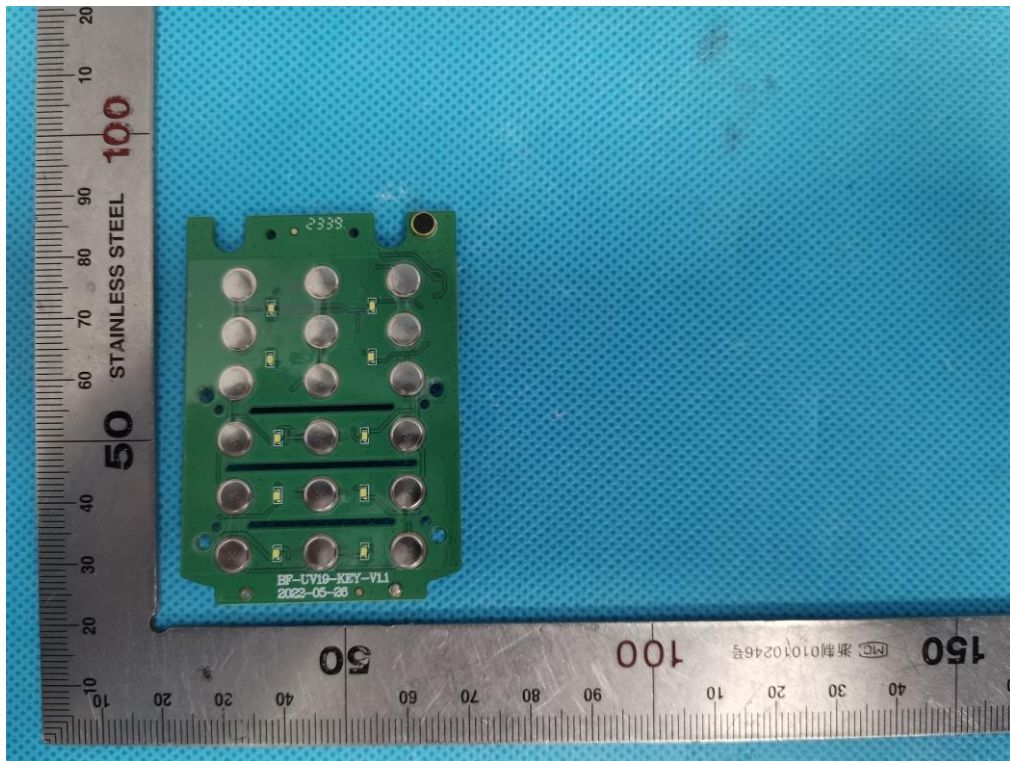
