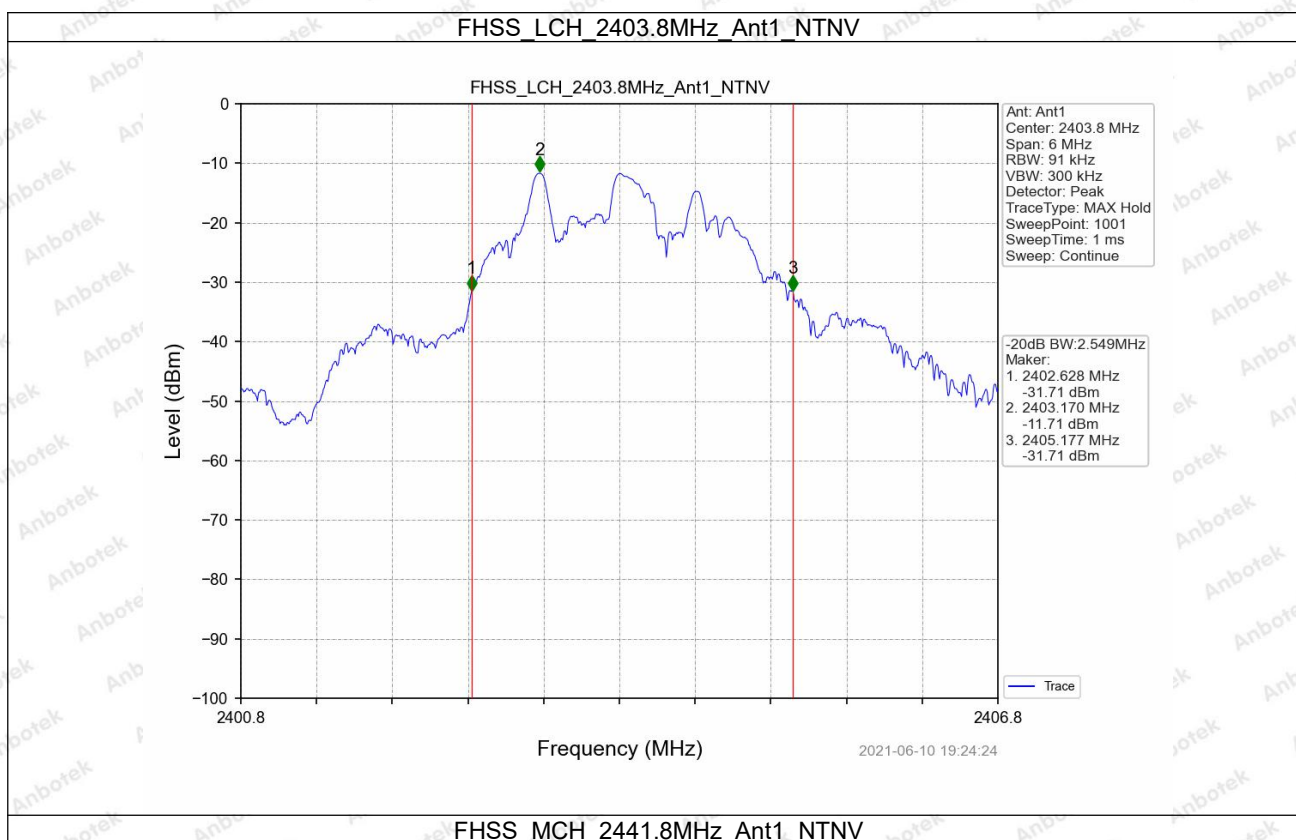

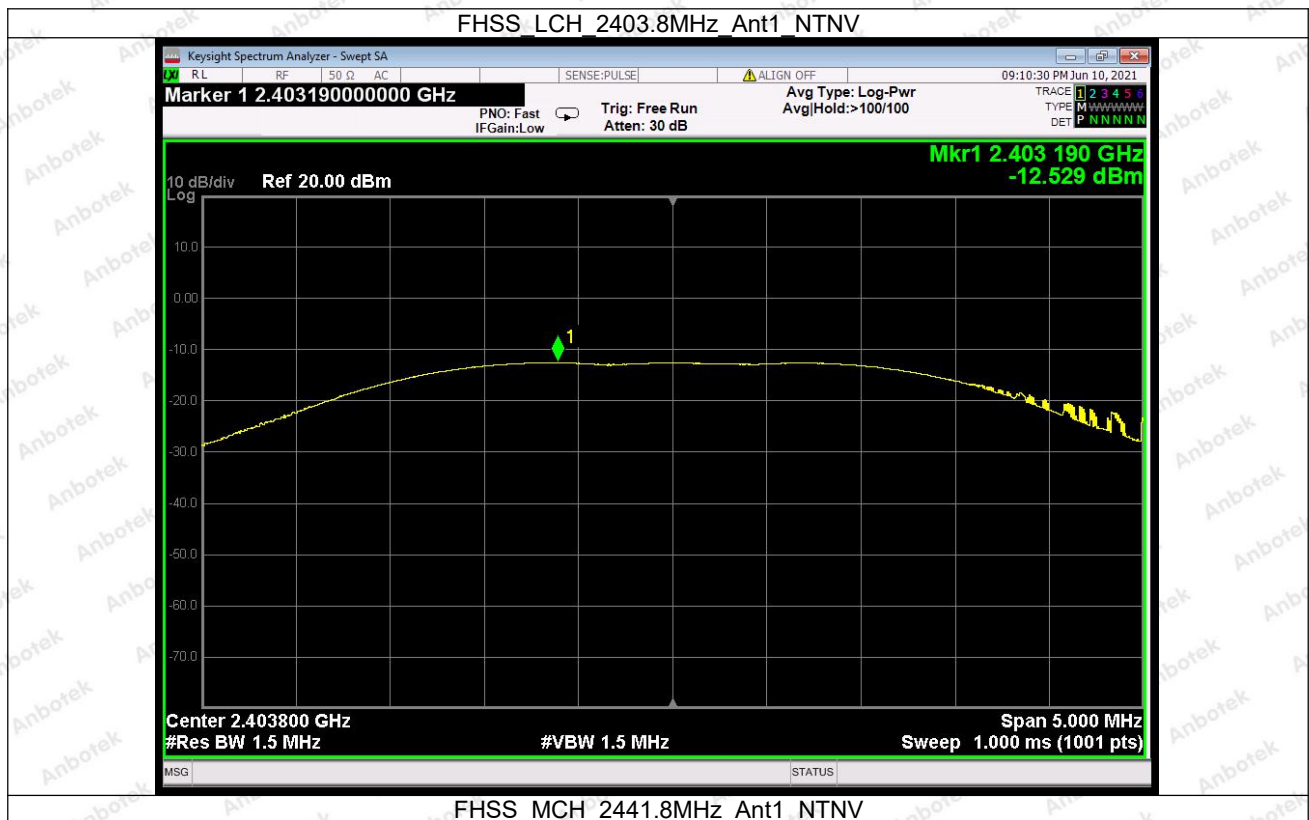

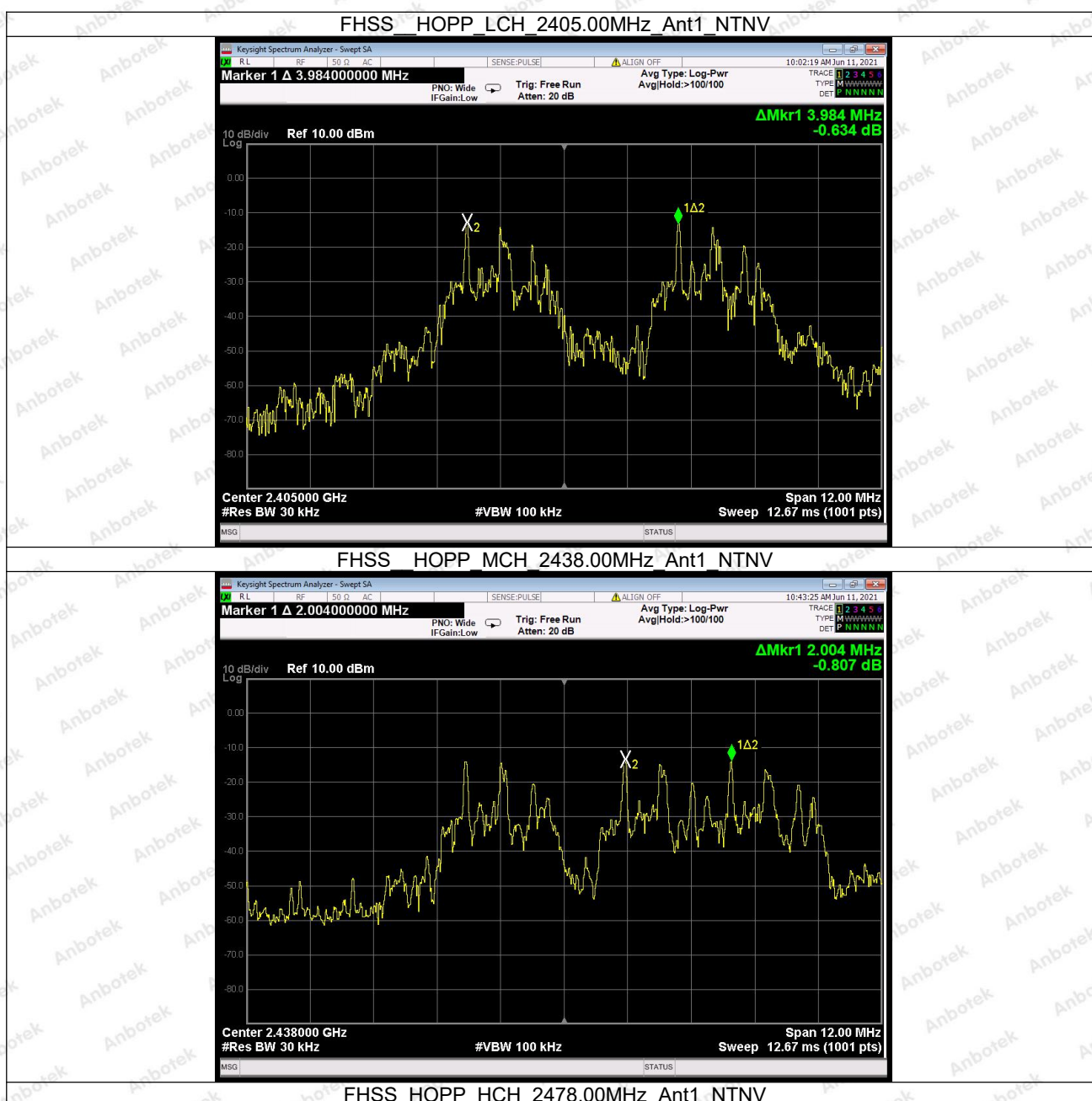

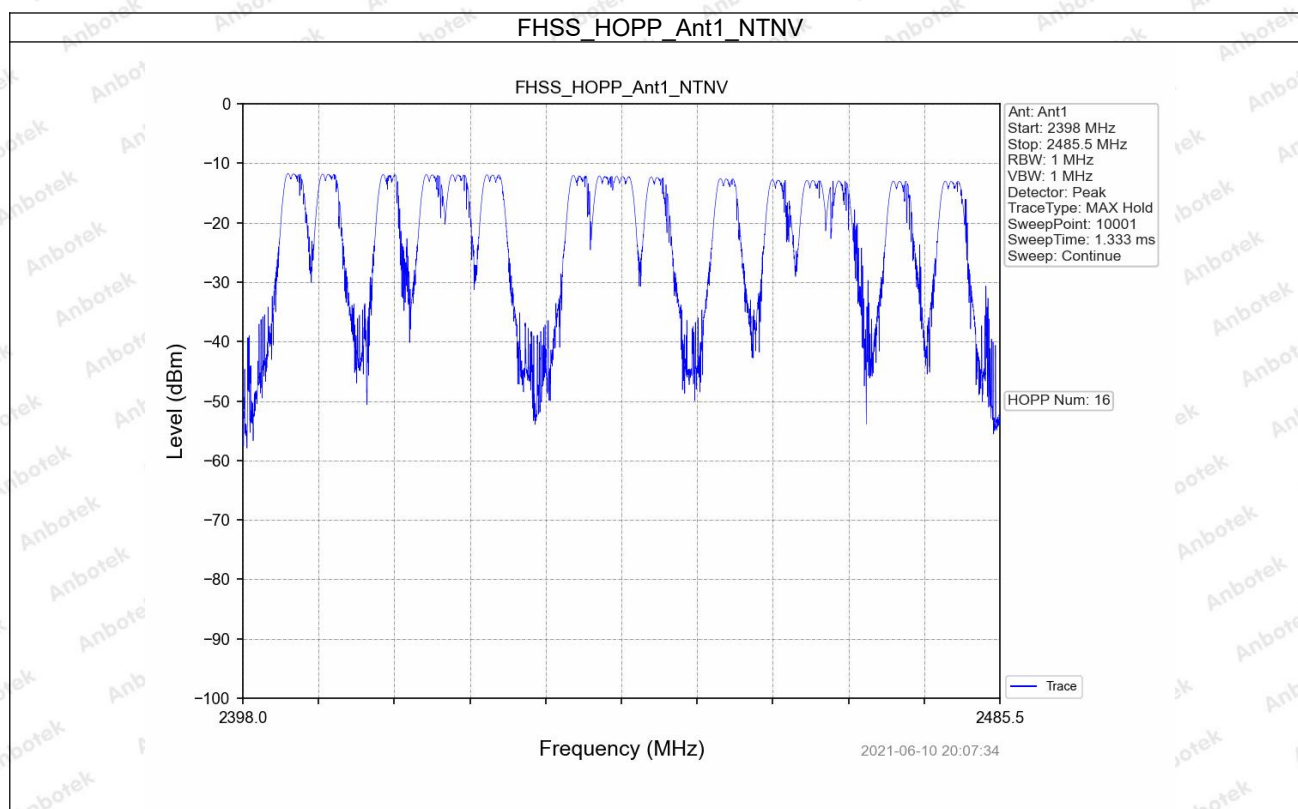

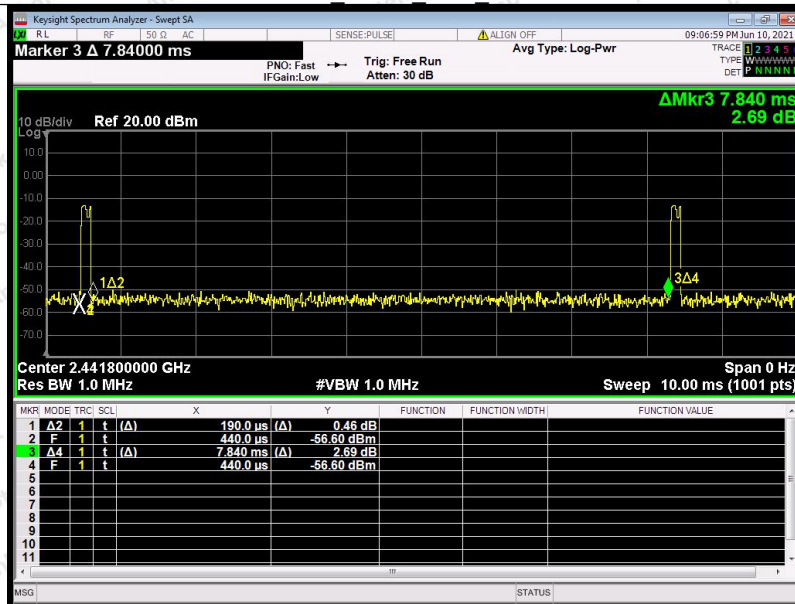

FHSS HOPP Period Ant1 NTN



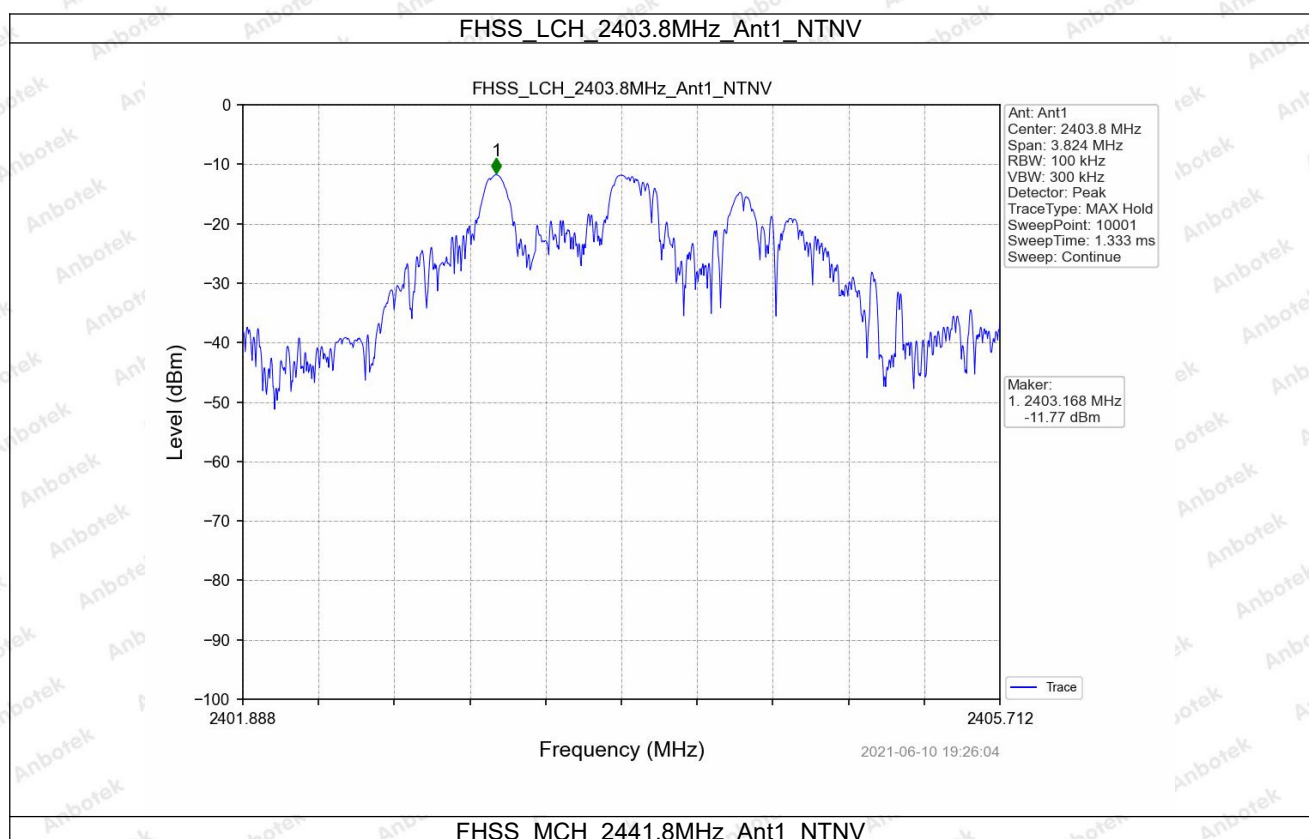
