- (a) Use a suitable cable to connect the Wireless Car Charger
- (*Remarks: This wireless car charger is suitable for 10W fast charge, need to connect to a Fast Charge power like 9V/2A)
- (b) Fix the Wireless Car charger to car's air condition mount or somewhere suitable
- (c) Put a Smartphone in the Wireless Car charger, the gravity design will make the charger close automatically and fix the Smartphone inside.
