2.2 Test Mode



- 7. The Measured power density (dBm)/ 100kHz is a reference level and used as 20dBc down limit line for Conducted Band Edges and Conducted Spurious Emission.





PSD 100kHz Plot on Channel 39







Unwanted Emissions measured in any 100 kHz bandwidth outside of the authorized frequency band shall be attenuated by at least 20 dB relative to the maximum in-band peak PSD level in 100 kHz when maximum peak conducted output power procedure is used. If the transmitter complies with the conducted power limits based on the use of RMS averaging over a time interval, the attenuation required under this paragraph shall be 30 dB instead of 20 dB.
- 5. Measure and record the results in the test report.
- 6. The RF fundamental frequency should be excluded against the limit line in the operating frequency band.





3.5.3 Test Procedures

- 1. The testing follows ANSI C63.10-2013 clause 11.11 & 11.12
- 2. The EUT was arranged to its worst case and then tune the antenna tower (from 1 m to 4 m) and turntable (from 0 degree to 360 degrees) to find the maximum reading. A pre-amp and a high pass filter are used for the test in order to get better signal level.
- 3. The EUT was placed on a turntable with 0.8 meter for frequency below 1GHz and 1.5 meter for frequency above 1GHz respectively above ground.
- 4. The EUT was set 3 meters from the interference receiving antenna, which was mounted on the top of a variable height antenna tower.
- 5. Corrected Reading: Antenna Factor + Cable Loss + Read Level Preamp Factor = Level
- 6. For testing below 1GHz, if the emission level of the EUT in peak mode was 3 dB lower than the limit specified, then peak values of EUT will be reported, otherwise, the emissions will be repeated one by one using the CISPR quasi-peak method and reported.

 - VBW ≥ 1/T, when duty cycle is less than 98 percent where T is the minimum transmission duration over which the transmitter is on and is transmitting at its maximum power control level for the tested mode of operation.






For radiated emissions below 30MHz



3.7 Antenna Requirements




