

#### 1. INSTALL SENSOR

Take out the sensor from the packaging box. Unzip the mattress cover at the head end, and place the sensor on the matress (See picture). The bottom of the sensor should be attached to the inner cover and edge alignment.



#### 2. DOWNLOAD APP

To download the app, scan the QR-code or search for it in the APP store. Currently the app is available in the APPLE store,Google play . When searching for APP, please enter "smart sleep" .You will need to scroll down to find the Mlily APP as per the screenshot below.







#### 3. REGISTER ACCOUNT

The user can register using email. The user can also login to the app using their 3rd party account eg facebook .



#### 4. INSTALL EQUIPMENT

Before installing the equipment the user needs to count all of the parts to make sure if they are working correctly. •Mattress\*1 •Controller \*1 •Battery charger\*1

- •MicroUSBdata wire\*1
- •User manual\*1
- •Audio wireinside of the mattress\*1 •Sensor\*1

After checking the parts and following the steps to connect, at last switch on the power. Notice:

•To avoid danger the voltage needs to be AC100-240V.


•The mattress should be face up as the sensor is located on this side.

 $\bullet \mbox{The light sensor should be"}$  unobserved at all times to avoid getting

the sensor wet, it should not be placed by an opened window. •In order to receive clear data, make sure it is positioned in the same side with the audio wire. Which is for sleeping.

•All parts need to be connected tightly untill they can be not moved.





After connecting, the user can turn on the light to check if it is working. On the side there is a touch button, use this button to check if it is working.



#### 5. CONNECT EQUIPMENT

To connect the equipment the user needs to connect the wifi code with the app.

Before connecting the equipment prepare the following:

1.Connect all of the equipment tightly and switch on the power.

2.Make sure the phone uses wifi internet.

3.Open the app and find the page named "add equipment".

Settings $\rightarrow$ equipment $\rightarrow$ find the "add equipment" button in the bottom of the page.



Follow these steps to connect the equipment:

1.Insert the wifi code in the sourcing page, don't click enter!

2.Push the light-switch; it will light up red.

3.Now click on enter in the app. If the phone finds the equipment, the light will change from red to green.

4. The equipment will appear in the list, select the equipment; the connection should be successfully.



If the user cannot find the equipment in the sourcing page; try the following steps to connect the equipment again.

If any problems still appear notice the following:

1.Wifi 2.4hz,5G is not allowed.

2.Check if the wifi code is right.

3.Sourcing the equipment might be slow in the first time, please in patient. It might take up to 40 seconds.

#### 6.USER SETUP

For a single user follow these steps:

After connecting click on the list in app to add a user. Fill in the page of user information. Input name, gender, day of birth, height, and weight. Click save to finish. During setup click on the head portrait in the page of user information, then add the member to MLILY. (The button on the mattress can also be used to setup the user information, and to add the member to MLILY.)



For the couple follow these steps:

After connecting click on the list in app to add a user. Fill in the page of user information. Input the users name, gender, day of birth, height, and weight. Click save to finish. Repeat this step for the second user. (Notice that the setup depends on the place each user sleeps)



#### Notice:

There are two versions in the equipment. For the couple version it is important to tell the difference. For the single version it is not important to tell the difference.

If a single user wants to use the couple version, only one user needs to be setup. Otherwise the other mattress will appear irregular.


#### **7.DATA REPORTS**

#### 7.1 PERSONAL REPORTS

The app will output the sleeping data. This data shows the user' s sleeping scores, sleeping cycle, time slept, percentage of time sleeping tightly, percentage of time sleeping deeply, heart rate, breathing rate, times moved. All of this data can be shown clearly.

There is a both daily sleeping report and a monthly sleeping report, so that the user can monitor the sleep quality over a period of time.







#### 7.2 3rd PARTY MONITORING

In this section of the APP,the user can see other people's data in a day,to monitor the sleep quality of loved ones too.
