1.INSTALL SENSOR

Take out the sensor from the packaging box. Unzip the mattress cover at the head end, and place the sensor on the matress (See picture). The bottom of the sensor should be attached to the inner cover and edge alignment.



2.DOWNLOAD APP

To download the App, scan the QR-code or search for it in the App store.Currently the App is available in the App store and Google play. When searching for App, please enter "Smart Sleep" or "MLILY". You will need to scroll down to find the Mlily App as per the screenshot below.





Warranty certificate

Warranty conditions:

3.REGISTER ACCOUNT

- (1). The user can register using their email. The user can also login to the App using their 3rd party account eg facebook.
- (2). Fill in the user's nickname, height, weight, age and other basic information.



4.INSTALL EQUIPMENT

Before installing the equipment the user needs to count all of the parts to make sure if they are working correctly.

- Mattress*1
 Controller*1
- Iler*1 •Battery charger*1
- Audio wireinside of the mattress*1

After checking the parts and following the steps to connect, at last switch on the power. Notice:

- •To avoid danger the voltage needs to be AC100-240V.
- •The mattress should be face up as the sensor is located on this side.
- •To avoid getting the sensor wet, it should not be placed by an opened window.

•All parts need to be connected tightly untill they can be not moved.



After connecting, the user can turn on the light to check if it is working.

I-Light operation method:

The controller has the function of i-Light, and you can control the i-Light opening and closing by touching the front of the controller.



5.CONNECT EQUIPMENT

App connects the device to the Wi-Fi network, and the device will monitor the data through the Wi-Fi network and upload it to the cloud server.

Before connecting the equipment prepare the following:

- (1). Connect all of the equipment tightly and switch on the power.
- (2). Make sure the phone uses wifi internet.

If searching device fails, follow the tips below to troubleshoot the problem.

- (1). The mobile phone needs to connect to the WiFi 2.4GHz band, do not use 5G mode.
- (2). Check if the WiFi password input is correct.

6.USER SETUP

After the device is added to the App, the user is added to the position of the avatar above "Please place the user" according to the sleeping position on the mattress.



7.DATA REPORTS

7-1. Sleep tips

On the "Sleep Tips " page, the App publishes sleep information articles about sleeping knowledge. You can share and collect your favorite articles. The collected articles will be saved in the favorites bar.



7-2.Sleep report

The sleep report is only stored for 7 days. Please update in time on the "Sleep Report" page daily.



The Springrain Doctor's sleep analysis system also provides analysis and advice based on your daily sleep data,which you can use to improve your sleep.

There is a both daily sleeping report and a monthly sleeping report, so that the user can monitor the sleep quality over a period of time. The sleep status distribution table consists of statistics on the sleep data of the four indicators of deep sleep, light sleep, REM, and awake. Each data graph has a different color.



Note:

"REM" refers to rapid eye movement sleep, which is a stage of the sleep cycle. Most dreams occur during the "REM" sleep phase.

7-3. 3rd Party monitoring



In this section of the App,the user can see other people's data in a day,to monitor the sleep quality of loved ones too. Steps to connect the device:

- (1). Open the App, click on the device information bar in the upper right corner → select "add device" → scan the QR code at the bottom of the device.
- (2). Enter the Wi-Fi connection page and enter the Wi-Fi password.
- (3). Click on the button to trigger the reset key on the controller. The red indicator of the conntroller will blink.
- (4). The device networking process lasts about 1 minute. After the network is connected, the indicator of the controller turns green.
- (5). The device will Appear in your device list and the device is added.
