

The EUT is put on a table of non-conducting material that is 80 cm high. The vertical conducting wall of shielding is located 40 cm to the rear of the EUT. The arrangement of the equipment is installed to meet the standards and operating in a manner, which tends to maximize its emission characteristics in a normal application.
