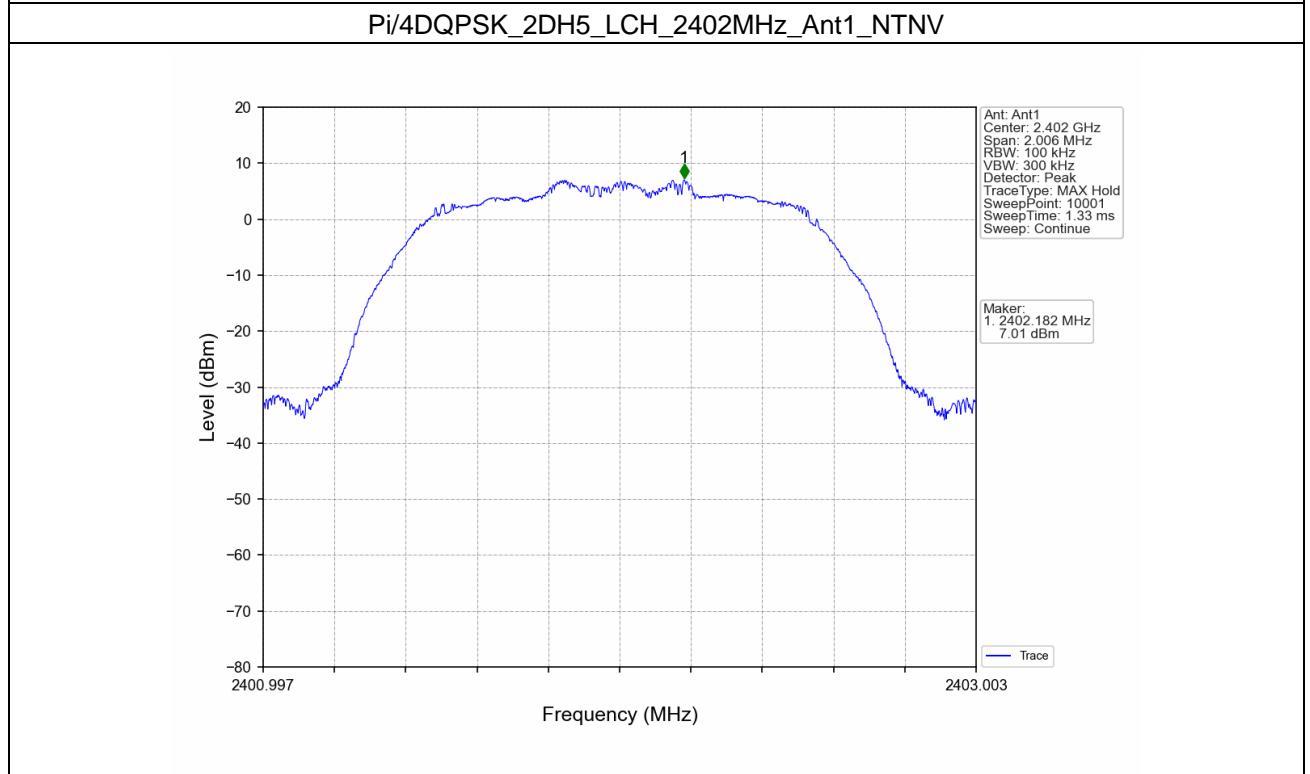
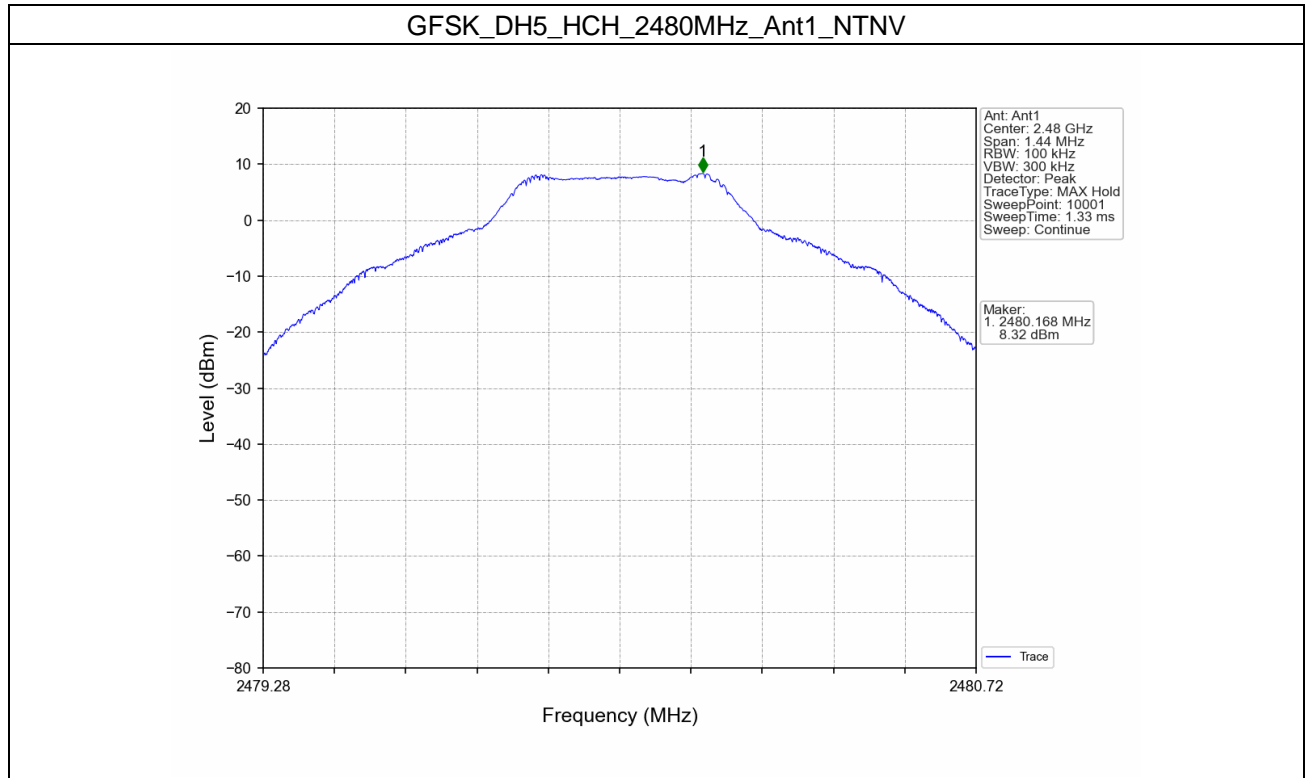
7.1.2 Test Graph

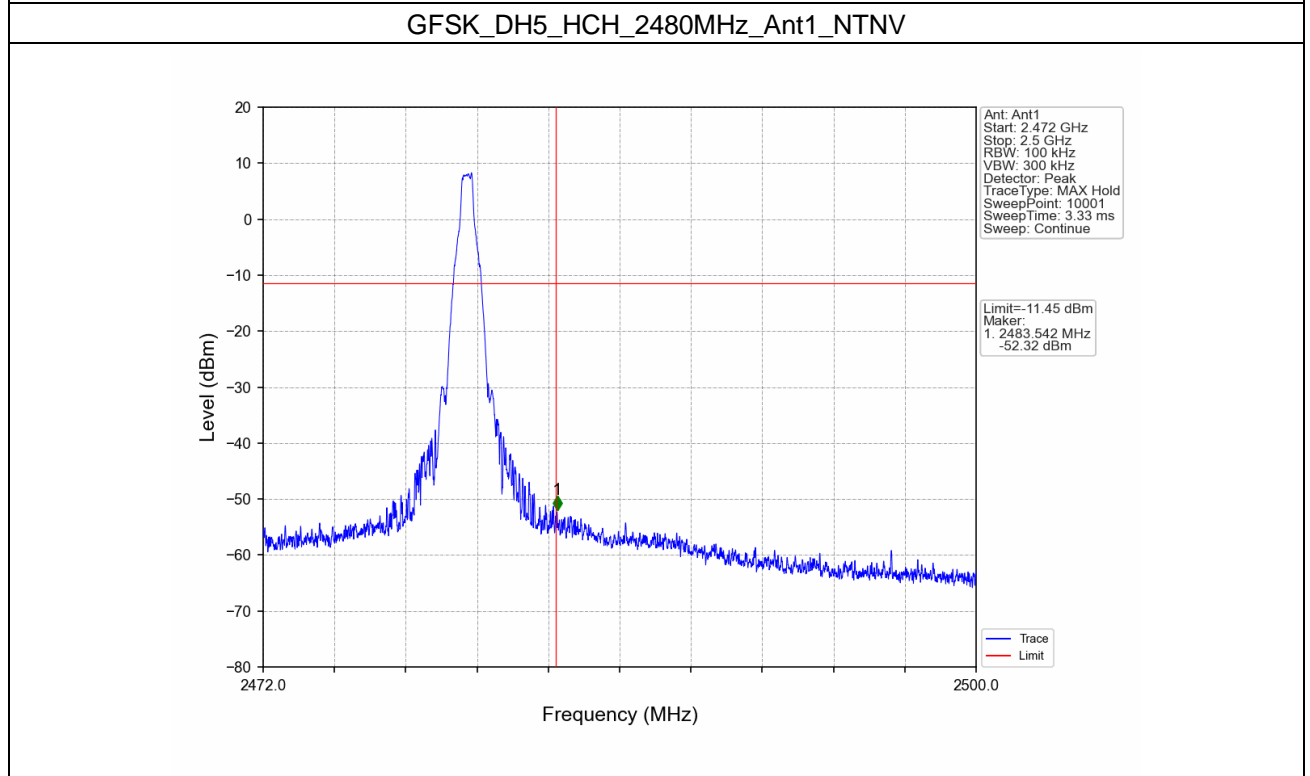
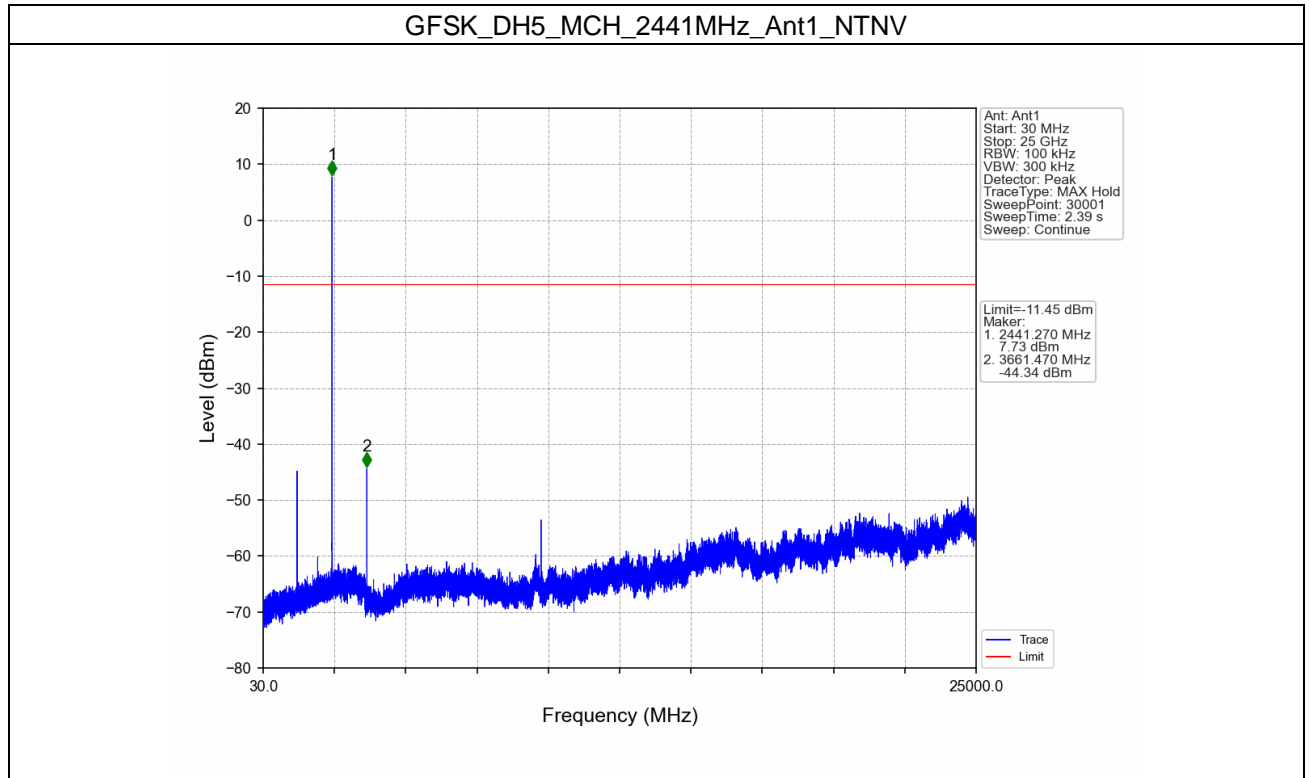
7.2.2 Test Graph
