5.2 MPE Calculation

The Max Conducted Average Output Power is 28.05mW;

The best case gain of the antenna is 2dBi. 2dB logarithmic terms convert to numeric result is nearly 1.58

For FCC:

According to the formula S= $\frac{PG}{4R^2\pi}$, we can calculate S which is MPE.

Note

dBm

- 1) P (Watts) = Power Input to antenna = 10^{10} / 1000
- 2) G (Antenna gain in numeric) = 10[^] (Antenna gain in dBi /10)
- 3) R = distance to the center of radiation of antenna (in meter) = 20cm
- 4) MPE limit = 1mW/cm²

$$S = \frac{PG}{4R^2\pi} = \frac{28.05 \times 1.58}{4 \times 400 \times 3.14} = 0.0088 \text{ mW/cm}^2$$

So the device is exclusion from SAR test.
