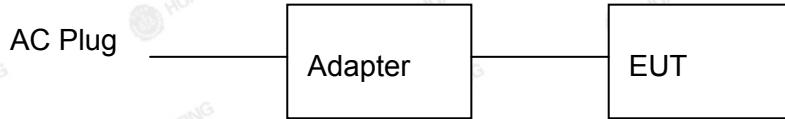

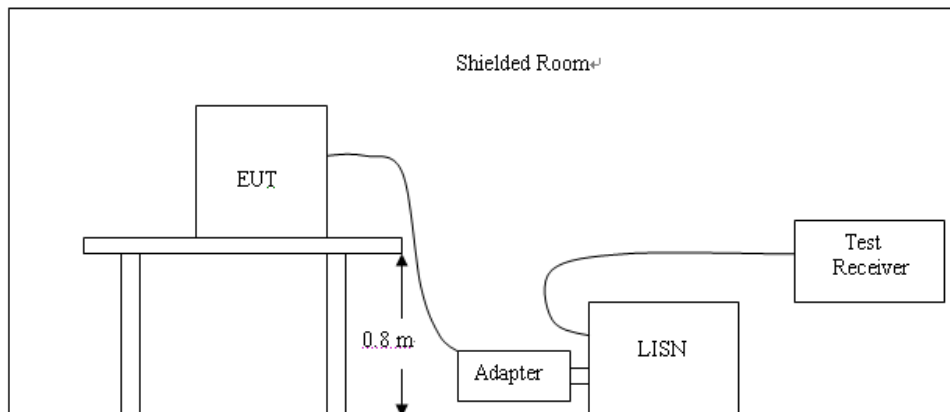

TEST PROCEDURE

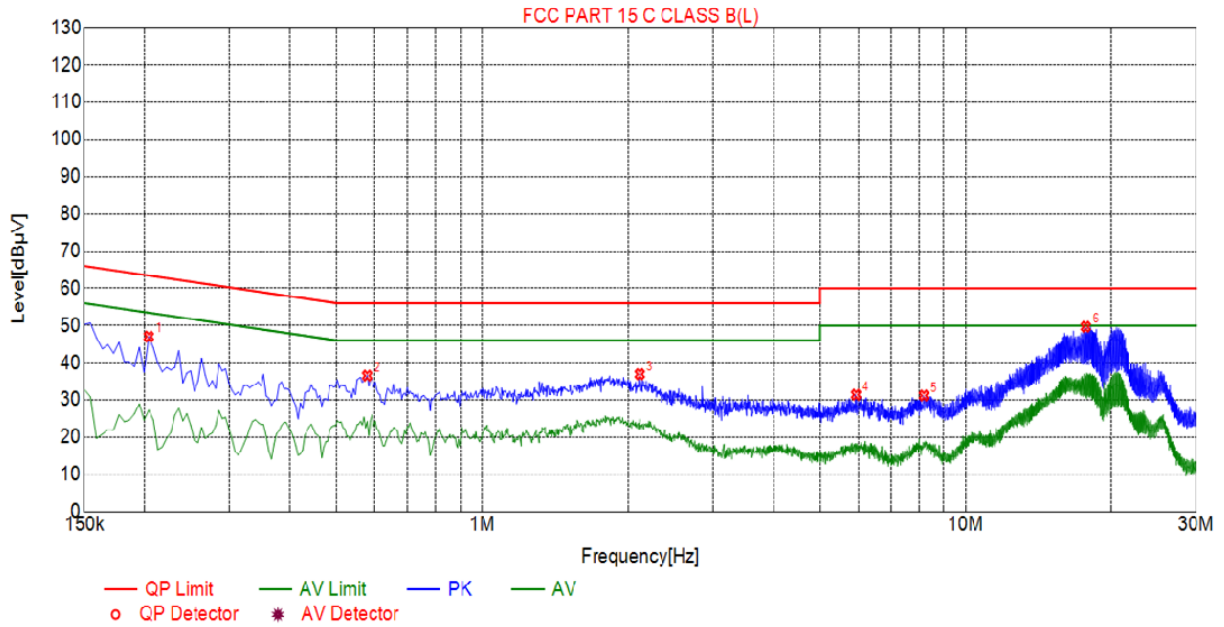
1. The equipment was set up as per the test configuration to simulate typical actual usage per the user's manual. The EUT is a tabletop system; a wooden table with a height of 0.8 meters is used and is placed on the ground plane as per ANSI C63.10:2013.
2. Support equipment, if needed, was placed as per ANSI C63.10:2013
3. All I/O cables were positioned to simulate typical actual usage as per ANSI C63.10:2013.
4. The adapter received AC120V/60Hz power through a Line Impedance Stabilization Network (LISN) which supplied power source and was grounded to the ground plane.
5. All support equipments received AC power from a second LISN, if any.
6. The EUT test program was started. Emissions were measured on each current carrying line of the EUT using a spectrum Analyzer / Receiver connected to the LISN powering the EUT. The LISN has two monitoring points: Line 1 (Hot Side) and Line 2 (Neutral Side). Two scans were taken: one with Line 1 connected to Analyzer / Receiver and Line 2 connected to a 50 ohm load; the second scan had Line 1 connected to a 50 ohm load and Line 2 connected to the Analyzer / Receiver.

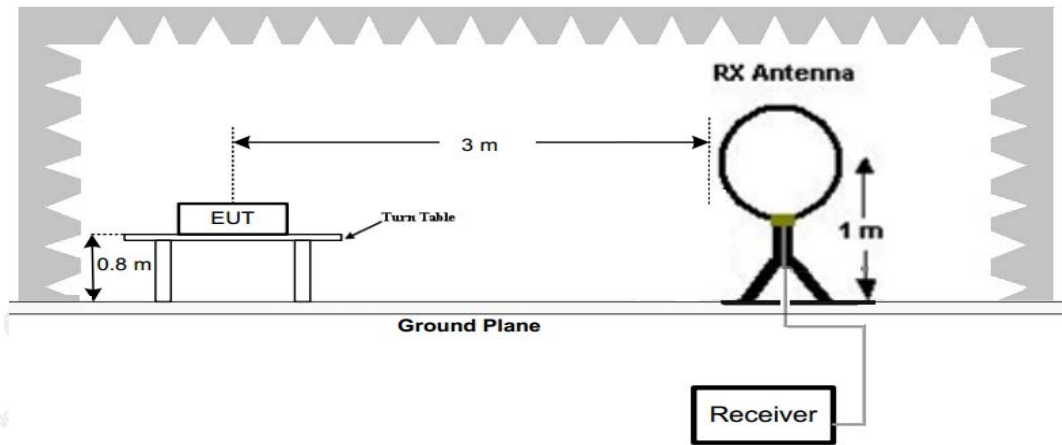

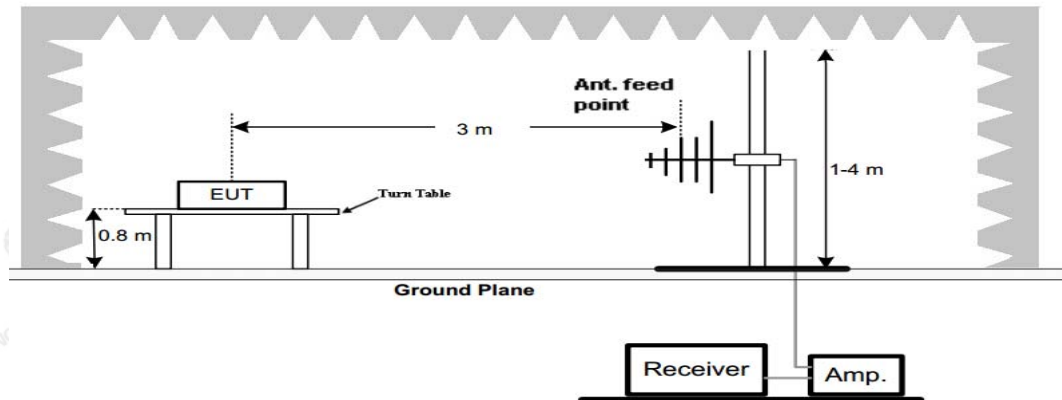

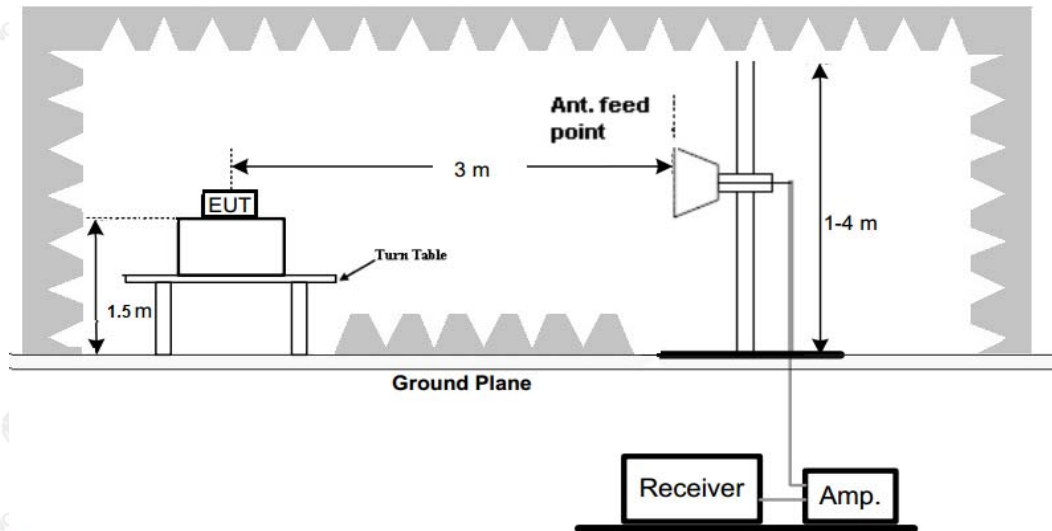
(A) Radiated Emission Test Set-Up, Frequency Below 30MHz

Test Procedure

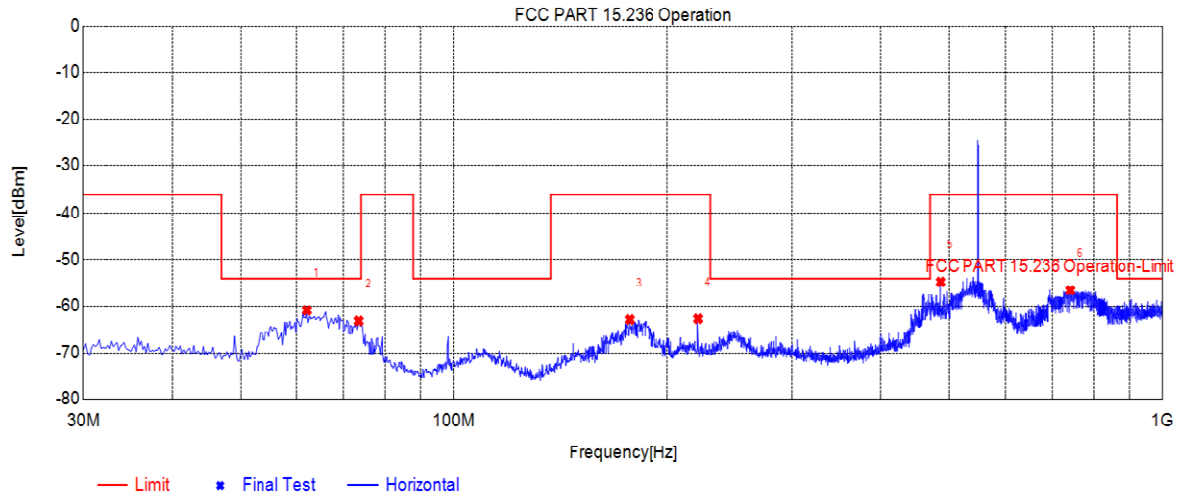
- 1.The setup of EUT is according with per TIA/EIA Standard 603 and ANSI C63.4-2014 measurement procedure.
- 2.The measurement antenna was placed at a distance of 3 meters from the EUT. During the tests, the antenna height and polarization as well as EUT azimuth were varied in order to identify the maximum level of emissions from the EUT. The test was performed by placing the EUT on 3-orthogonal axis.
- 3.The frequency range up to tenth harmonic of the fundamental frequency was investigated.
- 4.Remove the EUT and replace it with substitution antenna. A signal generator was connected to the substitution antenna by a non-radiating cable.

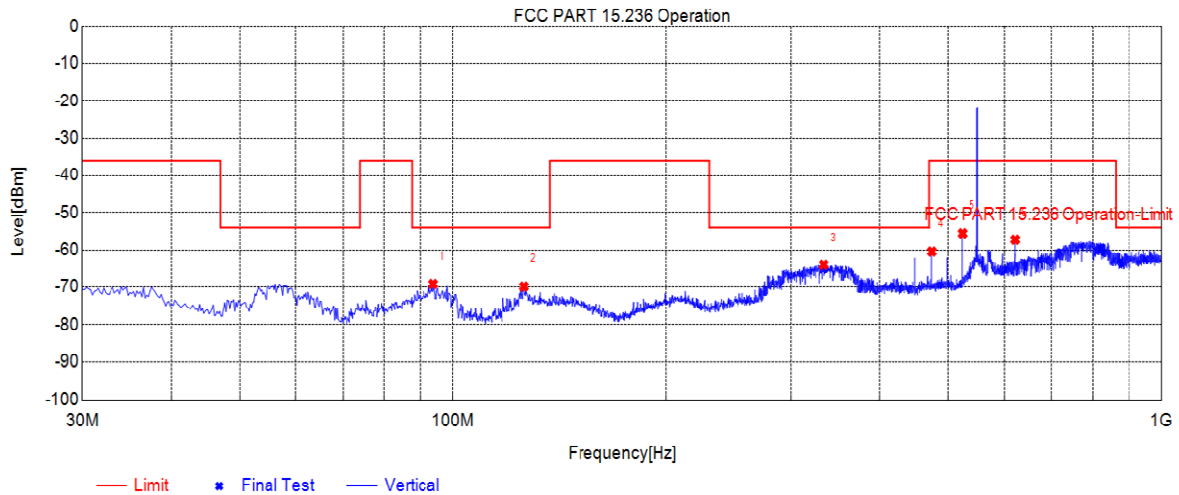

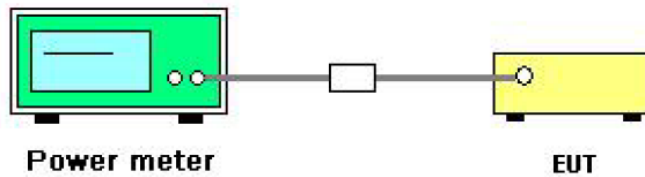

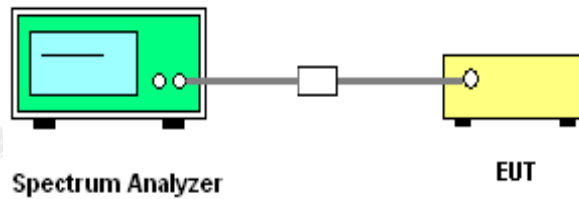

- (1) The frequency selection shall be offset from the upper or lower band limits by 25 kHz or an integral multiple thereof.
- (2) One or more adjacent 25 kHz segments within the assignable frequencies may be combined to form a channel whose maximum bandwidth shall not exceed 200 kHz. The operating bandwidth shall not exceed 200kHz.

Emissions within the band from one megahertz below to one megahertz above the carrier frequency shall comply with the emission mask in Section 8.3 of ETSI EN 300 422-1 V1.4.2 (2011-08) (incorporated by reference, see §15.38). According to TIA-603 for additional Test Set-Up procedures, the occupied bandwidth of emission was measured with a Spectrum Analyzer connected to the antenna terminal while EUT was operating in 2.5kHz tone at an input level 16 dB greater than that necessary to produce 50 percent modulation. Then mark the -26dB Bandwidth and record it.
