FIND THIS CAR!

YOUR KEY IS ONE OF THOUSANDS OF COPIES THAT UNLOCK THE SAME CAR. NO ONE KNOWS WHERE THE CAR IS LOCATED.

IF YOU FIND THE CAR, YOU CAN DRIVE IT! BUT SO CAN ANYONE ELSE WITH A KEY.

YEAH, THAT'S RIGHT. IT'S A PT CRUISER.

USING YOUR KEYFOB TO FIND THE CAR

PUSH THE BUTTON ON YOUR KEY FOB TO SEARCH FOR AND UNLOCK THE CAR. THE LIGHT ON THE KEY FOB WILL INDICATE HOW CLOSE YOU ARE TO IT.

BLUE LIGHT	RED LIGHT	GREEN LIGHT
YOU ARE VERY FAR AWAY FROM THE CAR	YOU ARE GETTING CLOSE TO THE CAR	YOU ARE IN RANGE TO UNLOCK THE CAR
IF YOU ARE VERY FAR AWAY FROM THE CAR, THE LIGHT WILL BLINK BLUE.	IF YOU ARE CLOSE TO THE CAR, THE LIGHT WILL STAY RED.	IF YOU ARE WITHIN UNLOCKING/LOCKING RANGE OF THE CAR, THE LIGHT WILL TURN GREEN. ONLY 1 KEY FOB CAN BE CONNECTED TO THE CAR AT A TIME.
YOU CAN PRESS THE BUTTON AGAIN TO PERFORM ANOTHER SEARCH FOR THE CAR.	PRESSING THE BUTTON WHILE THE LIGHT IS RED WILL CAUSE THE CAR TO BEEP ONCE AND FLASH ITS HEADLIGHTS.	ADDITIONAL BUTTON PRESSES WHILE THE LIGHT IS GREEN WILL LOCK OR UNLOCK THE CAR. AT THIS TIME, HEADLIGHTS ON THE CAR WILL FLASH.
THE KEY FOB MAY FLASH WHITE WHEN PROCESSING A COMMAND.	IN THIS STATE, YOU CAN PROBABLY SEE THE CAR!	UNLOCKING THE CAR
THE KEY FOB WILL TURN OFF AFTER BLINKING BLUE FOR 60 SECONDS OR WHEN IT DISCONNECTS FROM THE CAR.	BATTERIES ARE INCLUDED, BUT WILL NEED TO BE REPLACED OVER TIME. IF THE KEY FOB STOPS RESPONDING, TRY REPLACING THE BATTERIES.	BUTTON PRESS X1, LIGHT WILL FLASH
ONCE THE KEY FOB CONNECTS TO THE CAR (WHEN THE LIGHT TURNS RED OR GREEN), THE CAR WILL BEEP 3 TIMES IN A ROW.	LOCKING THE CAR	BUTTON PRESS X2, LIGHT WILL FLASH
		THE CAR WILL ALSO LOCK AUTOMATICALLY WHENEVER THE KEYFOB DISCONNECTS.
