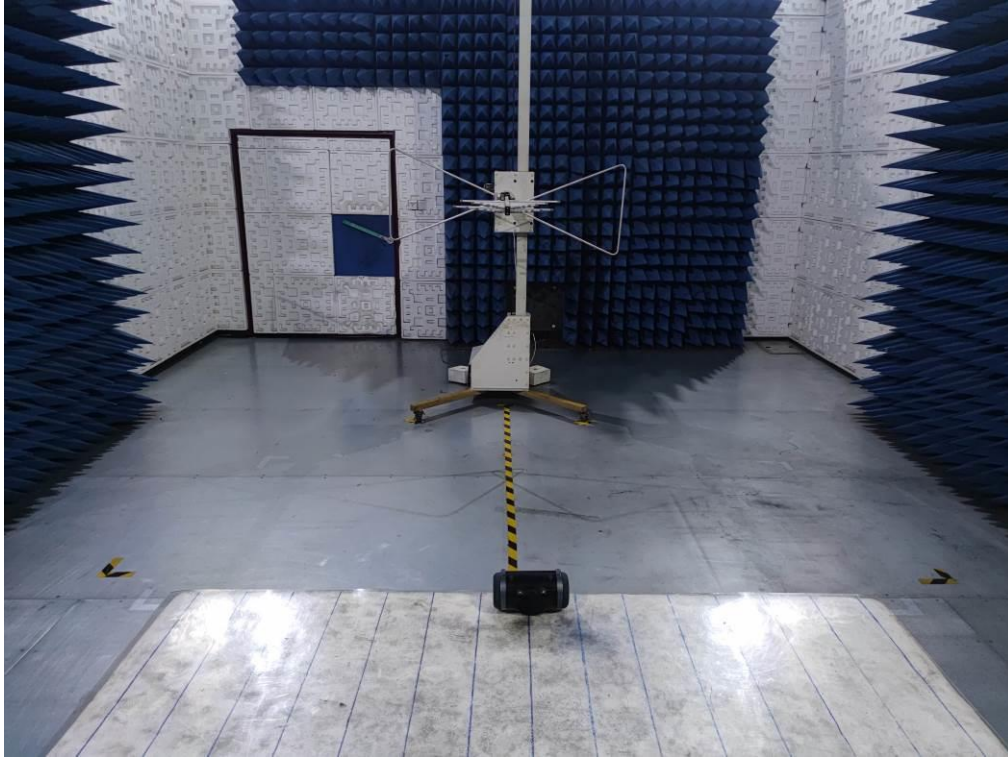

RADIATED EMISSION TEST SETUP ABOVE 1GHz



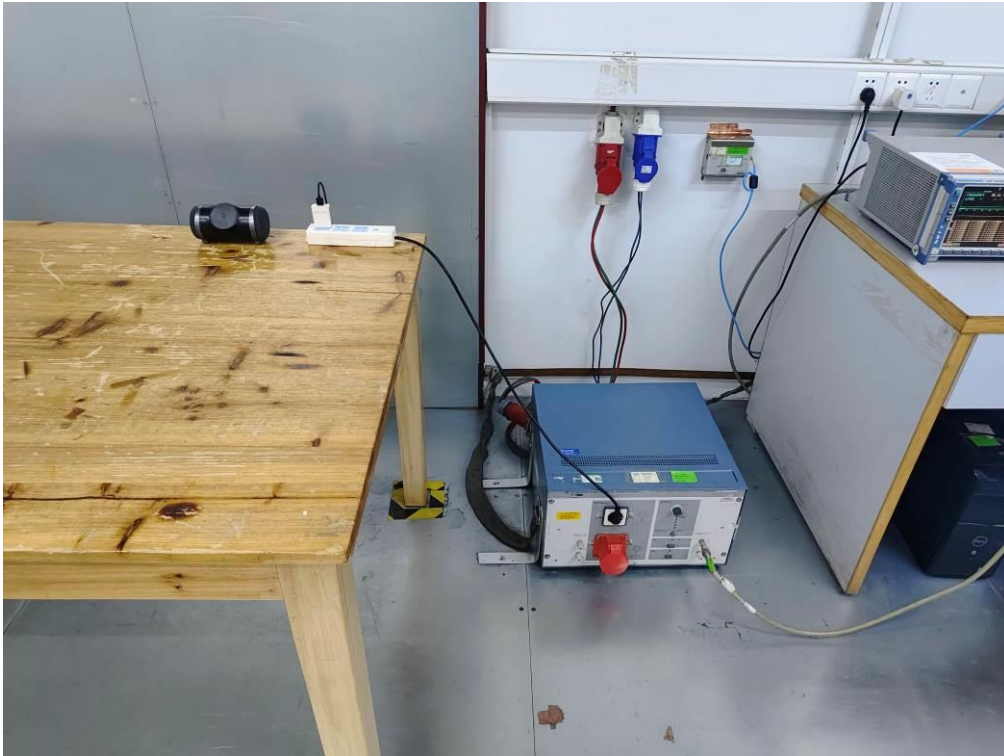

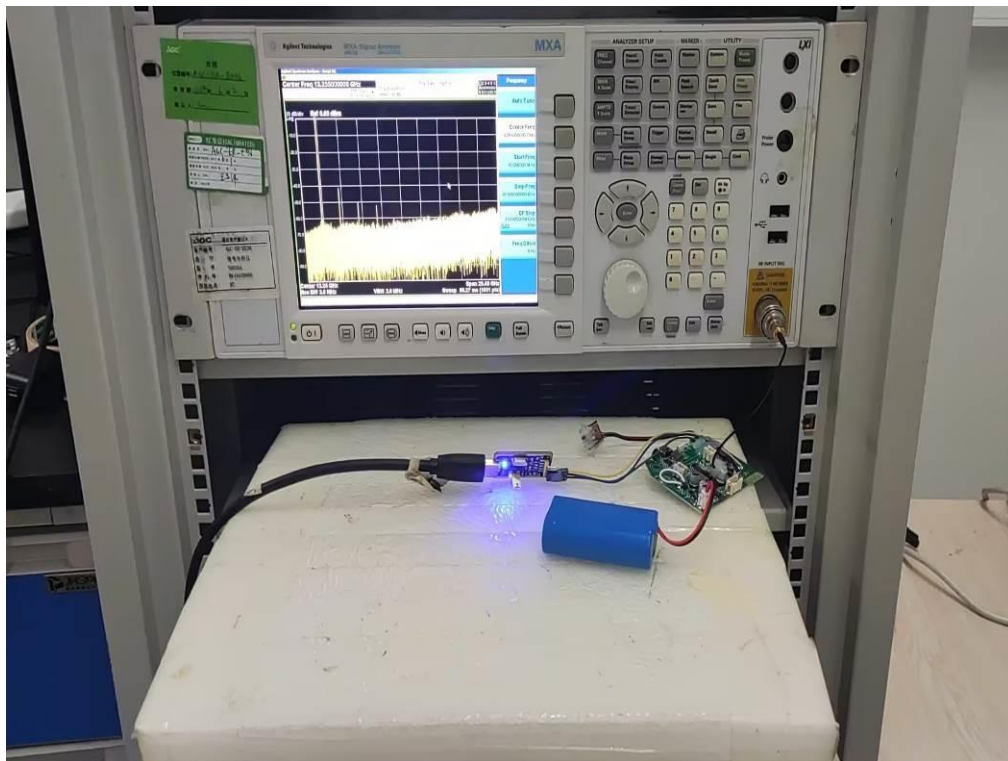

AC POWER LINE CONDUCTED TEST SETUP



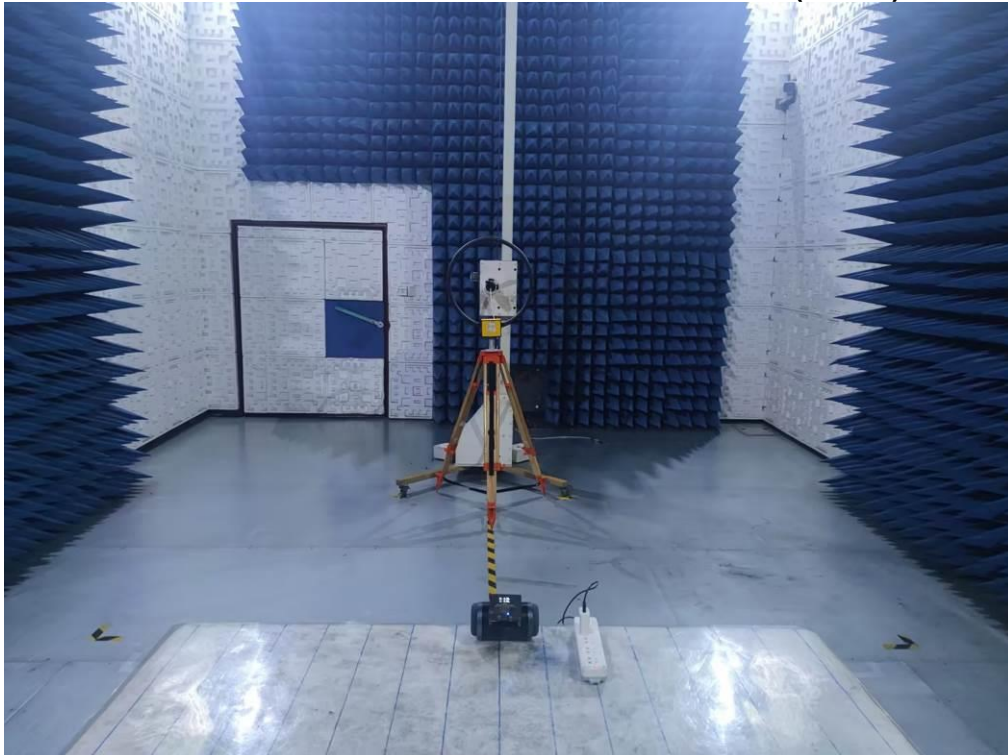

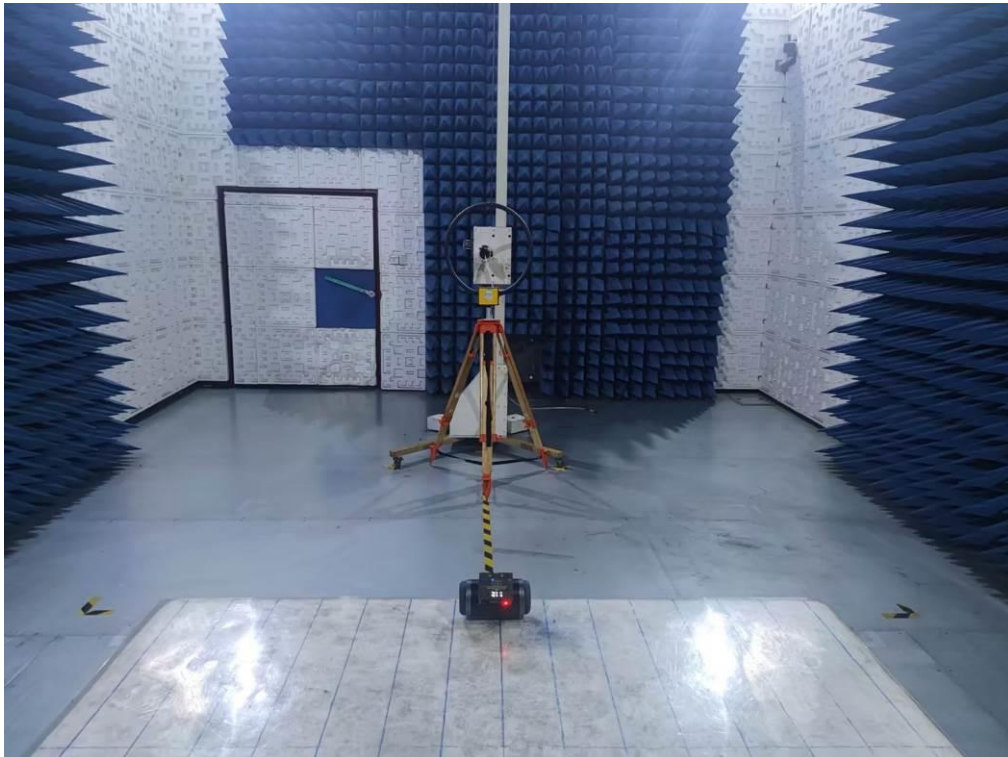

RADIATED EMISSION TEST SETUP BELOW 30MHz (Portable)

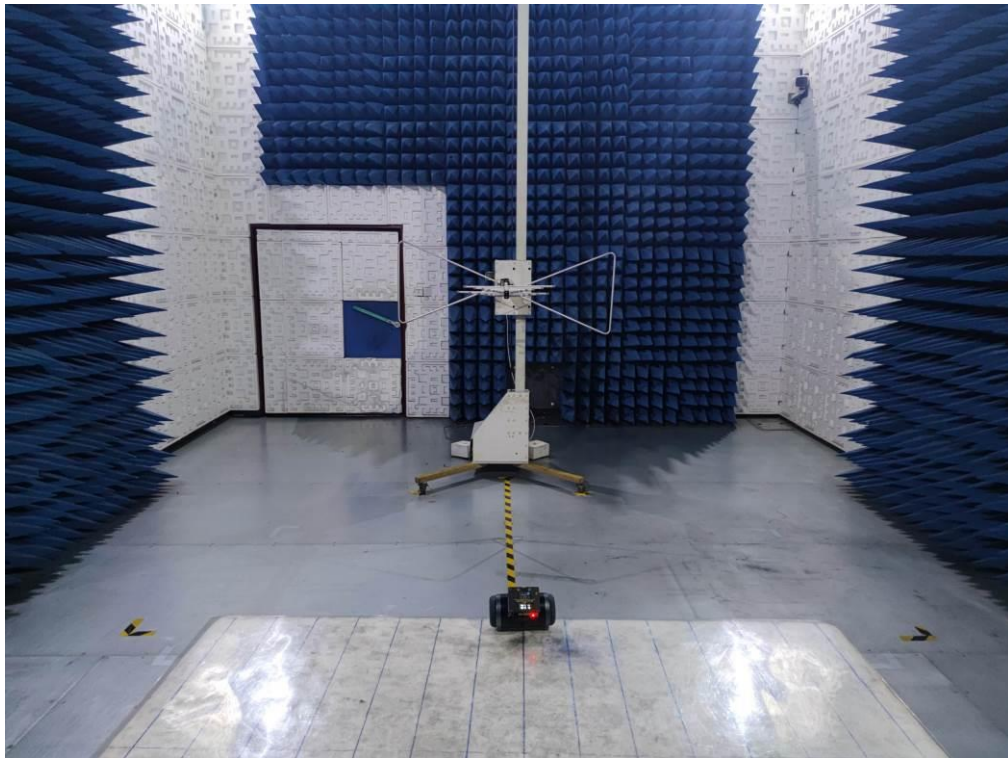

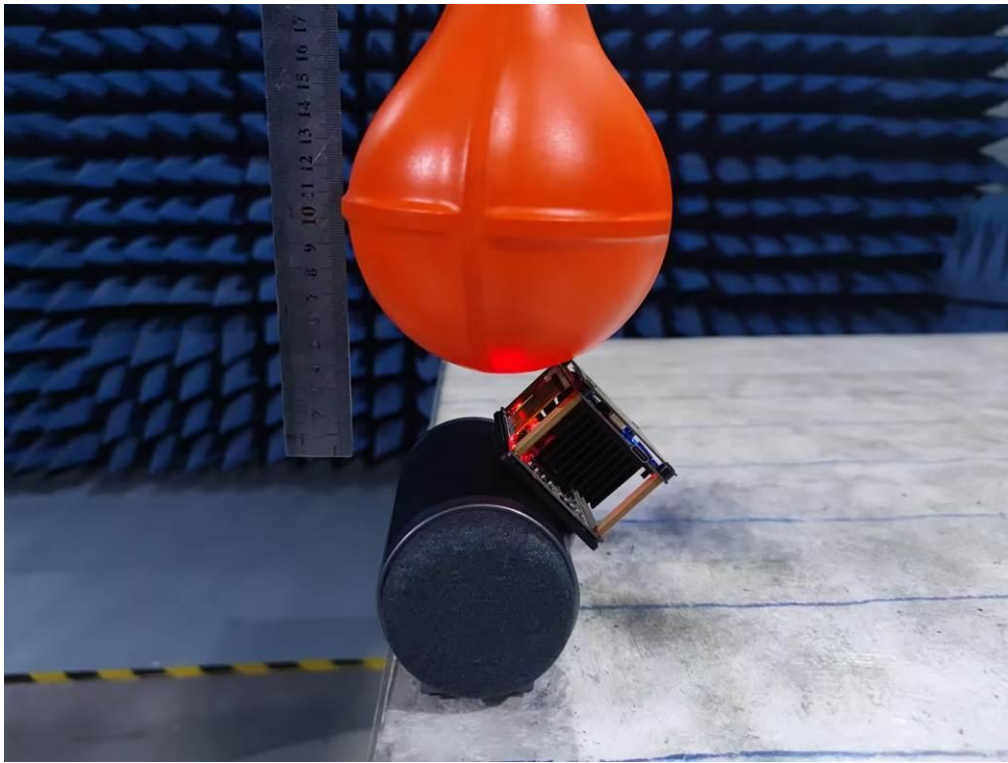

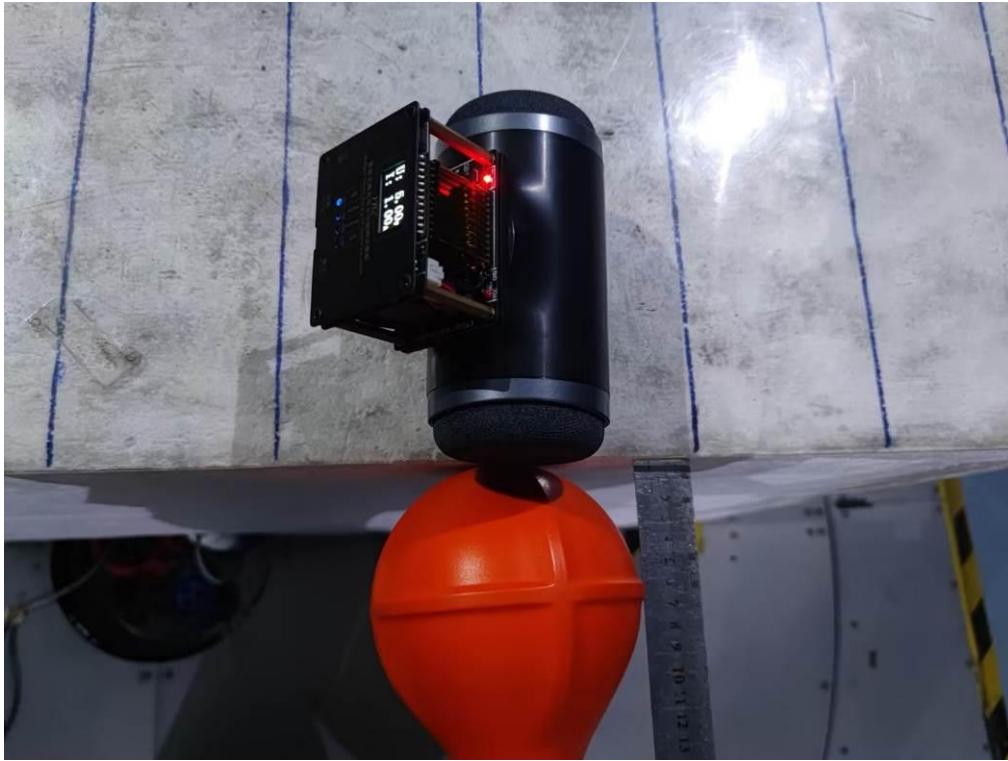


H-Field & E-Field Strength_ Position B

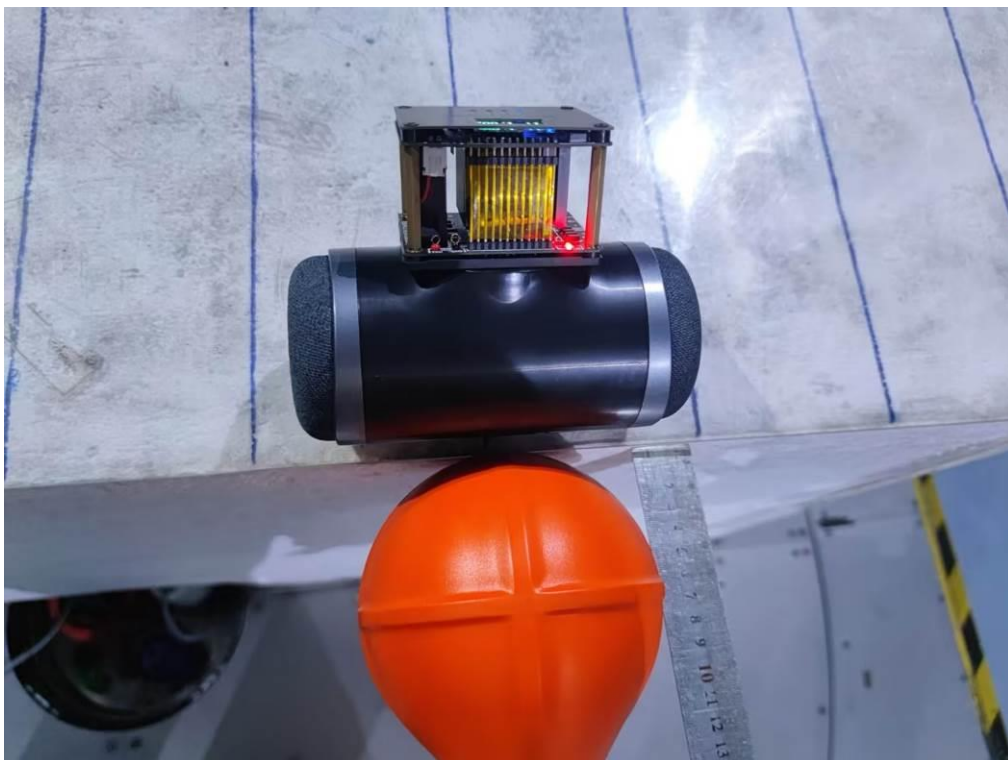

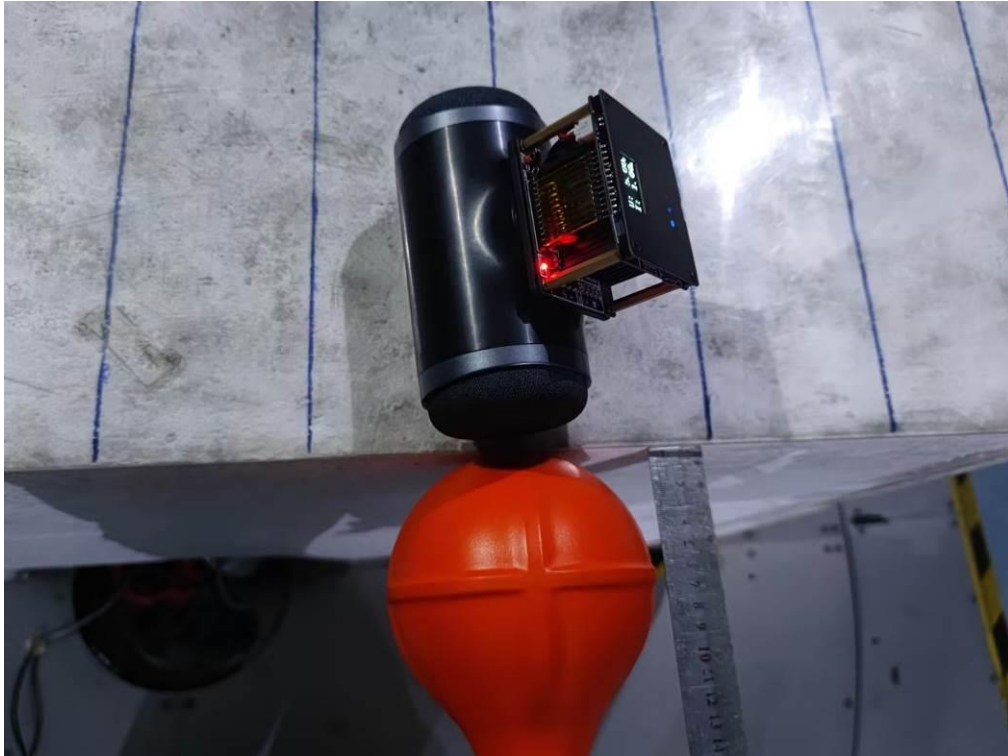

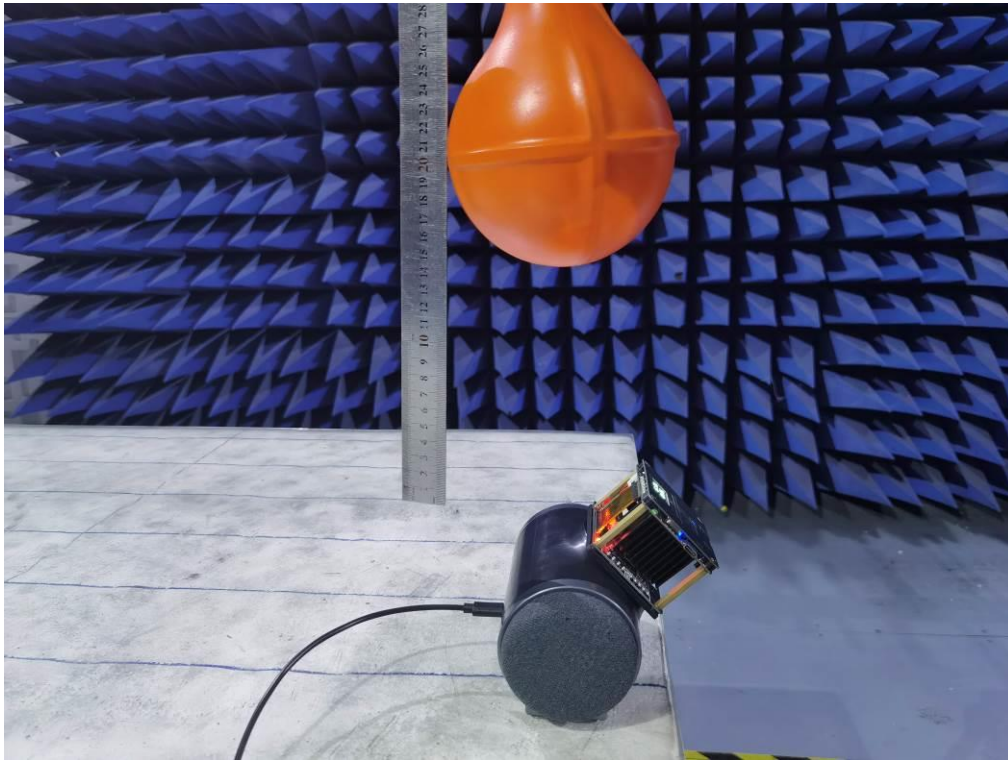

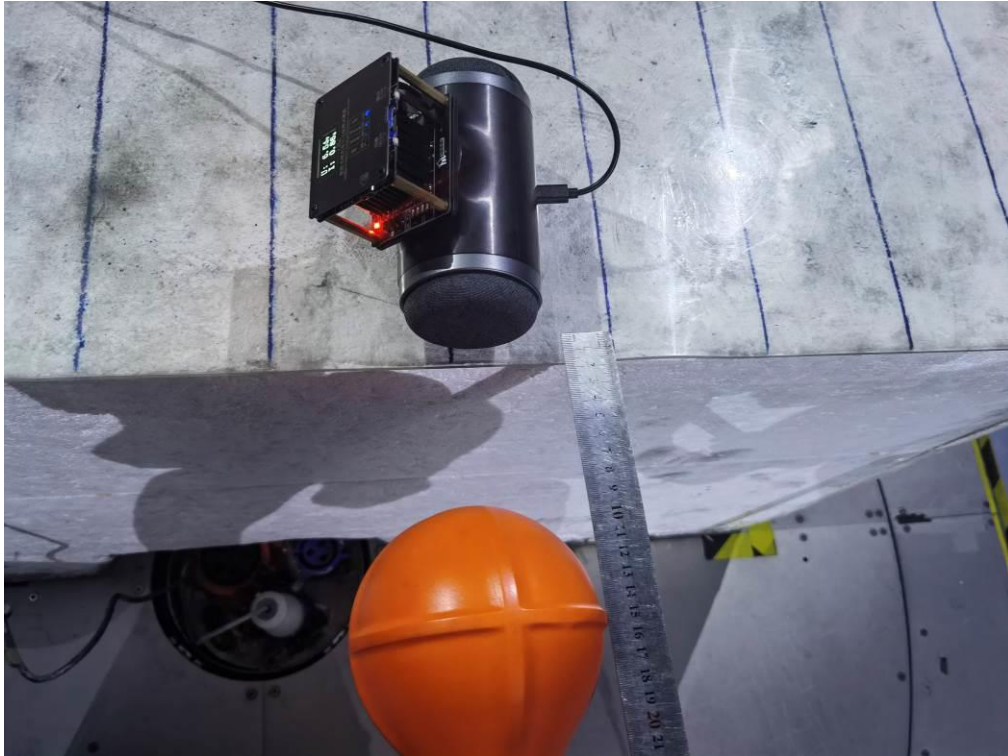
