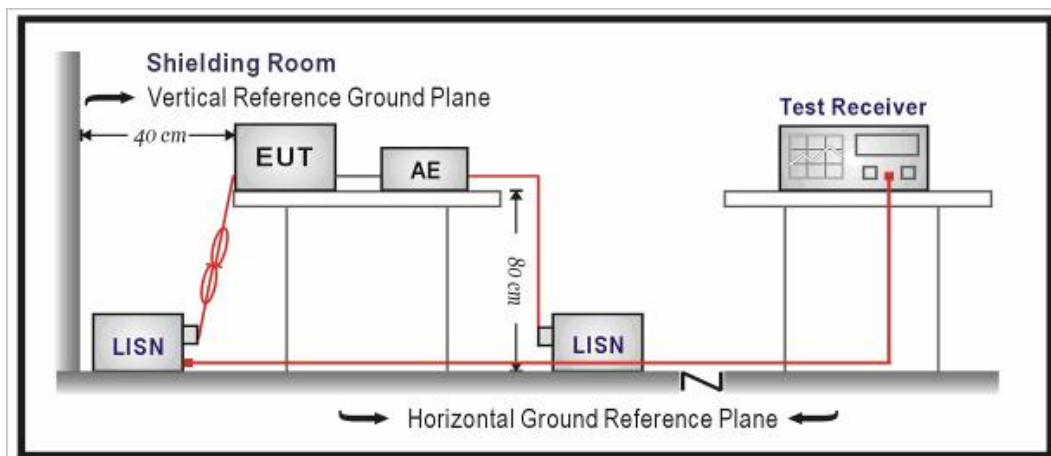

##### 3.1.2 TEST PROCEDURES

- a. The EUT was placed 0.4 meters from the conducting wall of the shielded room with EUT being connected to the power mains through a line impedance stabilization network (LISN). Other support units were connected to the power mains through another LISN. The two LISNs provide 50 ohm/ 50uH of coupling impedance for the measuring instrument.
- b. Both lines of the power mains connected to the EUT were checked for maximum conducted interference.
- c. The frequency range from 150kHz to 30MHz was searched. Emission levels under (Limit - 20dB) were not recorded.

**NOTE:** All modes of operation were investigated and the worst-case emissions are reported.

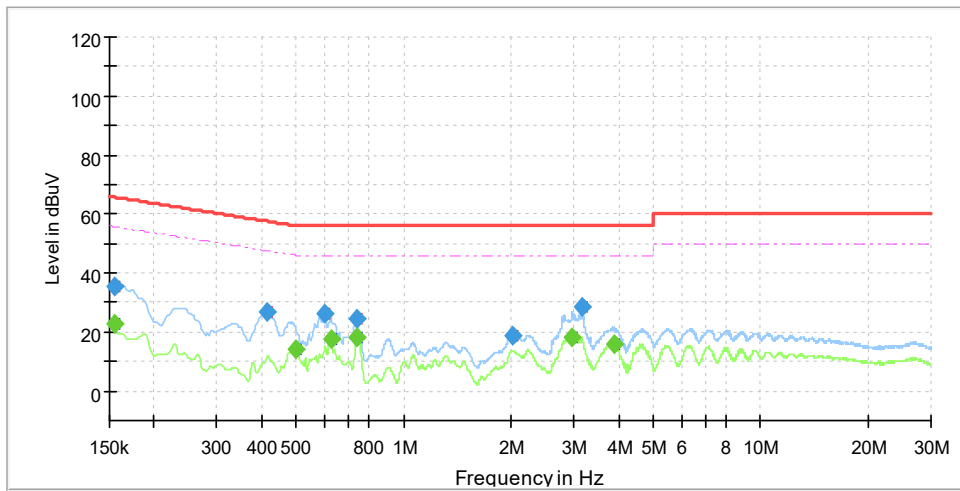

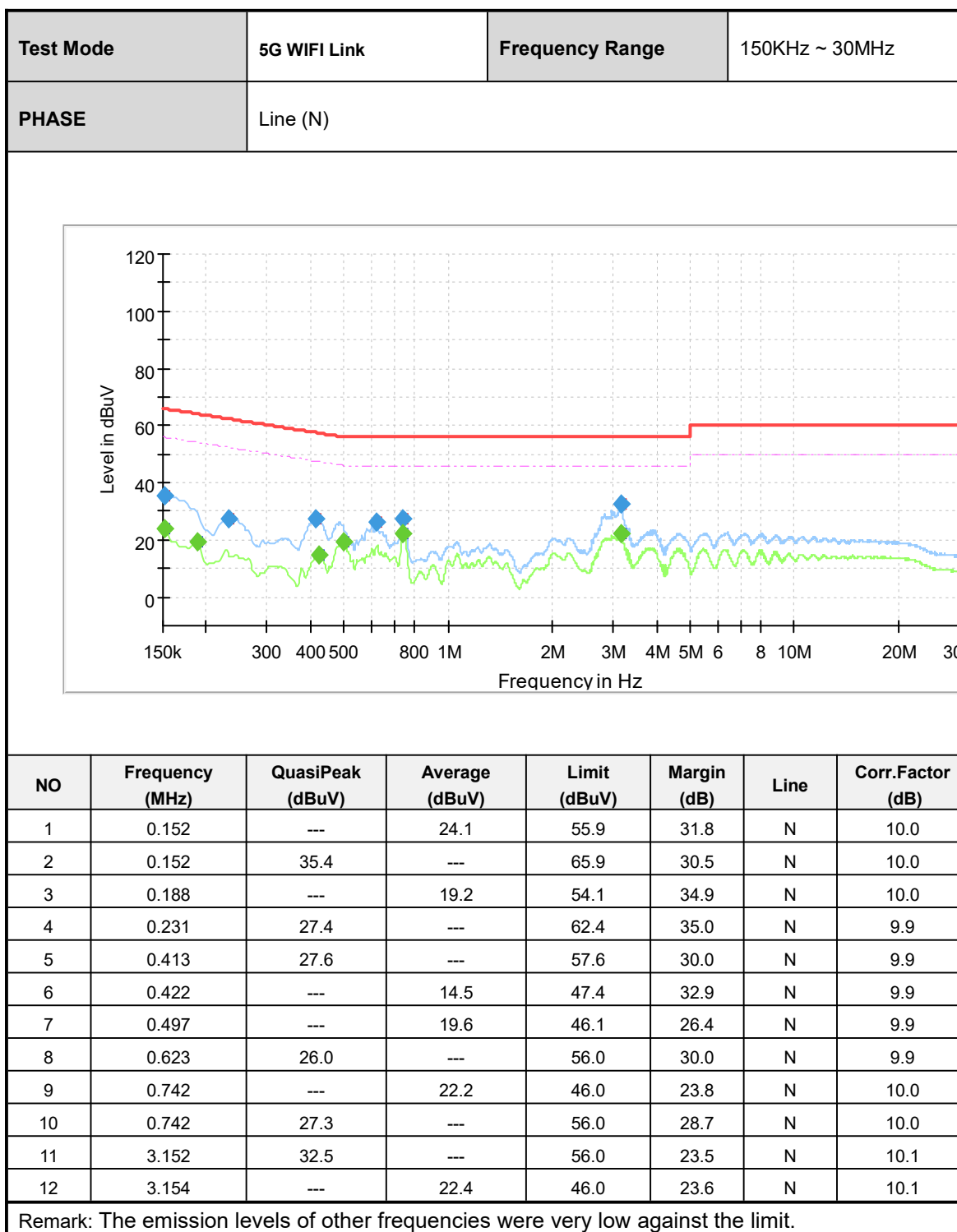

### 3.1.3 TEST PROCEDURES

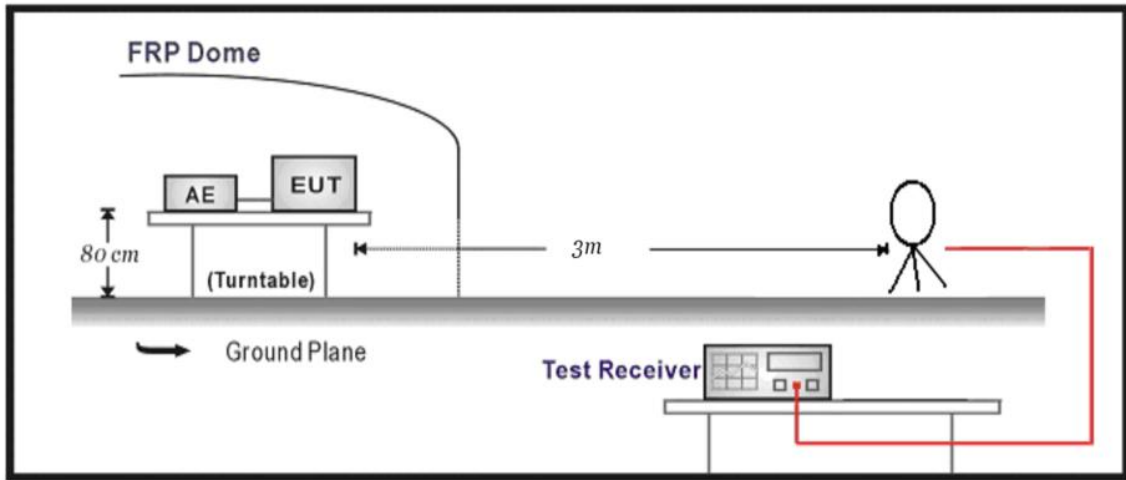
- a. The EUT was placed on the top of a rotating table 1.5 meters(above 1GHz)and 0.8 meters(below 1GHz) above the ground at a 3 meters semi-anechoic chamber. The table was rotated 360 degrees to determine the position of the highest radiation.
- b. The EUT was set 3 meters away from the interference-receiving antenna, which was mounted on the top of a variable-height antenna tower.
- c. The antenna is a broadband antenna, and its height is varied from one meter to four meters above the ground to determine the maximum value of the field strength. Both horizontal and vertical polarizations of the antenna are set to make the measurement.
- d. For each suspected emission, the EUT was arranged to its worst case and then the antenna was tuned to heights from 1 meter to 4 meters and the rotatable table was turned from 0 degrees to 360 degrees to find the maximum reading.
- e. The test-receiver system was set to Peak Detect Function and Specified Bandwidth with Maximum Hold Mode.
- f. If the emission level of the EUT in peak mode was 10dB lower than the limit specified, then testing could be stopped and the peak values of the EUT would be reported. Otherwise the emissions that did not have 10dB margin would be re-tested one by one using peak, quasi-peak or average method as specified and then reported in a data sheet.

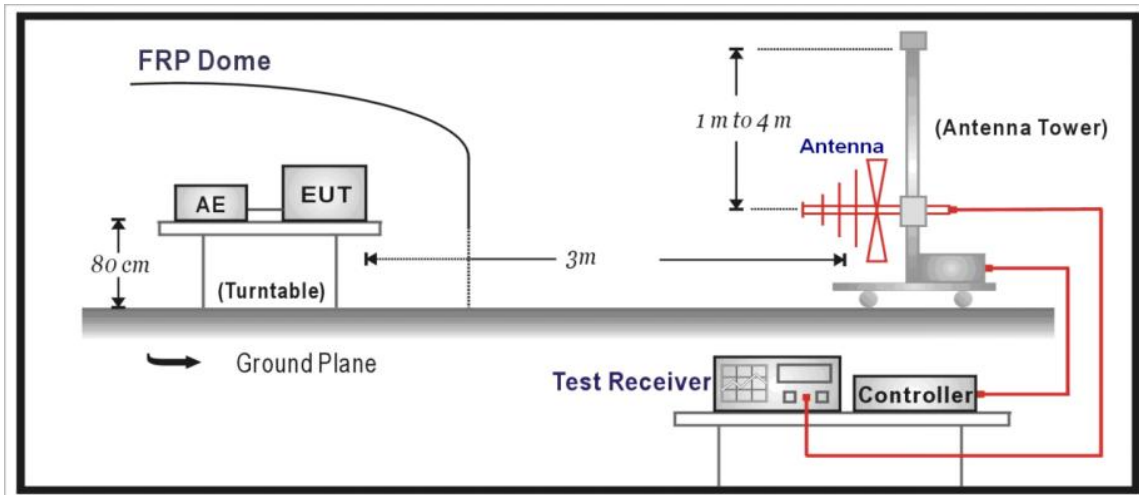

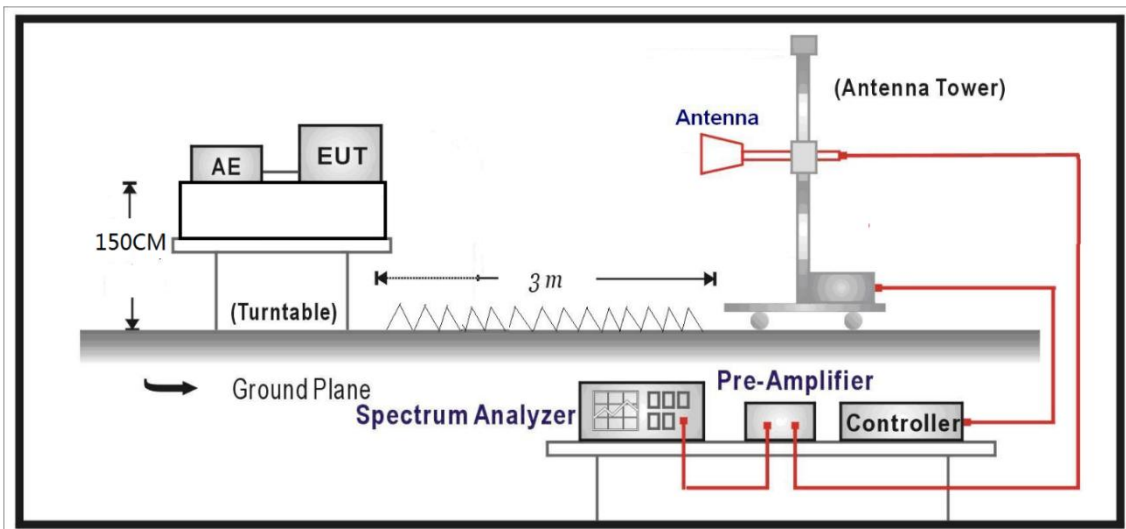
Below 30MHz Test Setup:



Below 1GHz Test Setup:

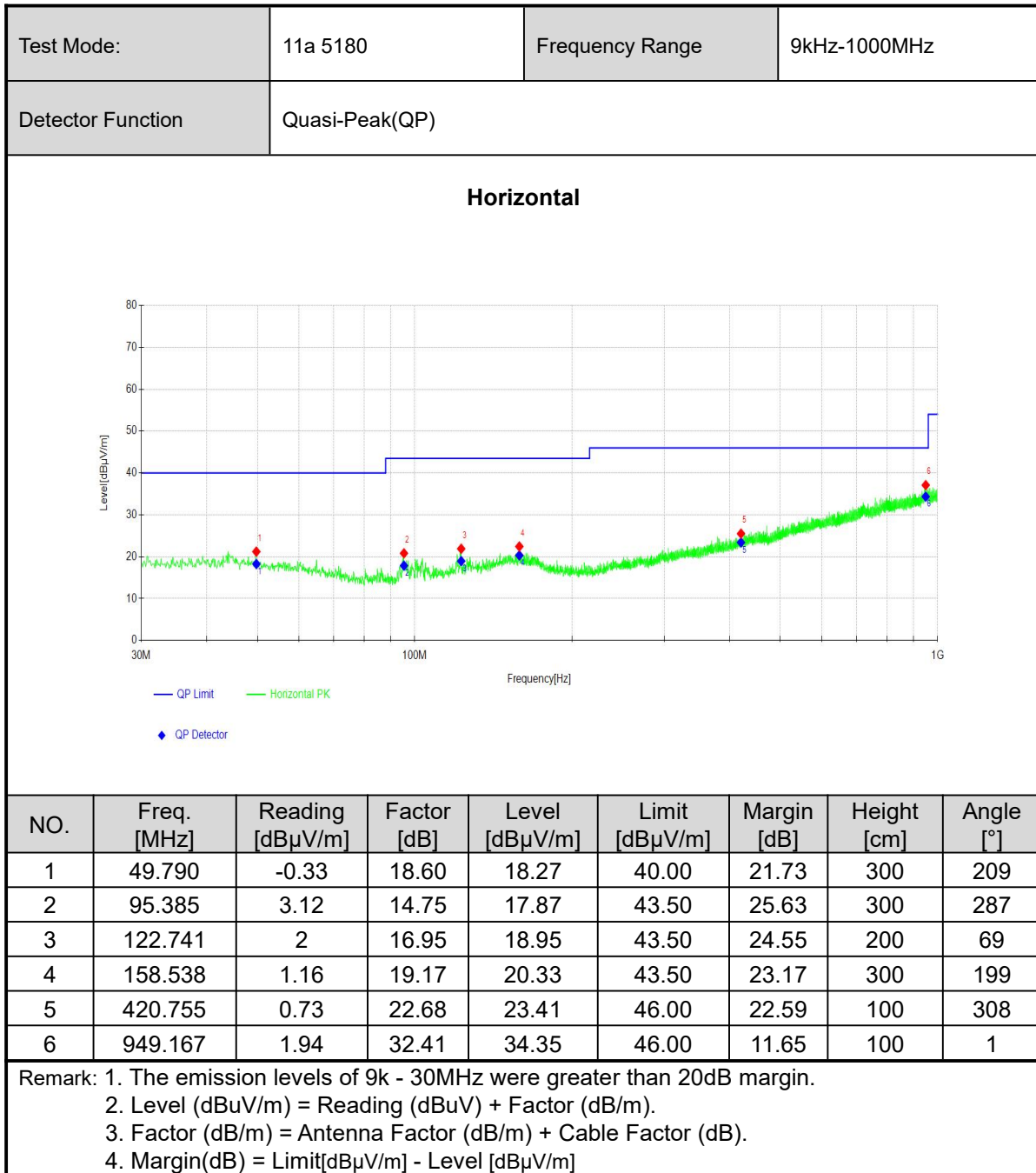

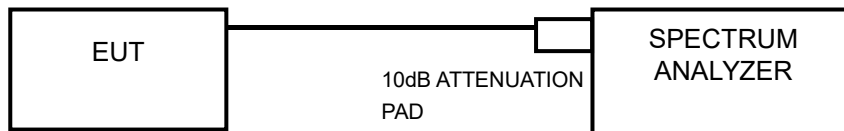

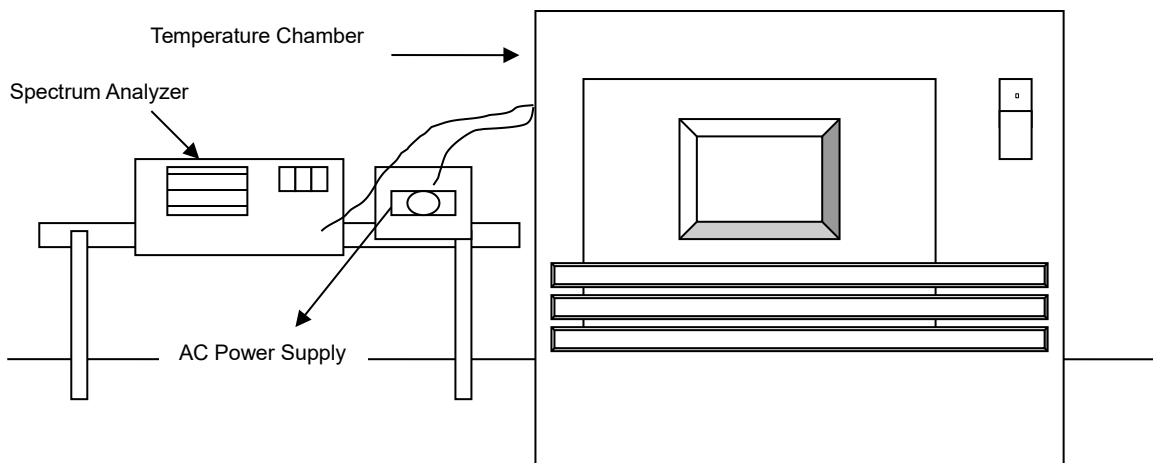
#### 3.8.1 LIMITS OFFREQUENCY STABILITY

#### 3.8.2 TEST PROCEDURES

- a. The EUT was placed inside the environmental test chamber and powered by nominal AC voltage.
- b. Turn the EUT on and couple its output to a spectrum analyzer.
- c. Turn the EUT off and set the chamber to the highest temperature specified.
