## 4 Technical Requirements Specification

### 4.1 Limits

According to KDB 447498 D04 Interim General RF Exposure Guidance v01 RF Exposure Procedures and Equipment Authorization Policies for Mobile and Portable Devices.

#### RF Exposure Test Exemptions for Single Source

##### 1-mW Test Exemption

Per § 1.1307(b)(3)(i)(A), a single RF source is *exempt RF device* (from the requirement to show data demonstrating compliance to RF exposure limits, as previously mentioned) if the available maximum time-averaged power is no more than 1 mW, regardless of separation distance.

This exemption applies to all operating configurations and exposure conditions, for the frequency range 100 kHz to 100 GHz, regardless of fixed, mobile, or portable device exposure conditions. This is a standalone exemption, and it cannot be applied in conjunction with any other test exemption.

### 4.2 Result

According to the calculation formula of power:

$$EIRP = P * G = (E * d)^2 / 30, \text{ So } P = (E * d)^2 / (30 * G).$$

Where:

P = transmitter output power in watts,

G = numeric gain of the antenna in the direction of interest relative to an isotropic radiator (unitless),

E = electric field strength in V/m, ---  $10^{((dBuV/m)/20)}/10^6$ ,

d = measurement distance in meters (m)---3m,

Thus, Worse case below:

### 4.3 Conclusion

Cuz  $0.114\text{mW} < 1\text{mW}$ , The device is exempt from the SAR test and satisfies RF exposure evaluation.
