5 Technical Requirements Specification in FCC CFR Title 47 Part 2.1093

5.1 Limits

According to 447498 D01 General RF Exposure Guidance v06 Mobile and Portable Devices RF Exposure Procedures and Equipment Authorization Policies.

The 1-g and 10-g SAR test exclusion thresholds for 100 MHz to 6 GHz at test separation distances \leq 50 mm are determined by:

[(max. power of channel, including tune-up tolerance, mW)/ (min. test separation distance, mm)] $\cdot [\sqrt{f(GHz)}] \le 3.0$ for 1-g SAR and ≤ 7.5 for 10-g extremity SAR, where

- f(GHz) is the RF channel transmit frequency in GHz
- Power and distance are rounded to the nearest mW and mm before calculation
- The result is rounded to one decimal place for comparison

5.2 Result

According to the calculation formula of power :

 $EIRP = P^*G = (E^*d)^2/30$

Where:

P = transmitter output power in watts,

G = numeric gain of the antenna in the direction of interest relative to an isotropic radiator (unitless),

E = electric field strength in V/m, --- 10((dBuV/m)/20)/106,

d = measurement distance in meters (m)---3m,

So,

 $P = (E^*d)^2/30 *G$

Thus, Worse case for FSK as below:

Frequency (MHz)	Max Output power (mW)	Min test distance (mm)	Result	Limit of 10-g SAR test exclusion thresholds
315	0.004	5	0.0005	7.5

5.3 Conclusion

Cuz 0.0005 < 7.5 for 10-g SAR, the device is exempt from the SAR test and satisfies RF exposure evaluation.
