Getting Started

Installing the AA Batteries

our radio uses 3 AA Alkaline batteries

1. With the back of the radio facing you, lift the battery latch

2. Insert 3 AA Alkaline batteries as shown on the inside of

3. Reposition the battery cover and press down to secure. The Sondpex Walkie-Talkie can use a NiMH rechargeable battery instead of 3 AA Alkaline batteries.

Battery Meter

The battery icon shows the battery charge level, 🍎 from full to empty - When the battery is empty, the radio chirps periodically after releasing . The radio powers off when the voltage drops below a predetermined level to protect the rechargeable battery.

Note: Remove the batteries before storing your radio for extended periods

Turning Your Tadio On and Off

After you insert batterise turn the radio on, the radio chirns and the display scrolls through the available channels and Interference Eliminator Codes Press and hold D button turn the radio off.

Setting the Volume

Use Oto:

Talking and Listening

To communicate, all radios in your group must be set to the same channel and Interference Eliminator Code

To talk press and hold PTT Hold the radio 2 to 3 inches away from your mouth when speaking.

When you finish speaking, release PTT (press to talk, release to listen)... Checking the Channel Before Transmitting

Your radio has multiple channels shared on a "take turn" basis. For uninterrupted communication, do not talk on a channel if someone else is currently talking on it.

To check for activity on a channel before you talk, press and hold, \$7/MON. If you hear static, the channel is clear to use.

Special Features

Interference Eliminator Code

Interference Eliminator Codes help minimize interference by providing you with a choice of code combinations. To set the code for a channel:

1. Press (a) until the code starts to flash.

3 Press PTT to save the code setting.

You can set a different code for each channel using this procedure. Note: You must set the Interference Eliminator Code to O on an FRS radio that uses Interence Eliminator Codes to communicate with other FRS radios that do not have Interference Eliminator Codes.

Push to Talk Timeout Timer

To prevent accidental transmissions and save battery life, the radio emits a continuous warning tone and stops transmitting if you press PTT for 180 continuous seconds

Locking the Keypad

To prevent accidentally changing your radio settings, press and hold for 3 seconds or until 🏚 displays. You can turn the radio on and off, adjust the volume, receive, transmit, send a call tone, and monitor channels. All other functions are locked. To unlock the radio, press and hold 🕝 for 3 seconds or until • is no

longer displayed

Special Features

Use scanning to monitor channels for transmissions or to find someone in your group who has accidentally changed channels.

To start scanning, briefly press and release Z. The scan indicator Z. displays. When the radio detects channel activity it stops scanning and you can hear the transmission. To respond to the transmission, press PTT within

Scan Advance

press and release or to resume scanning for the next active channel

Removing Channels from the Scan List(Nuisance Delete Feature)

To remove a channel so the radio does not stop on it while scanning, press and hold UP or DOWN for at least 3 seconds, then release. This temporarily removes the channel from the scan list.

To restore the channel, turn the radio off and then back on.

Note: You cannot remove the channel your radio was set to when you rted the scan(called your home channel)

Setting and Transmitting Call Tones

Your radio can transmit different call tones to other radios in your groupso you can alert them that you want to talk. 1. With the radio on, press 🕤 3 times. The current call tone setting flashes [A displays.

2. Press UP or DOWN to change and hear the call tone.

3.Press or 🕤 to set the new call tone.

To transmit your call tone to other radios set to the same channel and Interference Leliminator Code as your radio, press @

. Setting the call tone to 0 disables the call tone feature.

Voice Activation(VOX)

Voice activation (VOX) allows you to talk hands-free

1.Press PTT and D Turn the radio on.

2. Turn the radio on. ■ displays.

3.To transmit, speak into microphone. There is a short delay

between the time you start talking and when the radio transmits. 4 To receive ston talking

To turn VOX off, press PT1

Setting the Sensitivity Level

Adjusting your radio's sensitivity level helps minimize the possibility of unintended noises triggering a transmission and helps the radio nick up soft

1. Press 😭 until •€ displays. 2. Press UP or DOWN to select the sensitivity level:

3=High Sensitivity

2=Medium Sensitivity

1=Low Sensitivity

Setting the double channel monitor

1. Press 🕤 until CH displays,The current channel flashes. 2. Press LIP or DOWN to set the monitor channel. 3. Press PTT to save the **double channel monitor** setting.

Setting the SQUELCH Level 1-6

1.Press 🕝 until SL displays.

2. Press UP or DOWN to select the receive sensitivity level: 01=High receive Sensitivity

Setting the double channel monitor

1. Press 🕝 until PR displays,The current channel flashes. 2. Press IIP or DOWN to set the LO OR HI level 3. Press PTT to save the **TX POWER LO/HI** setting.

Safety and General Information

Important Information on Safe and Efficient Operation Read This Information Before Using Your Radio

The informantion provided in this document supersedes the general safety information contained in user guides published prior to July 2000. Transmit and Receive Procedure

Your two-way radio contains a transmitter and a receiver. To control your exposure and ensure compliance with the general population/uncontrolled Transmit no more than 50% of the time.

. To transmit(talk) press the Push to Talk(PTT) buttor

 To receive calls, release the PTT button.

Transmitting 50% of the time, ro lesss, is important because the radio generates measurable RF energy exposure only when transmitting (in terms of measuring standards compliance).

Exposure to Radio Frequency Energy

Your radio is designed to comply with the following national and international standards and guidelines regarding exposure of human beings to radio frequency electromagnetic energy

Two-Way Radio Operation

When using your radio as a traditional two-way radio, hold the radio in a vertical position with the microphone one to two inches(2.5 to 5 cm)

To avoid electromagnetic interference and/or compatibility conflicts.turn off your radio in any facility where posted notices instruct you to do so. Hospitals or health care facilities may be using equipment that is sensitive

When instructed to do so, turn off your radio when on board an aircraft. Any use of a radio must be in accordance with applicable regulations

Potentially Explosive Atmospheres

Turn off your radio prior to entering any area with a potentially explosive atmosphere. Do not remove, install, or charge batteries in such areas. Sparks in a notentially evolusive atmosphere, can cause an evolusion or fire resulting

Note: The areas with potentially explosive atmospheres referred to above include fueling areas such as below decks on boats, fuel or chemical transfer or storage facilities, areas where the air contains chemicals or particles,

such as grain, dust or metal powders, and any other area where you would normally be advised to turn off your vehicle engine. Areas with potentially explosive atmospheres are often but not always posted.

Blasting Caps and Areas

To avoid possible interference with blasting operations, turn off your radio when you are near electrical blasting caps, in ablasting area, or in areas posted: "Turn off two-way radio." Obey all signs and instructions.

Operational Cautions

Do not use any portable radio that has a damaged antenna. If a damaged antenna comes into contact with your skin, a minor burn can result.

All batteries can cause property damage and/or bodily injury such as burns if a conductive material such as jewelry, keys, or beaded chains touch

The conductive material may complete an electrical circuit(short circuit) and become quite hot. Exercise care in handling any charged battery, particularly when placing it inside a pocket, purse, or other container with metal objects.

Battery Charger Safety Instructions

1.Do not expose the charger to rain or snow 2.Do not operate or disassemble the charger if it has received a sharp blow. or has been dropped or damaged in any way.

3. Never alter the AC cord or plug provided with the unit. If the plug will not fit the outlet, have the proper outlet installed by a qualified electrician An improper condition can result in a risk of electric shock. ATTO reduce the risk of damage to the cord or plug, pull the plug rather than the cord when disconnecting the charger from the AC receptacle. 5. To reduce the risk of electric shock, unplug the charger from the outlet before attempting any maintenance or cleaning. 6.Use of an attachment, not recommended, may result in a risk of fire 7 Make sure the cord is located where it will not be stepped on, tripped
