

The span range for the EMI receiver or spectrum analyzer shall be between two times and five times the OBW.</p> <p>b) The nominal IF filter bandwidth (3 dB RBW) shall be in the range of 1% to 5% of the OBW and video bandwidth (VBW) shall be approximately three times RBW, unless otherwise specified by the applicable requirement.</p> <p>c) Set the reference level of the instrument as required, keeping the signal from exceeding the maximum input mixer level for linear operation. In general, the peak of the spectral envelope shall be more than <math>[10 \log (OBW/RBW)]</math> below the reference level. 

For all other frequency hopping systems in the 2400-2483.5 MHz band: 0.125 watts.

Procedure:	<p>This is an RF-conducted test to evaluate maximum peak output power. Use a direct connection between the antenna port of the unlicensed wireless device and the spectrum analyzer, through suitable attenuation. 
### 6.3 Channel Separation

Test Limit:	Refer to 47 CFR 15.247(a)(1), Frequency hopping systems shall have hopping channel carrier frequencies separated by a minimum of 25 kHz or the 20 dB bandwidth of the hopping channel, whichever is greater. Alternatively, frequency hopping systems operating in the 2400-2483.5 MHz band may have hopping channel carrier frequencies that are separated by 25 kHz or two-thirds of the 20 dB bandwidth of the hopping channel, whichever is greater, provided the systems operate with an output power no greater than 125 mW.



Procedure:	<p>The EUT shall have its hopping function enabled. Use the following spectrum analyzer settings:</p> <ul style="list-style-type: none"> <li>a) Span: The frequency band of operation. Depending on the number of channels the device supports, it may be necessary to divide the frequency range of operation across multiple spans, to allow the individual channels to be clearly seen.</li> <li>b) RBW: To identify clearly the individual channels, set the RBW to less than 30% of the channel spacing or the 20 dB bandwidth, whichever is smaller.</li> <li>c) VBW <math>\geq</math> RBW.</li> <li>d) Sweep: Auto.</li> <li>e) Detector function: Peak.</li> <li>f) Trace: Max hold.</li> <li>g) Allow the trace to stabilize.</li> </ul> <p>It might prove necessary to break the span up into subranges to show clearly all of the hopping frequencies. 

The average time of occupancy on any channel shall not be greater than 0.4 seconds within a period of 0.4 seconds multiplied by the number of hopping channels employed. Frequency hopping systems may avoid or suppress transmissions on a particular hopping frequency provided that a minimum of 15 channels are used.
Test Method:	ANSI C63.10-2013, section 7.8.4 KDB 558074 D01 15.247 Meas Guidance v05r02
Procedure:	<p>The EUT shall have its hopping function enabled. Use the following spectrum analyzer settings:</p> <ul style="list-style-type: none"> <li>a) Span: Zero span, centered on a hopping channel.</li> <li>b) RBW shall be <math>\leq</math> channel spacing and where possible RBW should be set <math>\gg 1/T</math>, where T is the expected dwell time per channel.</li> <li>c) Sweep: As necessary to capture the entire dwell time per hopping channel; where possible use a video trigger and trigger delay so that the transmitted signal starts a little to the right of the start of the plot. The trigger level might need slight adjustment to prevent triggering when the system hops on an adjacent channel; a second plot might be needed with a longer sweep time to show two successive hops on a channel.</li> <li>d) Detector function: Peak.</li> <li>e) Trace: Max hold.</li> </ul> <p>Use the marker-delta function to determine the transmit time per hop. If this value varies with different modes of operation (data rate, modulation format, number of hopping channels, etc.), then repeat this test for each variation in transmit time.</p> <p>Repeat the measurement using a longer sweep time to determine the number of hops over the period specified in the requirements. The sweep time shall be equal to, or less than, the period specified in the requirements. 


