



5.3. Test Procedure

- 5.3.1. To set up the EUT as indicated in ANSI C 63.10. The EUT was placed on the table which has 80 cm height to the ground and 40 cm distance to the conducting wall.
- 5.3.2. Power supplier of the EUT was connected to the AC mains through an Artificial Mains Network (A.M.N.).
- 5.3.3. The AC power supplies to all peripheral devices must be provided through line impedance stabilization network (L.I.S.N.)
- 5.3.4. Checking frequency range from 150 kHz to 30 MHz and record the emission which does not have 20 dB below limit.





6.1.1. Block Diagram of EUT Indicated as section 3.9


6.1.2. Setup Diagram for 9kHz-30MHz

6.2. Radiated Emission Limits

In any 100kHz bandwidth outside the frequency band, the radio frequency power produced by the intentional radiator shall be at least 20dB below that in the 100kHz bandwidth within the band that contains the highest level. In addition, radiated emissions which fall in restricted bands, as defined in Section 15.205, must also comply with the radiated emission limits specified as below.

- (2) The tighter limit applies to the edge between two frequency bands.
- (3) Distance refers to the distance in meters between the measuring instrument antenna and the closed point of any part of the device or system.
- (4) Fundamental and emission fall within operation band are exempted from this section.
- (5) Pursuant to ANSI C63.10: 6.6.4.3, if the maximized peak measured value complies with the average limit, then it is unnecessary to perform an average measurement.

6.3. Test Procedure

Frequency Range 9kHz~30MHz:

The EUT setup on the turn table which has 0.8 m height to the ground. The turn table rotated 360 degrees and antenna fixed to 1 m to find the maximum emission level. In order to find the maximum emission, all of the interface cables were manipulated according to ANSI C63.10-2013 regulation.

- (1) RBW = 9kHz with peak and average detector.
- (2) Detector: average and peak (9kHz-490kHz)

Q.P. (490kHz-30MHz)

Frequency Range 30MHz ~ 25GHz:

The EUT setup on the turn table which has 80 cm (for 30-1000 MHz) and 1.5m (for above 1GHz) height to the ground. The turn table rotated 360 degrees and antenna varied from 1 m to 4 m to find the maximum emission level. Both horizontal and vertical polarization are required. In order to find the maximum emission, all of the interface cables were manipulated according to ANSI C63.10-2013 regulation.

Frequency below 1 GHz:

Spectrum Analyzer is used for pre-testing with following setting:

- (1)RBW = 120KHz
- $(2)VBW > 3 \times RBW$.
- (3)Detector = Peak.
- (4)Sweep time = auto.
- (5)Trace mode = max hold.
- (6) Allow sweeps to continue until the trace stabilizes.
- (7) When peak-detected value is lower than limit that the measurement using the Q.P. detector is not required, otherwise using Q.P. for final measurement.

Frequency above 1GHz to 10th harmonic (up to 25 GHz): Peak Detector:

- (1)RBW = 1MHz
- (2)VBW $\geq 3 \times RBW$.
- (3)Detector = Peak.
- (4)Sweep time = auto.
- (5)Trace mode = max hold.
- (6) Allow sweeps to continue until the trace stabilizes.
- (7) When peak-detected value is lower than limit that the measurement using the average detector is not required, otherwise using average detector for final measurement.







The Limits of maximum Peak Output Power for digital modulation in 2400-2483.5MHz is: 1Watt. (30dBm), and E.I.R.P.: 4Watt (36dBm)

8.3. Test Procedure

Following measurement procedure is reference to KDB 558074 D01 DTS Meas Guidance v05:

KPM1 Peak power meter method:

EUT is connected to power sensor and record the maximum output power.

Maximum peak conducted output power method:

- (1) Set the RBW \geq DTS bandwidth
- (2) Set $VBW \ge 3 \times RBW$
- (3) Set span $\geq 3 \times RBW$.
- (4) Sweep time = auto couple
- (5) Detector = peak.
- (6) Trace mode = \max hold.
- (7) Allow trace to fully stabilize.
- (8) Use peak marker function to determine the peak amplitude level.

Method AVGPM (Measurement using an RF average power meter):

EUT is connected to power sensor and record the maximum average output power and duty cycle factor is added when duty cycle presented in section 3.7 is < 98%.

Method AVGSA-2 (Spectrum channel power)


- (1) Set span to at least 1.5 times the OBW
- (2) Set RBW = 1-5% of OBW
- (3) Set the video bandwidth (VBW) \geq 3 × RBW.
- (4) Detector = RMS.
- (5) Trace mode = trace average at least 100 traces
- (6) Sweep = auto couple.
- (7) Compute power by integrating the spectrum across the OBW of the signal using the instrument's band power measurement function with band limits set equal to the OBW band edges.
- (8) Duty cycle factor is added when duty cycle presented in section 3.7 is < 98%.

9.2. Specification Limits

In any 100kHz bandwidth outside the frequency band in which the spread spectrum or digitally modulated intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20dB below that in the 100kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement. If the transmitter complies with the conducted power limits based on the use of RMS averaging over a time interval, that the required attenuation shall be 30 dB instead of 20 dB.

Attenuation below the general limits specified in Section 15.209(a) is not required. In addition, radiated emissions which fall in restricted bands, as defined in Section 15.205(a), must also comply with the radiated emission limits specified in Section 15.209(a) (See Section 15.205(c)).

9.3. Test Procedure

Following measurement procedure is reference to KDB 558074 D01 DTS Meas Guidance v05:

Reference Level

- (1) Set analyzer center frequency to DTS channel center frequency.
- (2) Set the span to 1.5 times the DTS bandwidth.
- (3) Set the RBW to: 100 kHz.
- (4) Set the VBW \geq 3 × RBW.
- (5) Detector = peak.
- (6) Sweep time = auto couple.
- (7) Trace mode = max hold.
- (8) Allow trace to fully stabilize to find the max PSD as reference level.



The peak power spectral density conducted from the intentional radiator to the antenna shall not be greater than 8dBm in any 3kHz band.

10.3.Test Procedure

Following measurement procedure is reference to KDB 558074 D01 DTS Meas Guidance v05:

Method PKPSD (peak PSD)

- (1) Set analyzer center frequency to DTS channel center frequency.
- (2) Set the span to 1.5 times the DTS bandwidth.
- (3) Set the RBW to: $3 \text{ kHz} \le \text{RBW} \le 100 \text{ kHz}$.
- (4) Set the VBW \geq 3 × RBW.
- (5) Detector = peak.
- (6) Sweep time = auto couple.
- (7) Trace mode = max hold.
- (8) Allow trace to fully stabilize.
- (9) Use the peak marker function to determine the maximum amplitude level.
- (10) If measured value exceeds limit, reduce RBW (no less than 3 kHz) and repeat.

Method AVGPSD-2

- (1) Using peak PSD procedure step 1 to step 4.
- (2) Detector= RMS detector
- (3) Sweep time = auto couple
- (4) Trace mode = trace averaging over a minimum of 100 traces
- (5) Use the peak marker function to determine the maximum amplitude level.
- (6) Duty cycle factor is added when duty cycle presented in section 3.7 < 98%.
- (7) If measured value exceeds limit, reduce RBW (no less than 3 kHz) and repeat.

10.4. Test Results
