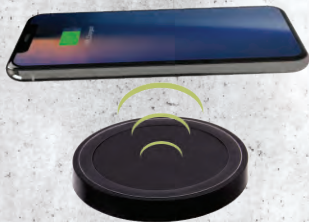


# VIVITAR® WIRELESS CHARGER

# Important Safety Precautions

When using your charger, basic safety precautions should always be followed, including the following:

1. READ ALL INSTRUCTIONS BEFORE USING YOUR CHARGER.
2. Never expose your charger to high temperatures, extreme cold, high humidity or any moisture or water.
3. In order to avoid the risk of electric shock, never attempt to open your charger or repair it without the assistance of certified professionals.
4. Your charger is not to be used by children or the infirm without suitable adult supervision.
5. When your smartphone is fully charged, remove it from your charger.
6. Do not use your charger at temperatures under 40°F (5°C) or over 95°F (35°C).
7. Do not drop your charger, throw it, or subject it to strong impacts or physical trauma.
8. If you detect any abnormalities when using your charger, contact the manufacturer for support.
9. When charging, do not place your charger on flammable materials such as rugs, carpets or bedding.
10. Do not place any metallic items other than compatible smartphones on the surface of your charger.
11. Only place Qi compatible phones on the surface of your charger. The use of incompatible phones can cause your charger to overheat.
12. Your charger may cause interference to radio equipment and should not be installed near maritime safety communications equipment or other critical navigation, communication or medical equipment.
13. Please recycle or dispose of your power pack properly based on the laws and rules of your municipality. Contact local recycling facilities and/or the manufacturer of your power pack for further information.

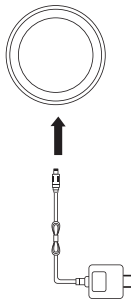
# Plugging In Your Charger



1. The included charging cable has a Micro USB plug and a standard plug.

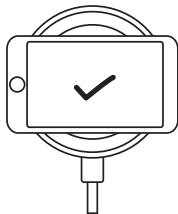


2. Insert the charging cable's standard plug into a suitable wall outlet in your home.



3. Insert the charging cable's Micro USB plug into the charging port on your charger.

# Using Your Charger

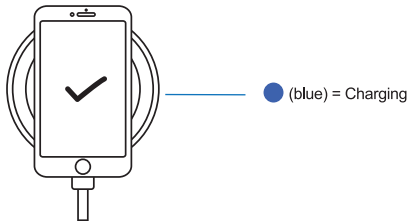


1. Place your Qi compatible smartphone on the charging surface of your charger. For best results, make sure that your phone is as close to the center of the charging surface as possible.

-Your charger can only be used to charge one Qi compatible smartphone at once. Do not attempt to charge multiple phones at the same time.

-Make sure that your phone's ringer is not in vibrate mode and that **all** other vibration functions are disabled while your phone is charging. Any vibrations can cause your phone to move around, disrupting its connection to the charger.

## Using Your Charger (continued)



2. The Charging Indicator Light turns blue as your phone is charging. Look at your phone's display screen to see the charging progress. Remove your phone from the charging surface once charging is complete.

\*OTP Protection: The OTP function (over temperature protection) reduces output and will eventually shut off your charger to prevent overheating.



## **IMPORTANT WARNING**

Do not use to charge any phones that have a metal body, or phone cases that contain any metal parts, metal pieces or magnets. Doing so can increase the risk of fire, serious malfunction or damage to your phone.
