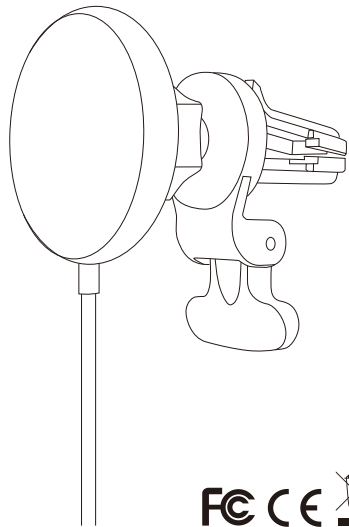

Case Thickness(Over 4mm)

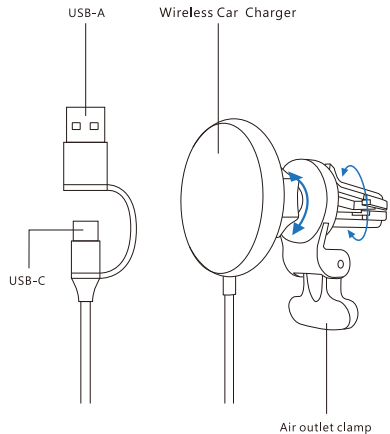

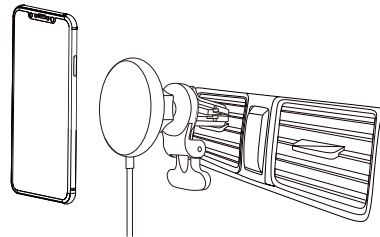
