

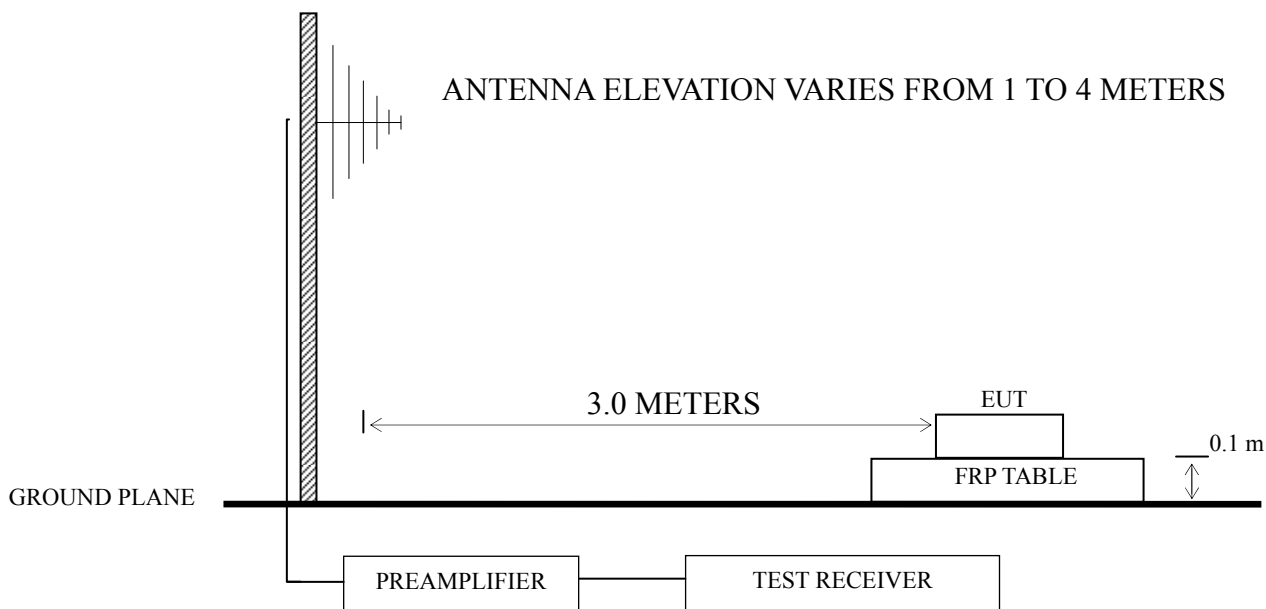

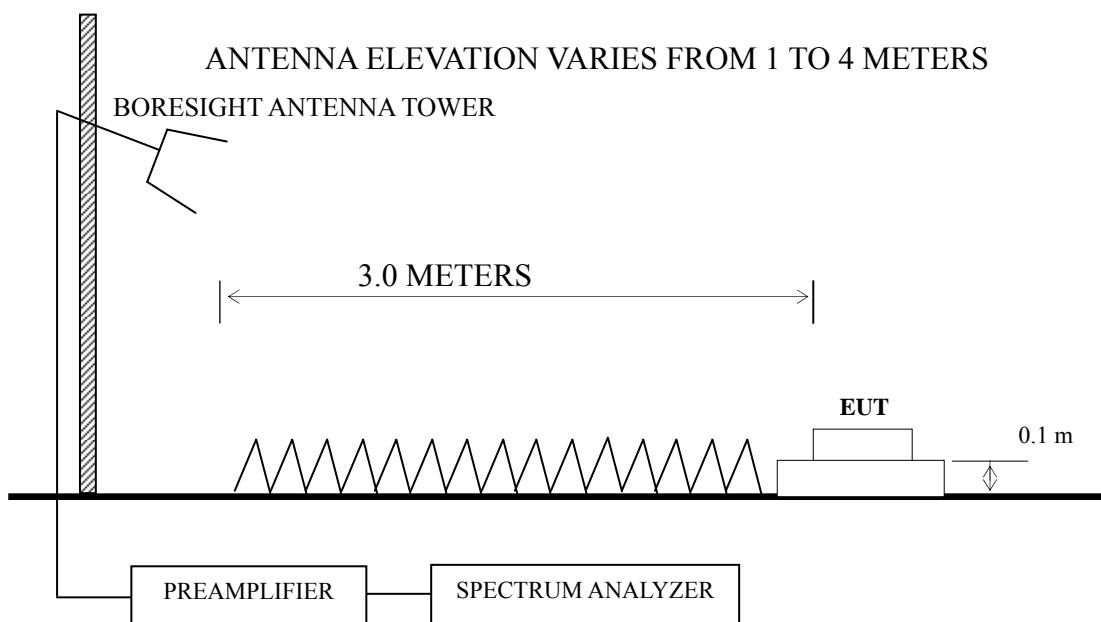
#### 3.2 Block Diagram of Test Setup

### 3.4 Test Configuration

The EUT (listed in Sec.2.1) and the simulators (listed in Sec.2.2) were installed as shown on Sec.3.2 to meet FCC requirements and operating in a manner that tends to maximize its emission level in a normal application.

### 3.5 Operating Condition of EUT

3.5.1 Setup the EUT as shown in Sec. 3.2.

3.5.2 Turn on the power of all equipment.

3.5.3 Turn the EUT on the test mode, and then test.

### 3.6 Test Procedures

Radiated emission test applies to harmonics/spurs that fall in the restricted bands listed in Section 15.205. The maximum permitted average field strength is listed in Section 15.209. A pre-amp is necessary for this measurement. For measurement above 1 GHz, set RBW = 1MHz, VBW = 10 Hz, Sweep: Auto. If the emission is pulsed, modify the unit for continuous operation; use the settings shown above, then correct the reading by subtracting the peak-average correction factor, derived from the appropriate duty cycle calculation.

The EUT was placed on a turntable. Below 1 GHz, the table height is 10 cm above the reference ground plane. Above 1 GHz, the table height is 10 cm. The turntable rotated 360 degrees to determine the position of the maximum emission level. The EUT was set 3 meters away from the receiving antenna, which was mounted on an antenna tower. The antenna moved up and down between 1 meter and 4 meters to find out the maximum emission level. Broadband antenna (Calibrated Bilog Antenna) or Horn antenna was used as receiving antenna. Both horizontal and vertical polarizations of the antenna were set on measurement. In order to find the maximum emission, all of the interference cables were manipulated according to ANSI C63.10: 2013 requirements during radiated emission test.

The bandwidth of Test Receiver R&S ESCI was set at 120 kHz from 30MHz to 1000MHz.

The bandwidth of the VBW was set at 1MHz and RBW was set at 1MHz for peak emission measurement above 1GHz and 1MHz RBW, 10Hz VBW for average emission above 1GHz for Spectrum Agilent N9010A.

The frequency range from 30 MHz to 25 GHz (Up to 10<sup>th</sup> harmonics from fundamental frequency) was checked.

All the test results are listed in Sec.3.7.

### 3.7 Test Results

The frequency and amplitude of the highest radiated emission relative the limit is reported. All the emissions not reported below are too low against the FCC limit.

For above 1GHz test, if the peak measured value complies with the average limit, it is unnecessary to perform an average measurement.

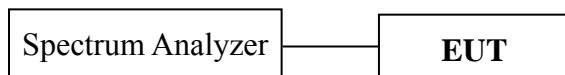

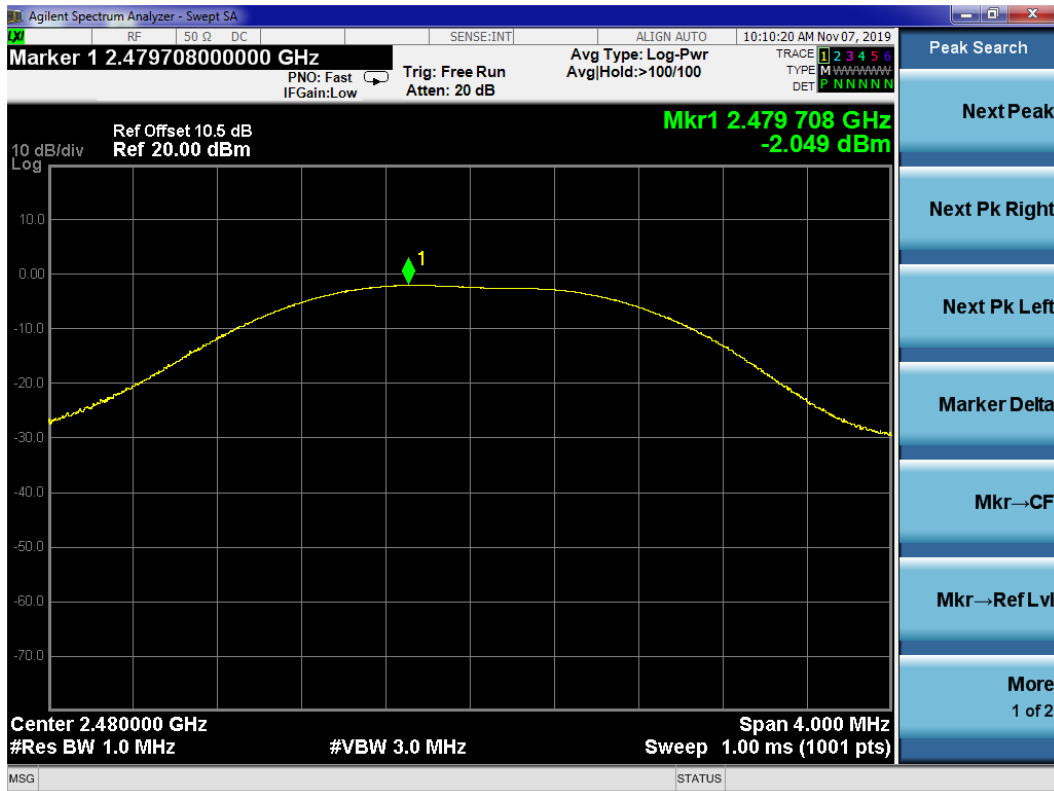

### 6.3 Specification Limits (§15.247(d))

In any 100 kHz bandwidth outside the frequency band in which the spread spectrum or digitally modulated intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20 dB below that in the 100 kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement, provided the transmitter demonstrates compliance with the peak conducted power limits. If the transmitter complies with the conducted power limits based on the use of RMS averaging over a time interval, as permitted under paragraph (b)(3) of this section, the attenuation required under this paragraph shall be 30 dB instead of 20 dB. Attenuation below the general limits specified in §15.209(a) is not required.

Establish a reference level by using the following procedure:

- a) Set instrument center frequency to DTS channel center frequency.
- b) Set the span to  $\geq 1.5$  times the DTS bandwidth.
- c) Set the RBW = 100 kHz.
- d) Set the VBW  $\geq [3 \times \text{RBW}]$ .
- e) Detector = peak.
- f) Sweep time = auto couple.
- g) Trace mode = max hold.
- h) Allow trace to fully stabilize.
- i) Use the peak marker function to determine the maximum PSD level.

Note that the channel found to contain the maximum PSD level can be used to establish the reference level.

Establish an emission level by using the following procedure:

- a) Set the center frequency and span to encompass frequency range to be

measured.

b) Set the RBW = 100 kHz.

c) Set the VBW  $\geq [3 \times \text{RBW}]$ .

d) Detector = peak.

e) Sweep time = auto couple.

f) Trace mode = max hold.

g) Allow trace to fully stabilize.

h) Use the peak marker function to determine the maximum amplitude level.

Ensure that the amplitude of all unwanted emissions outside of the authorized frequency band (excluding restricted frequency bands) is attenuated by at least the minimum requirements specified in 11.11. Report the three highest emissions relative to the limit.

Scan up through 10<sup>th</sup> harmonic.

The test procedure is defined in ANSI C63.10-2013 (11.11.2 Reference level measurement and 11.11.3 Emission level measurement was used).

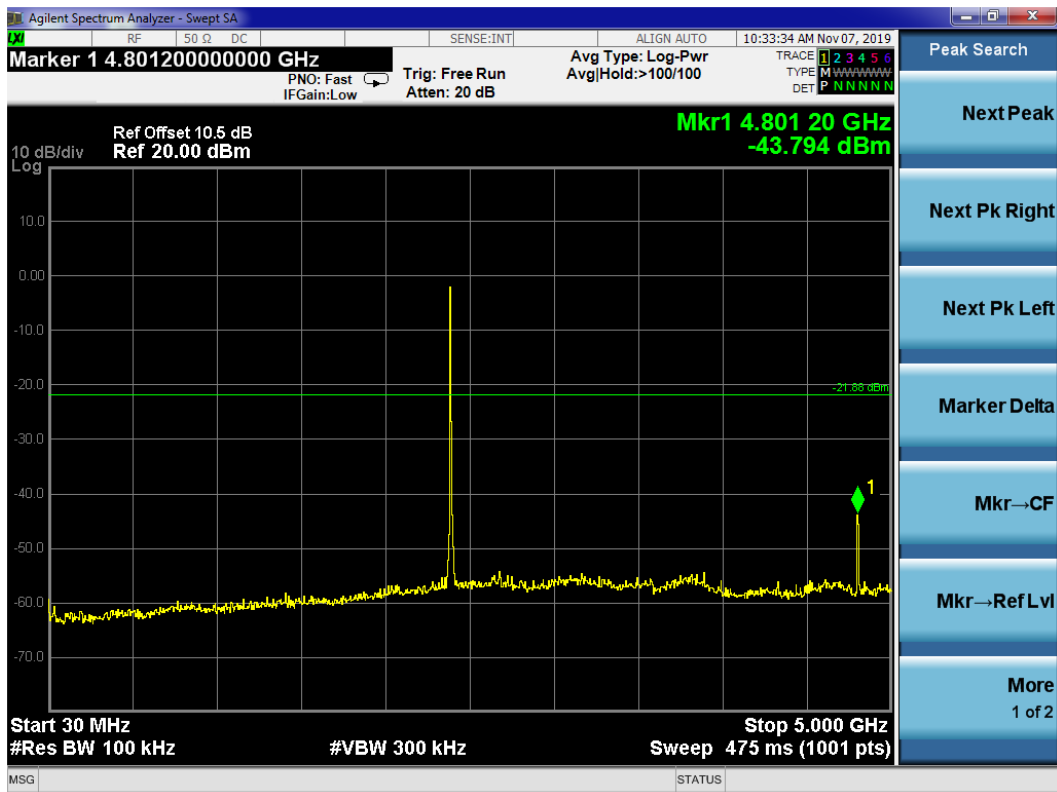

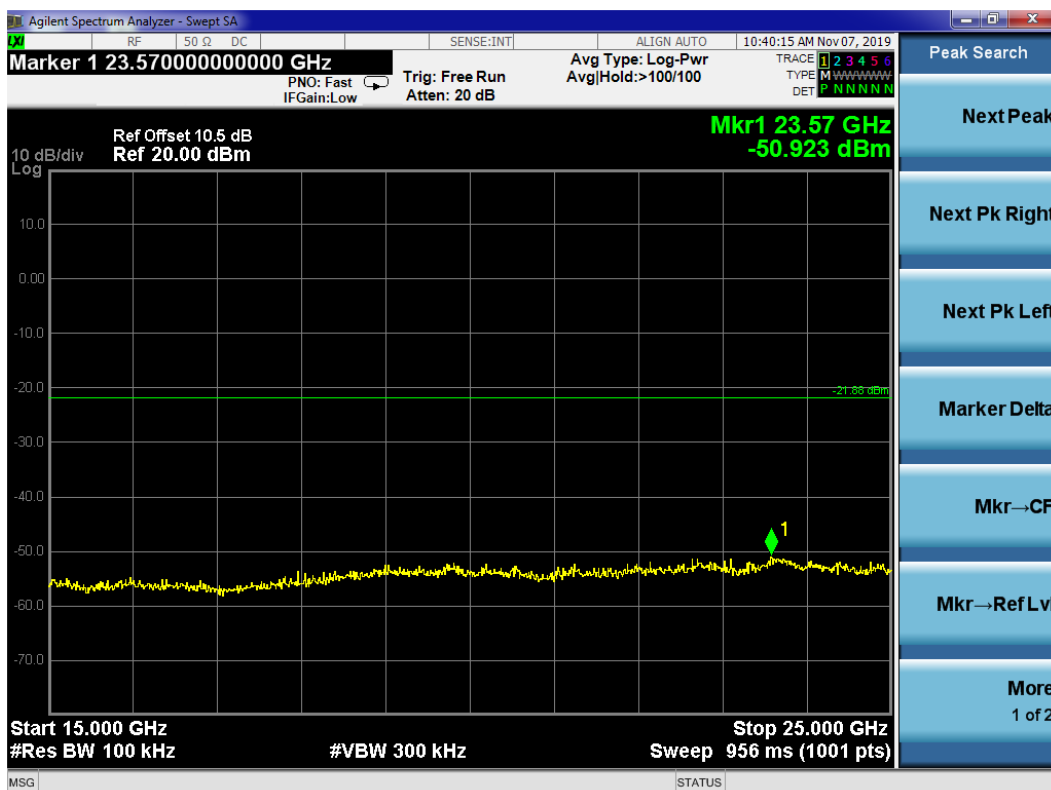
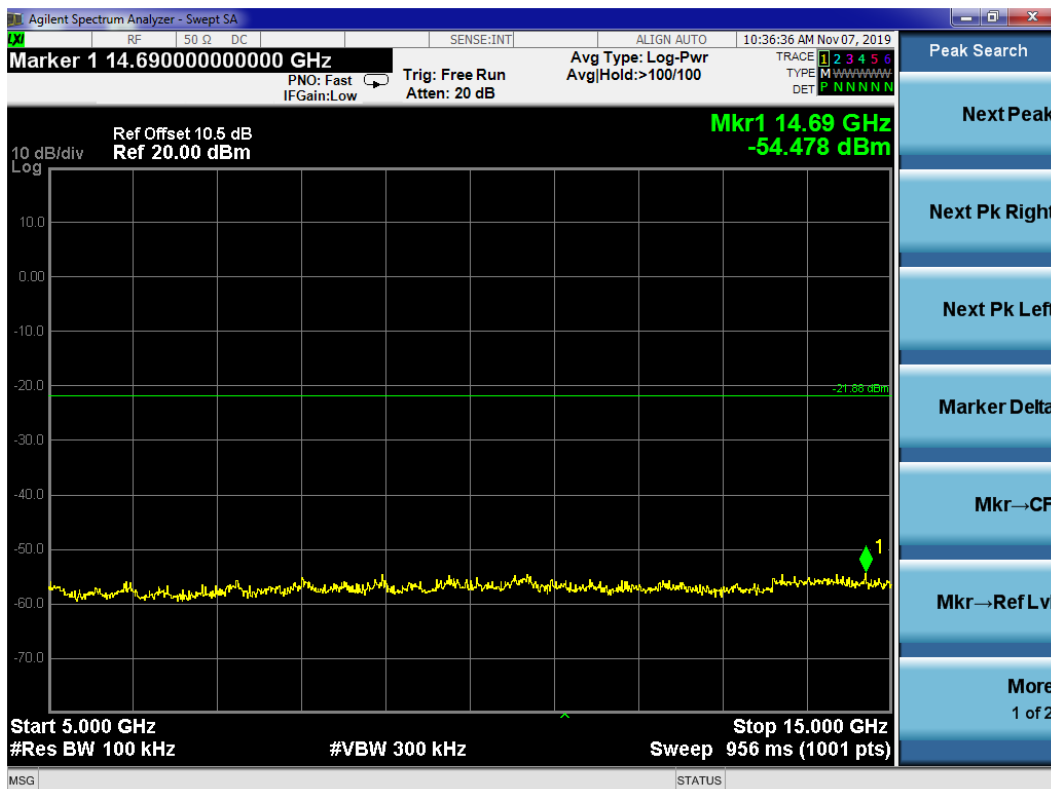

#### Reference level



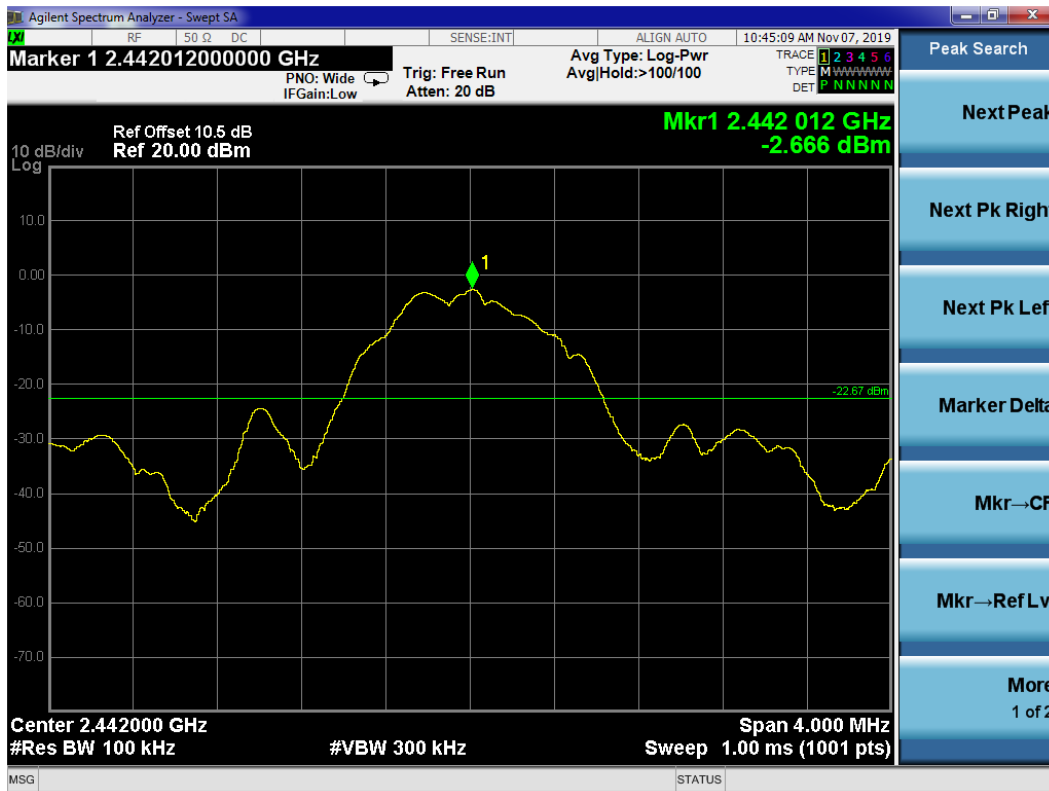
#### Emission level



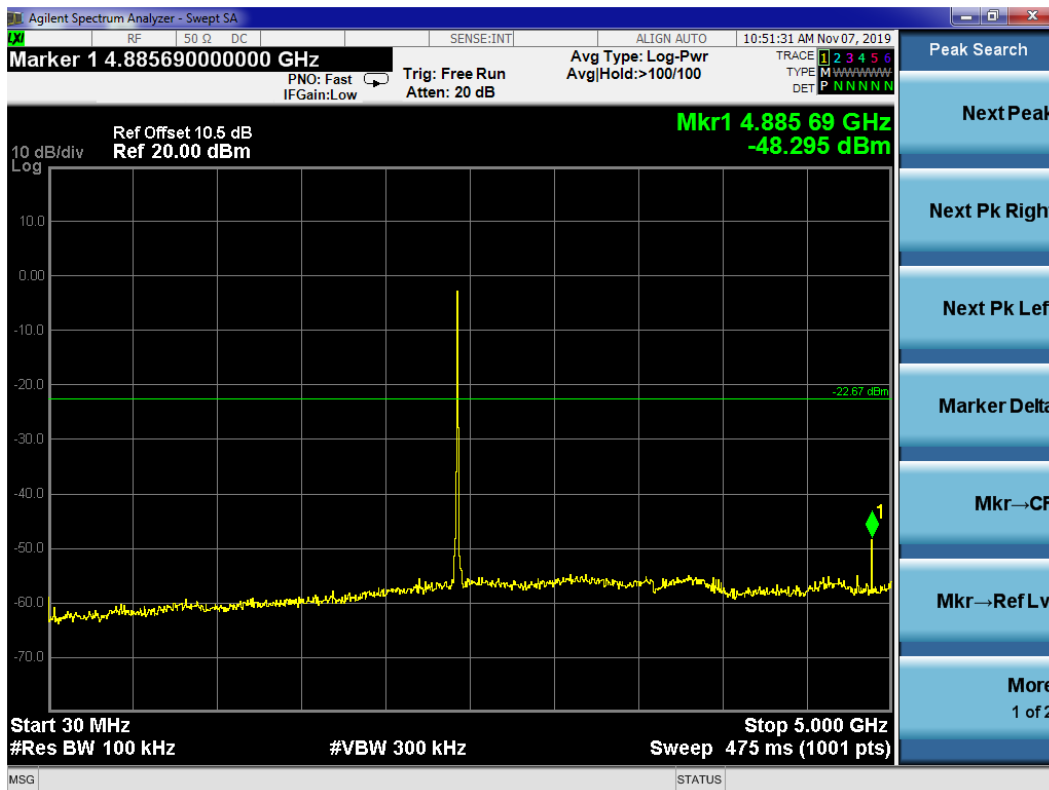


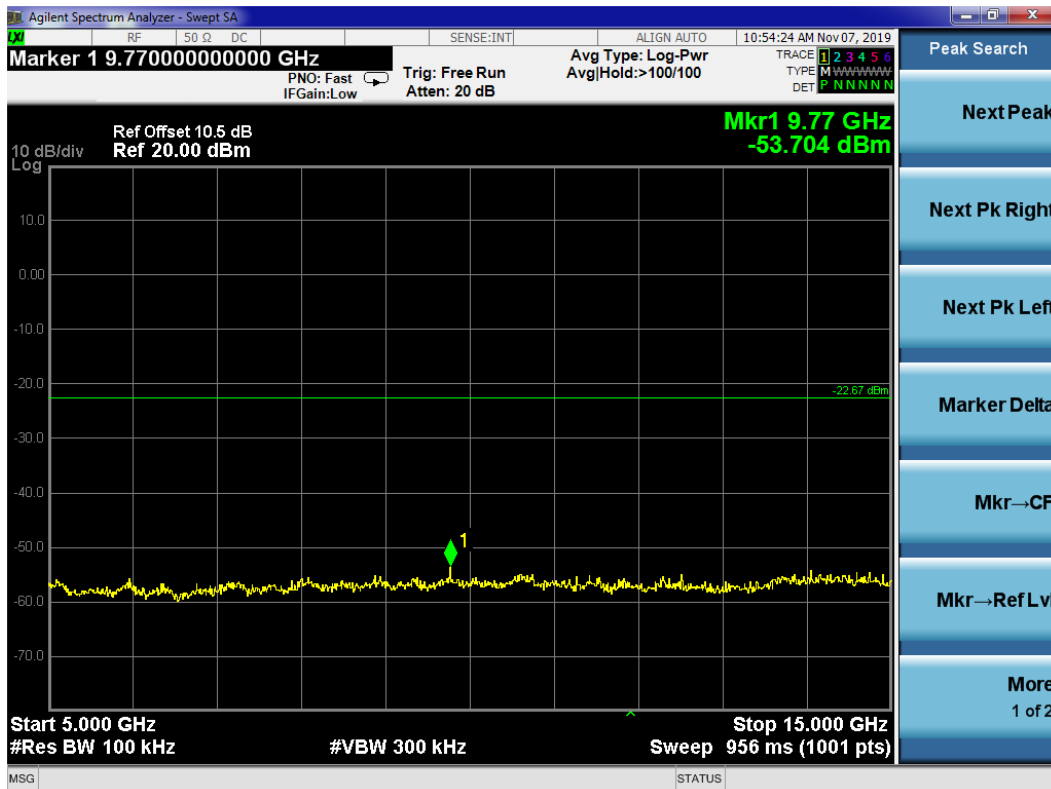

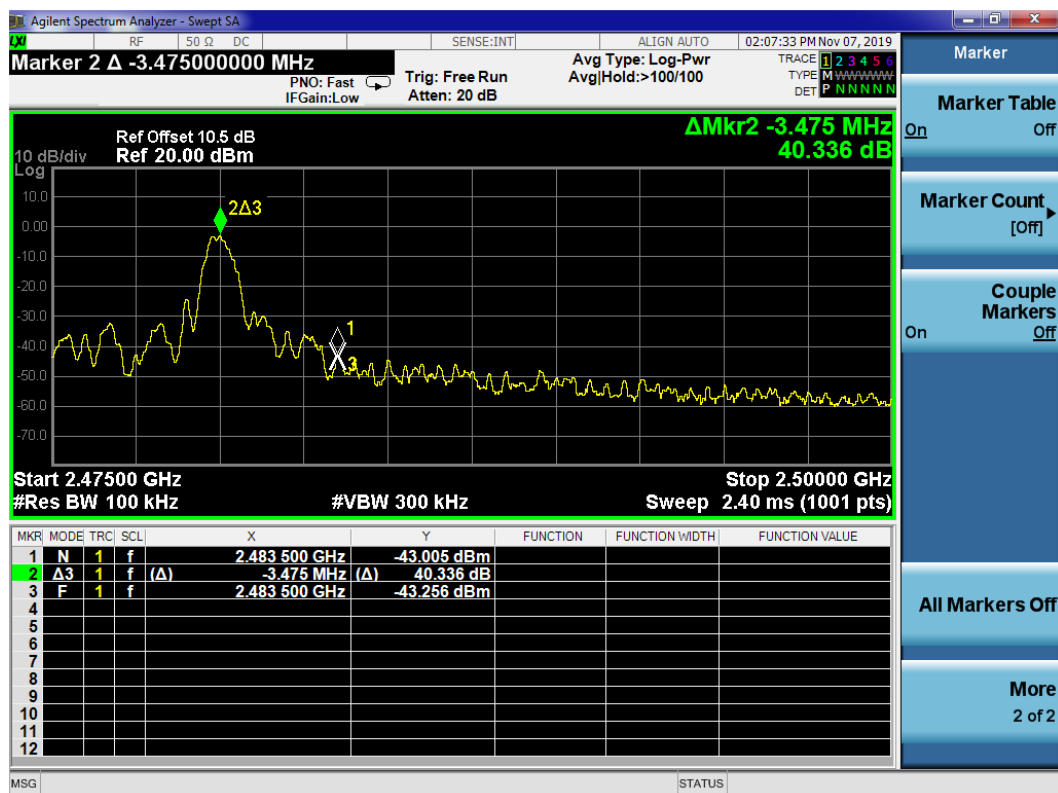

- c) Set the RBW to  $3 \text{ kHz} \leq \text{RBW} \leq 100 \text{ kHz}$ .
- d) Set the VBW  $\geq [3 \times \text{RBW}]$ .
- e) Detector = peak.
- f) Sweep time = auto couple.
- g) Trace mode = max hold.
- h) Allow trace to fully stabilize.
- i) Use the peak marker function to determine the maximum amplitude level within the RBW.
- j) If measured value exceeds requirement, then reduce RBW (but no less than 3 kHz) and repeat.

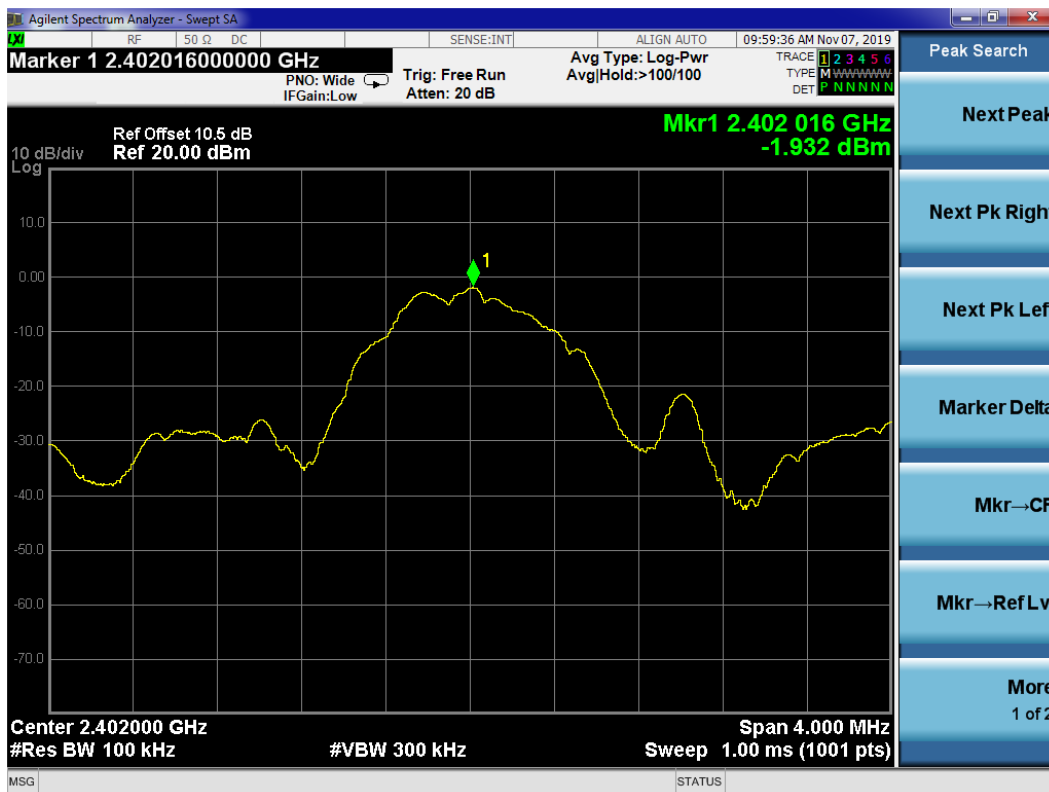

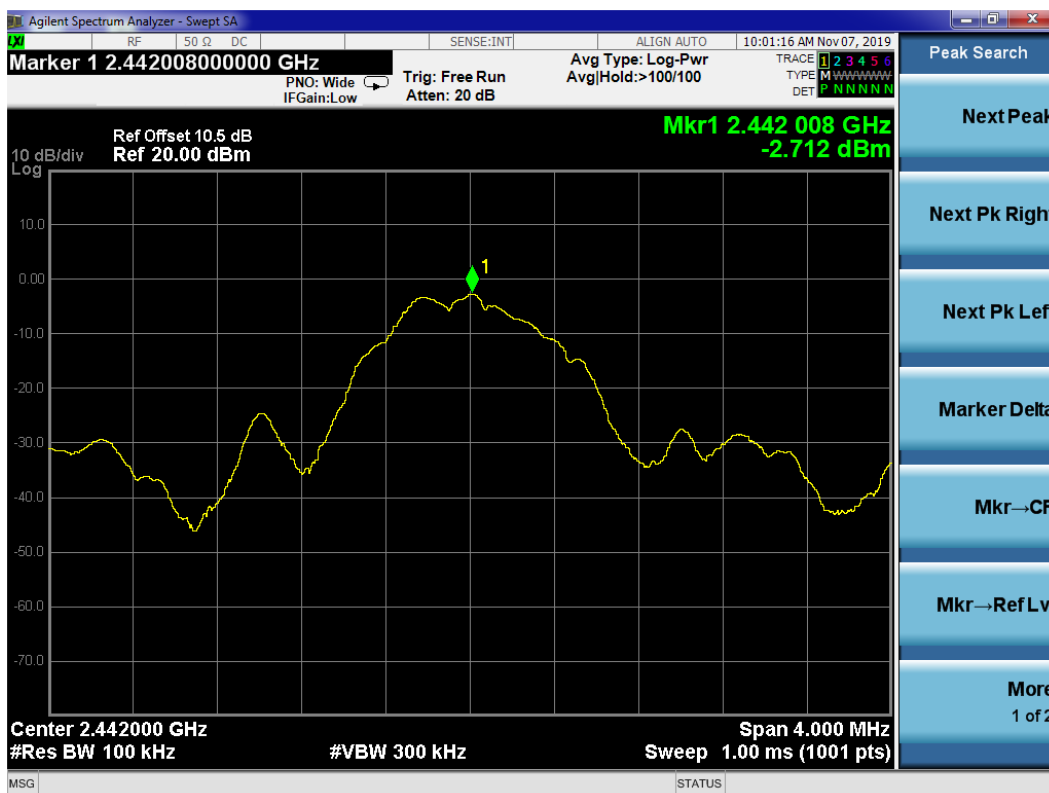
