Prinker is a comprehensive solution that allows you to apply images on skin.

Follow included manual to setup and use Prinker in a safe and proper manner. Visit SketchOn Website to see the demonstration video. We recommend that you take part in user training workshop to get accustomed to Prinker before using it for commercial purposes. For information about user training workshops please contact an authorized Prinker reseller or info@sketchon.me

Every effort has been made to ensure that the contents of this manual are accurate, however SketchOn Inc. reserves the right to make changes without notice.

Inserting Batteries and Cartridges

1. Slide the top cover backwards to open the Prinker inner compartment.
2. Cartridges: Remove the tape and orange plastic cap from the cartridge. Place the cartridge into the slot and gently push until it locks in place. Cartridge head should be oriented towards the display.
3. Batteries: To unlatch the battery slot cover push inward the release tab. Insert battery in the direction of the arrow until it locks in place.
4. Slide the top cover upward to close the top cover.

TIP! Remove the cartridges from the device if you do not use Prinker for more than few hours.

ALWAYS TURN THE DEVICE OFF BEFORE INSERTING OR REMOVING CARTRIDGES.

INSERTING THE CARTRIDGES OR BATTERIES UPSIDE DOWN OR BACKWARDS COULD DAMAGE THE DEVICE. BE SURE TO CHECK THAT THE CARTRIDGES AND BATTERIES ARE IN THE CORRECT ORIENTATION.

App Setup Guide

To install the Android Prinker app:

1. Open Google Play Store and search for Prinker SketchOn
2. Tap the Download button. Tap the Accept and download button to accept terms of use.
3. Tap the Prinker icon to open the Prinker mobile app.

TIP! You can also use the QR code imprinted on the box to get to the App directly.

Setting up the Device

1. Boot the device by pressing shortly (app. 3 sec) the Power button.
Wait until Prinker logo appears on the device display.
2. Connect your smartphone to a Wi-Fi network.
3. Bluetooth Pairing:
 - Press Bluetooth button to pair the device with your phone
 - Scan for available Bluetooth devices on your mobile phone, select the serial number of the device inscribed above the battery compartment from the available devices and confirm connection (e.g w00008 prinker_white_8)
4. Open the Prinker App and tap the Bluetooth icon to select Prinker device you are going to use
5. Sign in and Insert your Access Pass to use services.
6. Device is ready to start operating.

How to Apply Images to Skin by Prinker in 10 Steps (Check the demonstration video on SketchOn website for better understanding.)

- Step 1. Remove the bottom slide by sliding it backwards.
- Step 2. Press the Power button to turn on Prinker. The Prinker logo will appear on the display screen.
- Step 3. Spray the Coating Primer on the part of the body where you want to apply image.
Spray app. 30cm from place where image is to be applied. Wait app. 10 sec to dry.
 - ▲ Avoid contact with eyes, mouth, wounds and scars.
- Step 4. In the Prinker App select the content to apply to skin. You can select image from the Gallery or draw your own image by using Sketcher function.
- Step 5. Tap the Send icon to send the image to the device. If sent successfully, the App will display the prompt "Sent Successfully!" and device display will show "READY".
It may take a while to send an image you drew by using Sketcher function. Please wait until the app will display the prompt "Sent Successfully!" and device display will show "READY"
- Step 6. Hold the Prinker in the place where image is to be applied.
 - ▲ Prinker should be placed on flat surface (e.g. forearm, shoulder, back, leg, thigh etc.)
- Step 7. Press the Operating button. Wait until "GO" message appear on the device display to rub the device.
- Step 8. Move the Prinker device at a constant speed. Front wheels should lead the direction of rubbing.
 - ▲ Do not press the device to the skin surface and do not raise wheels from the skin surface.

Step 9. Wait 10-20 seconds for ink to dry. You can spray Coating Primer for longer effect.

To apply new image repeat procedures starting from Step 3.

To apply the same image repeat procedure starting from Step 5.

If not used for more than 90 seconds Prinker device will go into Sleep mode. To activate the device you can select and send image in the App or press any of following buttons: Power, Bluetooth, Operating.

Step 10. Slide the bottom cover upward to prevent cartridges from drying out. After finishing using the device remember to turn off the device by pressing the power button for 1-2 seconds.

Useful Tips

1. Spray Coating Primer offered by SketchOn before and after application of image to skin for better and longer effect.
2. Dry the surface where you are going to rub the Prinker.
3. Images applied by Prinker are soap-washable. Applied images can be also removed by wet wipes or other make-up cleansing cosmetics. When removing refrain from rubbing strongly or scratching the skin as it may cause skin irritation, redness or allergic reaction.
4. If nozzles are dirty or clogged with dried ink use wet wipes to wipe and clean them. Due to environmental conditions, in some high altitude regions it may be necessary to clean nozzles more often.
5. Do not alter the speed of moving Prinker while rubbing. Refrain from moving while applying image to skin.
6. In case of strong wind the image may not be applied correctly. Operating the device in too hot, too cold or too humid environment may influence the quality of image applied to skin.

Significance of the Commands on the Screen

Command	Meaning
SLIDE / COVER	Open or close bottom slide / top cover
RETRY	Failed to send image. Send image again.
READY	Image was sent successfully to Prinker device, ready to apply image
GO	After pushing operating button, image is to be applied
UPDATE	Wait. Prinker device is updating.
ERROR	The error occurred. Reboot the device. If problem persists contact an authorized reseller.
Battery Icon	Battery is getting low. Change batteries.
Bluetooth Icon	Ready to pair Prinker with your mobile device.
Lock	Your device is locked. Check your account or contact reseller for assistance.

Notes for the Priniker

- ⚠ Do not attempt to disassemble the Priniker device.
- ⚠ Do not drop the Priniker device or allow it to hit solid objects.
- ⚠ To prevent the Priniker device from being damaged by moisture, do not use or store it in very humid environments, such as in rain or near bodies of water.
- ⚠ Do not use or store Priniker in dusty places or on a beach to prevent dust or sand from entering the Priniker device, causing possible damage to it.
- ⚠ Do not use or store the Priniker device in a hot environment or under direct sunlight.
- ⚠ Do not use or store the Priniker device near a powerful magnetic field, for example near a magnet or transformer.
- ⚠ Turn the Priniker device off if it overheats and wait until the unit cools down to resume using the device.
- ⚠ Avoid touching and scratching the print head nozzles and copper-colored electrical contacts.
- ⚠ Store the Priniker device in on the closed bottom cover on a flat surface when you are going to store the device for a long period of time.
- ⚠ When you clean the body of the Priniker device, do not use abrasive, alcohol-based or organic cleaner.
- ⚠ Use the wet wipe to clean nozzles and cooper-colored electrical contacts inside the device. Due to environmental conditions, in some high altitude regions it may be necessary to clean nozzles more often.
- ⚠ If ink accidentally split inside the device, turn the device off, remove the battery and the cartridges, and use wet wipe to clean the cooper-colored electrical contacts inside the Priniker device.
- ⚠ Remove the battery and cartridges when you are not going to use the Priniker device for more than 3 days. Before you remove the battery

Notes for the Battery

- ⚠ Do not short circuit, disassemble, dispose of in fire, heat, expose to water, puncture or crush. Do not solder directly to the cell or battery and do not connect in reverse polarity.
- ⚠ Do not store the battery in a hot environment or in direct sunlight.
- ⚠ Do not let the battery come in contact with metal objects (including coins) to avoid short circuiting, discharging, excessive heat, or possible leakage.
- ⚠ Do not allow children or animals/pets to handle or transport batteries (prevent dangerous behavior such as licking, putting in mouth or chewing).
- ⚠ Before loading, always inspect the battery carefully for leaks, discoloration, warping, or any other abnormality.

- ⚠ If battery fluid leaks inside the Prinker device, please contact an authorized reseller from whom you purchased Prinker.
- ⚠ If battery fluid leaks, avoid contact with eyes and skin. If leaked onto your skin or eyes, rinse your with clean water and seek immediate medical attention.
- ⚠ Do not inhale leaked fluid. If inhaled, seek immediate medical attention. Move to fresh air. If symptoms persist, call a physician.

This limited warranty does not cover any damage, deterioration or malfunction resulting from any alteration, modification, improper or unreasonable use or maintenance, misuse, abuse, accident, neglect, exposure to excess moisture, fire, improper packing and shipping (such claims must be presented to the carrier), lightning, power surges, or other acts of nature.

This limited warranty does not cover any damage, deterioration or malfunction resulting from the installation or removal of this product from any installation, any unauthorized tampering with this product, any repairs attempted by anyone unauthorized by SketchOn to make such repairs, or any other cause which does not relate directly to a defect in materials and/or workmanship of this product.

This limited warranty is void if (i) the label bearing the serial number of this product has been removed or defaced, (ii) a product or a part that has been modified without the written permission of SketchOn, (iii) the product is not distributed by SketchOn or (iv) the product is not purchased from an authorized SketchOn reseller. How Long this Coverage Lasts

The standard limited warranty for Printer device is one (1) year from the date of original purchase.

The standard limited warranty for ink cartridges lasts until the SketchOn ink is depleted or the "Warranty Ends" date printed on the cartridge has been reached, whichever occurs first.

Who is Covered

Only the original purchaser of this product is covered under this limited warranty. This limited warranty is not transferable to subsequent purchasers or owners of this product. Original proof of purchase is the sole responsibility of the consumer/purchaser and is required for all warranty related claims.

What SketchOn Will Do

SketchOn will, at its sole option, provide one of the following three remedies to whatever extent it shall deem necessary to satisfy a proper claim under this limited warranty: (i) elect to repair or facilitate the repair of any defective parts within a reasonable period of time, free of any charge for the necessary parts and labor to complete the repair and restore this product to its proper operating condition, SketchOn will also pay the shipping costs necessary to return this product once the repair is complete; (ii) exchange the product with a product that is new or which has been manufactured from new or serviceable used parts and is at least functionally equivalent to the original product, or (iii) refund your actual purchase price less reasonable depreciation based on actual usage of the product in any instance where the product is no longer available and repair is not possible.
