Smart Doorbell User Manual

1 . App downloading and Installation

Scan the QR code to download the App, then install it on your phone

Or search "mini doorbells" on App Store or Google play to download the App.

2 . Add a Smart Doorbell

In the room interface, click "+" button (Shown in Figure 1), enter into interface of adding Doorbell devices (Shown in Figure 2), then follow the instructions on the App to finish the smart doorbell adding.

Click the "Upload" button to upload the data to cloud after doorbell adding (Shown in Figure 3), then the app can get instant photo notification when visitors press the doorbell.

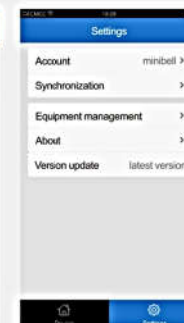

3 . Delete and Rename Smart Doorbell

【Settings】 - 【Equipment Management】 (Shown in Figure 4) , Find your smart doorbell icon and slide to the left. There will be two small options (Shown in Figure 5) , click on the right one (delete icon) to delete the smart doorbell, click on the left one (rename icon) to rename the smart doorbell.

4 . Functions of Smart Doorbell

4.1 In the room interface(Shown in Figure 6), click on 【Mini doorbell】 icon to enter into the smart doorbell interface(Shown in Figure 7), the App will get instant photo when visitors press the doorbell.

4.2 In the smart doorbell interface, click on 【visitors list】 icon to enter into the visitor interface (Shown in Figure 8), click on 【Save picture】 icon to save the picture.

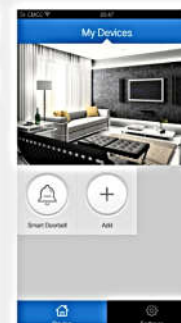

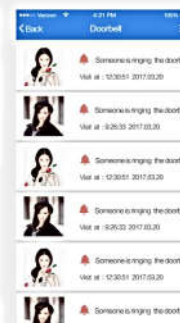
