Objective

This type approval report is prepared on behalf of *Shenzhen Qianhai Patuoxun Network & Technology co.,ltd* in accordance with Part 2-Subpart J, and Part 15-Subparts A and C of the Federal Communication Commissions rules.

The tests were performed in order to determine compliance with FCC Rules Part 15, Subpart C, and section 15.203, 15.205, 15.209, 15.215 and 15.249 rules.

Test Methodology



According to § 15.203, an intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device. The use of a permanently attached antenna or of an antenna that uses a unique coupling to the intentional radiator shall be considered sufficient to comply with the provisions of this section. The manufacturer may design the unit so that a broken antenna can be replaced by the user, but the user of a standard antenna jack or electrical connector is prohibited. The structure and application of the EUT were analyzed to determine compliance with section §15.203 of the rules. §15.203 state that the subject device must meet the following criteria:

- a. Antenna must be permanently attached to the unit.
- b. Antenna must use a unique type of connector to attach to the EUT.
- c. Unit must be professionally installed, and installer shall be responsible for verifying that the correct antenna is employed with the unit.

The EUT has internal PCB Antenna permanently attached to the unit, the antenna gain is 2.0 dBi, fulfill the requirement of this section. Please refer to the EUT photos.





The radiated emission below 1GHz tests were performed in the 10 meters chamber test site, above 1GHz tests were performed in the 3 meters chamber test site B, using the setup accordance with the ANSI C63.10-2013. The specification used was the FCC 15.209, and FCC 15.249 limits.

Test Equipment Setup

The system was investigated from 30 MHz to 25 GHz.

During the radiated emission test, the EMI test receiver & Spectrum Analyzer Setup were set with the following configurations:

If the maximized peak measured value complies with under the QP/Average limit more than 6dB, then it is unnecessary to perform an QP/Average measurement.

Test Procedure

Maximizing procedure was performed on the highest emissions to ensure that the EUT complied with all installation combinations.

Data was recorded in Quasi-peak detection mode for frequency range of 30 MHz - 1 GHz, peak and average detection modes for frequencies above 1 GHz.

Corrected Amplitude & Margin Calculation

The Corrected Amplitude is calculated by adding the Antenna Factor and Cable Loss, and subtracting the Amplifier Gain from the Meter Reading. The basic equation is as follows:

Corrected Amplitude = Meter Reading + Antenna Factor + Cable Loss - Amplifier Gain

The "Margin" column of the following data tables indicates the degree of compliance with the applicable limit. For example, a margin of 7dB means the emission is 7dB below the limit. The equation for margin calculation is as follows:

Margin = Limit – Corrected Amplitude

Fundamental Test with Band Rejection Filter











Test Procedure

- 1. Check the calibration of the measuring instrument using either an internal calibrator or a known signal from an external generator.
- 2. Measure the frequency difference of two frequencies that were attenuated 20 dB from the reference level. Record the frequency difference as the emission bandwidth.
- 3. Repeat above procedures until all frequencies measured were complete.






