Conducted Peak Output Power_2DH5_2402

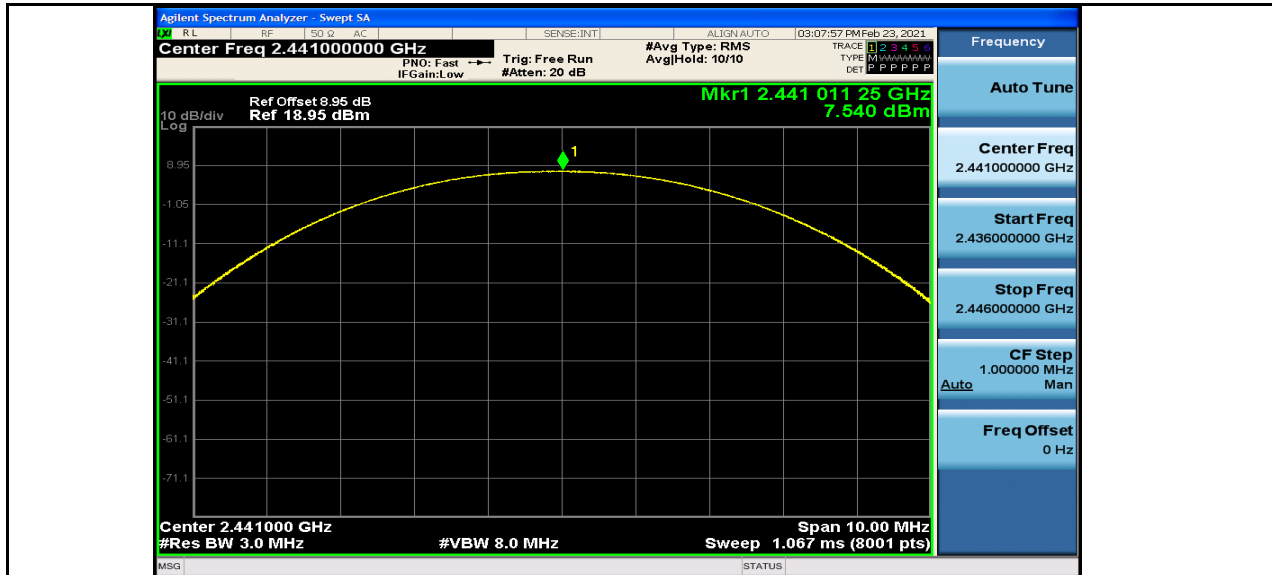

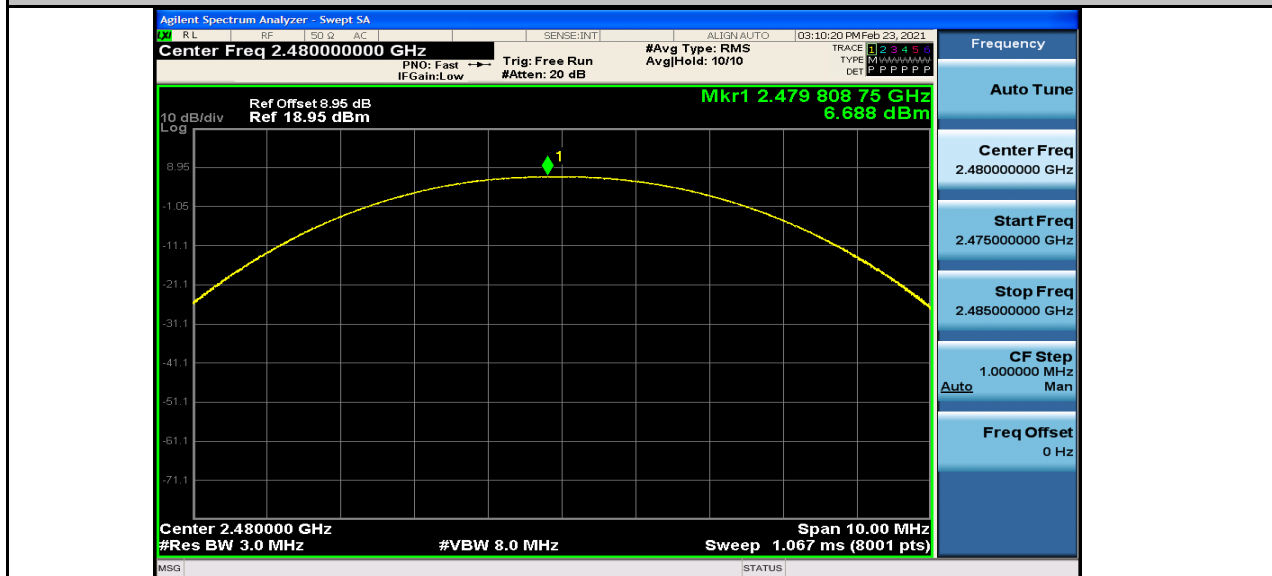

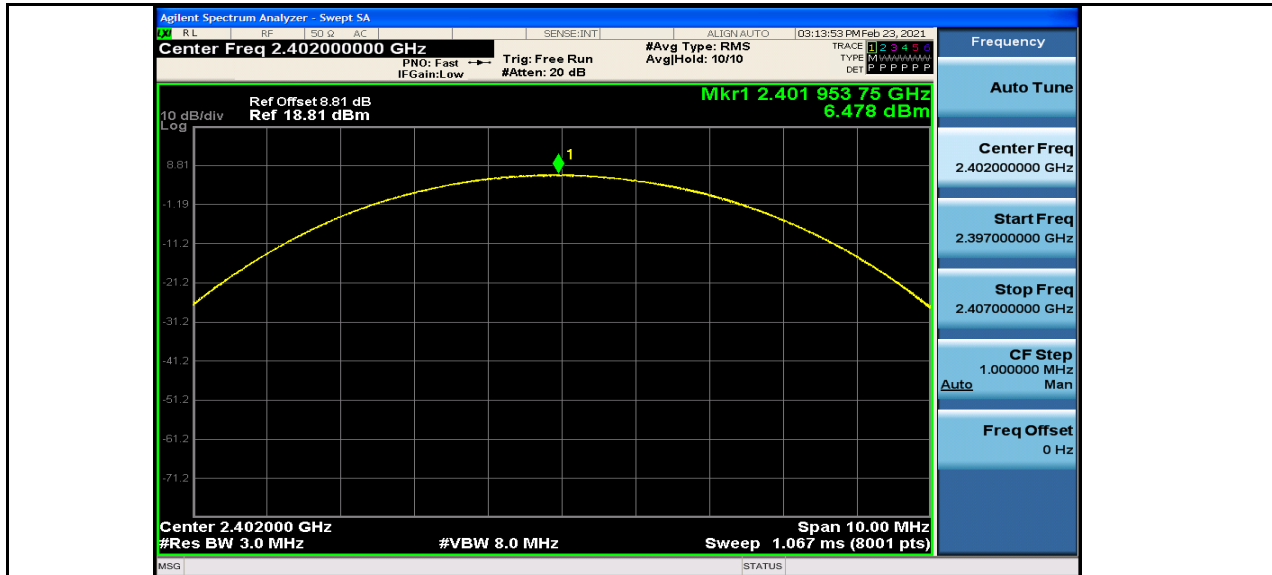
Conducted Peak Output Power_2DH5_2480



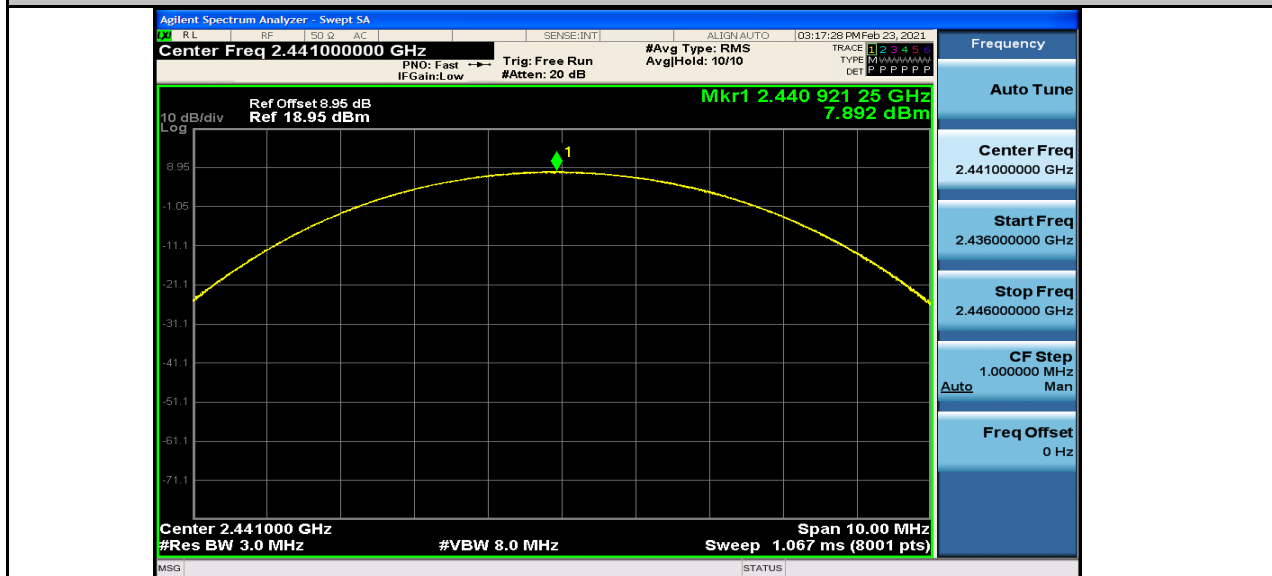

Conducted Peak Output Power_3DH5_2441

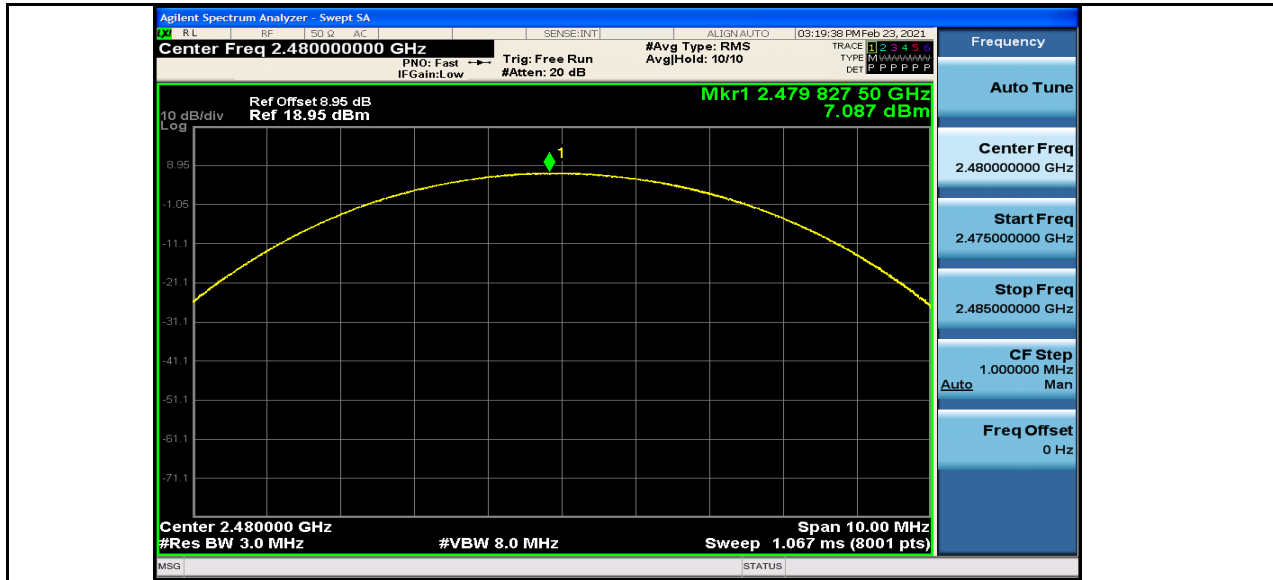
