Maximum conducted (average) output power_11G_2412_Ant1

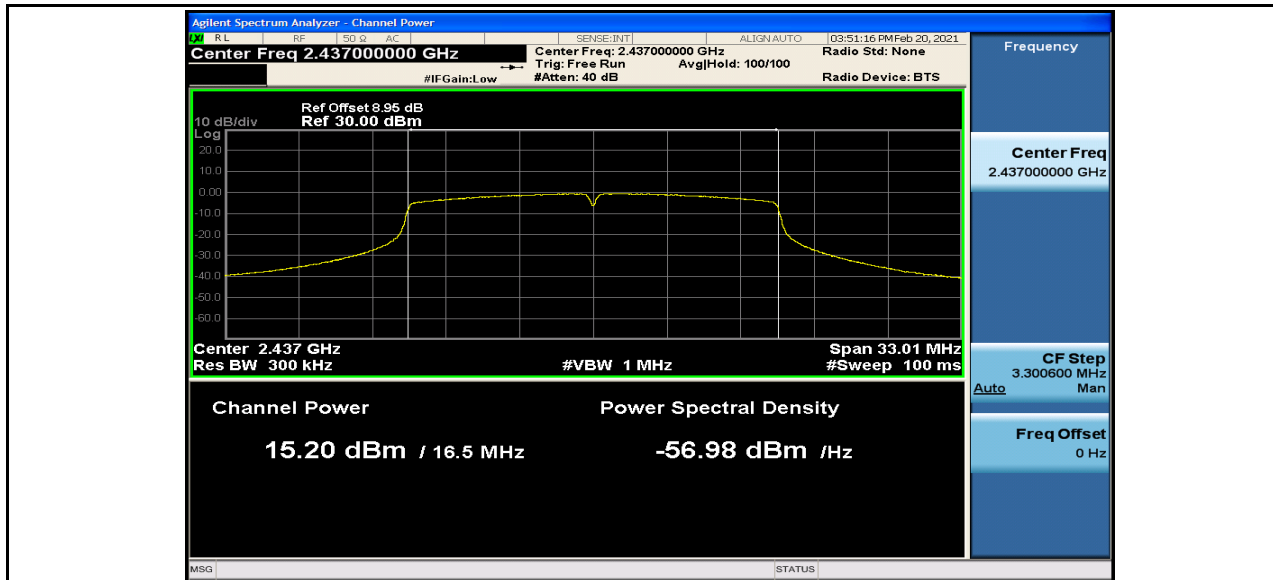
