After verification, all tests were carried out with the worst case test modes as shown below except radiated spurious emission below 1GHz, which worst case was in normal link mode only, and power line conducted emission below 30MHz, which worst case was in normal link mode.

IEEE802.11b mode: Channel Low (2412MHz), Channel Mid (2437MHz) and Channel High (2462MHz) with 1Mbps data rate were chosen for full testing.

IEEE802.11g mode: Channel Low (2412MHz), Channel Mid (2437MHz) and Channel High (2462MHz) with 6Mbps data rate were chosen for full testing.



- The test equipment EUT installed received AC main power, through a Line Impedance Stabilization Network (LISN), which supplied power source and was grounded to the ground plane. All support equipment power received from a second LISN. The two LISNs provide 50 ohm/ 50uH of coupling impedance for the measuring instrument.
- The EUT test program was started. Emissions were measured on each current carrying line of the EUT using an EMI Test Receiver connected to the LISN powering the EUT.

Test Plot IEEE 802.11b mode











IEEE 802.11g mode









Below 30MHz




Below 1 GHz

7.7. PEAK POWER SPECTRAL DENSITY MEASUREMENT

7.7.1. LIMITS

According to §15.247(e), for digitally modulated systems, the power spectral density conducted from the intentional radiator to the antenna shall not be greater than 8 dBm in any 3 kHz band during any time interval of continuous transmission.

According to §15.247(f), the digital modulation operation of the hybrid system, with the frequency hopping turned off, shall comply with the power density requirements of paragraph (d) of this section.


7.7.2. TEST PROCEDURES (please refer to measurement standard)

§15.247(e)specifies a conducted power spectral density (PSD) limit of 8 dBm in any 3 kHz band segment within the fundamental EBW during any time interval of continuous transmission. The same method as used to determine the conducted output power shall be used to determine the power spectral density (i.e.,if peak-detected fundamental power was measured then use the peak PSD procedure and if average fundamental power was measured then use the average PSD procedure).

10.2 Method PKPSD (peak PSD)

- 1. Set analyzer center frequency to DTS channel center frequency.
- 2. Set the span to 1.5 times the DTS bandwidth.
- 3. Set the RBW to: $3 \text{ kHz} \leq \text{RBW} \leq 100 \text{ kHz}$.
- 4. Set the VBW \geq 3 x RBW.
- 5. Detector = peak.
- 6. Sweep time = auto couple.
- 7. Trace mode = max hold.
- 8. Allow trace to fully stabilize.
- 9. Use the peak marker function to determine the maximum amplitude level within the RBW.
- 10. If measured value exceeds limit, reduce RBW (no less than 3 kHz) and repeat.





Test Plot


IEEE 802.11b mode




