
4.1 Output Power

- b) Connect a low loss RF cable from the antenna port to a CMW 500 by an Att.
- c) EUT Communicate with CMW 500 then selects a channel for testing.
- d) Add a correction factor to the display CMW 500, and then test.


This is the test for the maximum radiated power from the EUT.

Per §22.913(2) Extend coverage on a secondary basis into cellular unserved areas, as those areas are defined in §22.949, the ERP of base transmitters and cellular repeaters of such systems must not exceed 1000 Watts. The ERP of mobile transmitters and auxiliary test transmitters must not exceed 7 Watts. Rule Part 24.232(c) specifies, "Mobile/portable stations are limited to 2 watts e.i.r.p. Peak power" and 24.232(e) specifies that "Peak transmit power must be measured over any interval of continuous transmission using instrumentation calibrated in terms of an rms-equivalent voltage."

Per Part 27.50(d) (4) specifies, Fixed, mobile, and portable (hand-held) stations operating in the 1710-1755MHz band are limited to 1W EIRP. Fixed stations operating in this band are limited to a maximum antenna height of 10 meters above ground. Mobile and portable stations operating in this band must employ a means for limiting power to the minimum necessary for successful communications.

Per Part 27.50(c) (10)specifies, Portable stations (hand-held devices) in the 600 MHz uplink band and the 698-746 MHz band, and fixed and mobile stations in the 600 MHz uplink band are limited to 3 watts ERP. Per Part 27.50(h) (2)specifies Mobile and other user stations. Mobile stations are limited to 2.0 watts EIRP. All user stations are limited to 2.0 watts transmitter output power.

TEST PROCEDURE

- 1. EUT was placed on a 1.50 meter high non-conductive stand at a 3 meter test distance from the receive antenna. A receiving antenna was placed on the antenna mast 3 meters from the EUT for emission measurements. The height of receiving antenna is 1.50m. Detected emissions were maximized at each frequency by rotating the EUT through 360° and adjusting the receiving antenna polarization. The radiated emission measurements of all transmit frequencies in three channels (High, Middle, Low) were measured with peak detector.
- 2. A log-periodic antenna or double-ridged waveguide horn antenna shall be substituted in place of the EUT. The log-periodic antenna will be driven by a signal generator and the level will be adjusted till the same power value on the spectrum analyzer or receiver. The level of the spurious emissions can be calculated through the level of the signal generator, cable loss, the gain of the substitution antenna and the reading of the spectrum analyzer or receiver.

- 3. The EUT is then put into continuously transmitting mode at its maximum power level during the test.Set Test Receiver or Spectrum RBW=1MHz,VBW=3MHz, And the maximum value of the receiver should be recorded as (P_r).
- 4. The EUT shall be replaced by a substitution antenna. In the chamber, an substitution antenna for the frequency band of interest is placed at the reference point of the chamber. An RF Signal source for the frequency band of interest is connected to the substitution antenna with a cable that has been constructed to not interfere with the radiation pattern of the antenna. A power (P_{Mea}) is applied to the input of the substitution antenna, and adjust the level of the signal generator output until the value of the receiver reach the previously recorded (P_r). The power of signal source (P_{Mea}) is recorded. The test should be performed by rotating the test item and adjusting the receiving antenna polarization.
- 5. A amplifier should be connected to the Signal Source output port. And the cable should be connect between the Amplifier and the Substitution Antenna. The cable loss (P_{cl}) ,the Substitution Antenna Gain (G_a) and the Amplifier Gain (P_{Ag}) should be recorded after test. The measurement results are obtained as described below:

Power(EIRP)= P_{Mea} + P_{Aq} - P_{cl} + G_a

- 6. This value is EIRP since the measurement is calibrated using an antenna of known gain (2.15 dBi) and known input power.
- 7. ERP can be calculated from EIRP by subtracting the gain of the dipole, ERP = EIRP-2.15dBi.

- 1. EUT was placed on a 1.50 meter high non-conductive stand at a 3 meter test distance from the receive antenna. A receiving antenna was placed on the antenna mast 3 meters from the EUT for emission measurements. The height of receiving antenna is 1.50m. Detected emissions were maximized at each frequency by rotating the EUT through 360° and adjusting the receiving antenna polarization. The radiated emission measurements of all transmit frequencies in three channels (High, Middle, Low) were measured with peak detector.
- 2. A log-periodic antenna or double-ridged waveguide horn antenna shall be substituted in place of the EUT. The log-periodic antenna will be driven by a signal generator and the level will be adjusted till the same power value on the spectrum analyzer or receiver. The level of the spurious emissions can be calculated through the level of the signal generator, cable loss, the gain of the substitution antenna and the reading of the spectrum analyzer or receiver.
- 3. The EUT is then put into continuously transmitting mode at its maximum power level during the test.Set Test Receiver or Spectrum RBW=1MHz,VBW=3MHz, And the maximum value of the receiver should be recorded as (P_r).
- 4. The EUT shall be replaced by a substitution antenna. In the chamber, an substitution antenna for the frequency band of interest is placed at the reference point of the chamber. An RF Signal source for the frequency band of interest is connected to the substitution antenna with a cable that has been constructed to not interfere with the radiation pattern of the antenna. A power (P_{Mea}) is applied to the input of the substitution antenna, and adjust the level of the signal generator output until the value of the receiver reach the previously recorded (P_r). The power of signal source (P_{Mea}) is recorded. The test should be performed by rotating the test item and adjusting the receiving antenna polarization.
- 5. A amplifier should be connected to the Signal Source output port. And the cable should be connect between the Amplifier and the Substitution Antenna. The cable loss (P_{cl}), the Substitution Antenna Gain (G_a) and the Amplifier Gain (P_{Ag}) should be recorded after test. The measurement results are obtained as described below: $Power(EIRP) = P_{Mea} + P_{Ag} P_{cl} + G_a$
- 6. This value is EIRP since the measurement is calibrated using an antenna of known gain (2.15 dBi) and known input power.
- 7. ERP can be calculated from EIRP by subtracting the gain of the dipole, ERP = EIRP -2.15dBi.



- § 2.1055(a), 2.1055(d),
- § 22.355, the carrier frequency of each transmitter in the Public Mobile Services must be maintained within the tolerances given in Table C-1 of this section.

For Mobile devices operating in the 824 to 849 MHz band at a power level less than or equal to 3 Watts, the limit specified in Table C-1 is +/- 2.5 ppm.

- § 24.235, the frequency stability shall be sufficient to ensure that the fundamental emission stays within the authorized frequency block.
- § 27.54, the frequency stability shall be sufficient to ensure that the fundamental emission stays within the authorized bands of operation.

TEST PROCEDURE

The EUT was setup according to TIA-603-E

Frequency Stability Under Temperature Variations:

In order to measure the carrier frequency under the condition of AFC lock, it is necessary to make measurements with the EUT in a "call mode". This is accomplished with the use of R&S CMW 500 DIGITAL RADIO COMMUNICATION TESTER.

- 1. Measure the carrier frequency at room temperature.
- 2. Subject the EUT to overnight soak at -30℃.
- 3. With the EUT, powered via nominal voltage, connected to the CMW 500 and in a simulated call on middle channel for LTE band 2, LTE band 4, LTE band 5, LTE band 7 and LTE Band 17; measure the carrier frequency. These measurements should be made within 2 minutes of Powering up the EUT, to prevent significant self-warming.
- 4. Repeat the above measurements at 10° C increments from -30° C to $+50^{\circ}$ C. Allow at least 1.5 hours at each temperature, unpowered, before making measurements.
- 5. Re-measure carrier frequency at room temperature with nominal voltage. Vary supply voltage from minimum voltage to maximum voltage, in 0.1Volt increments re-measuring carrier frequency at each voltage. Pause at nominal voltage for 1.5 hours unpowered, to allow any self-heating to stabilize, before continuing. 6. Subject the EUT to overnight soak at +50°C.
- 7. With the EUT, powered via nominal voltage, connected to the CMW 500 and in a simulated call on the centre channel, measure the carrier frequency. These measurements should be made within 2 minutes of Powering up the EUT, to prevent significant self-warming.
- 8. Repeat the above measurements at 10 $^{\circ}$ C increments from +50 $^{\circ}$ C to -30 $^{\circ}$ C. Allow at least 1.5 hours at each temperature, unpowered, before making measurements
- 9. At all temperature levels hold the temperature to +/- 0.5° C during the measurement procedure.

Frequency Stability Under Voltage Variations:

According to the JTC standard the frequency stability of the carrier shall be accurate to within 0.1 ppm of the received frequency from the base station. The frequency stability shall be sufficient to ensure that the fundamental emission stays within the authorized frequency block. As this transceiver is considered "Hand carried, battery powered equipment" Section 2.1055(d)(2) applies. This requires that the lower voltage for frequency stability testing be specified by the manufacturer. This transceiver is specified to operate with an input voltage of between 3.3VDC and 4.2VDC, with a nominal voltage of 3.7DC.

TEST RESULTS

Remark:

We were tested all RB Configuration refer 3GPP TS136 521 for each Channel Bandwidth of LTE FDD Band 2, LTE FDD Band 4, LTE FDD Band 5, LTE FDD Band 7 and LTE Band 17; recorded worst case for each Channel Bandwidth of LTE FDD Band 2, LTE FDD Band 4, LTE FDD Band 5, LTE FDD Band 7 and LTE Band 17.
