The Plegium® Smart Mini Pepper Spray is a multi-function Pepper Spray that connects to your phone. Download the FREE Plegium app (available for iOS and Android) and set it up in less than a minute. All functions: Pepper Spray, location texts and phone calls activate automatically when the user presses the button. The trigger button is protected by a flip-top safety lid that prevents accidental triggering and at the same time ensures fast and safe activation. The button also has a sensory sight enabling the user to feel the direction of the nozzle. The product has an ergonomic grip that prevents the index finger from covering the spray nozzle.

It is also equipped with a quick-release magnetic keychain making it easy to have it ready when ever needed. The plastic enclosure of the product is made of 2 mm thick PC-ABS which makes it very robust and durable. The Smart Mini Pepper Spray has a 4-year no-charging battery life that ensures that the product is ready whenever needed.

#2 Location Text Messages

- A voice informs the emergency contacts that the user is in danger and that they have received a text message with the location of the incident
