<p>1. The modular transmitter must have its own RF shielding. This is intended to ensure that the module does not have to rely upon the shielding provided by the device into which it is installed in order for all modular transmitter emissions to comply with FCC limits. It is also intended to prevent coupling between the RF circuitry of the module and any wires or circuits in the device into which the module is installed. Such coupling may result in non-compliant operation. <p><i>Details: No, this RF Module has no RF shielding and therefore does not comply to this requirement. Limited Modular Approval is instead applied here because it has complied entirely with the requirements in a standalone configuration.</i></p>		
<p>2. The modular transmitter must have buffered modulation/data inputs (if such inputs are provided) to ensure that the module will comply with FCC requirements under conditions of excessive data rates or over-modulation. 15.212(a)(1)(ii)</p>	<input checked="" type="checkbox"/> - YES	<input type="checkbox"/> - NO(*)
<p><i>Details: Refer to Schematic. The modular transmitter has buffered modulation/data inputs on U100 for BLE and U202 for LoRa.</i></p>		
<p>3. The modular transmitter must have its own power supply regulation on the module. <p><i>Details: The transmitter does have internal power regulation and the Power Amplifier has its own regulator. The transmitter is powered by internal regulation from the incoming external power rail (through induction).</i></p>		
<p>4. The modular transmitter must comply with the antenna and transmission system requirements of §§ 15.203, 15.204(b), 15.204(c), 15.212(a), and 2.929(b). The antenna must either be permanently attached or employ a “unique” antenna coupler (at all connections between the module and the antenna, including the cable). <p><i>Details: The BLE antenna is an onboard antenna. The LoRa antenna is software controlled to a hardware switch to enable only one of the following at any time: onboard antenna or an external antenna with a unique PCB coupling to satisfy the above requirements. External antenna connector on the host device meets with professional installation requirements as previously described.</i></p>		
<p>5. The modular transmitter must be tested in a stand-alone configuration, i.e., the module must not be inside another device during testing. This is intended to demonstrate that the module is capable of complying with Part 15 emission limits regardless of the device into which it is eventually installed. Unless the transmitter module will be battery powered, it must comply with the AC line conducted requirements found in Section 15.207. AC or DC power lines and data input/output lines connected to the module must not contain ferrites, unless they will be marketed with the module (see Section 15.27(a)). The length of these lines shall be length typical of actual use or, if that length is unknown, at least 10 centimeters to insure that there is no coupling between the case of the module and supporting equipment. <p>6. The modular transmitter must be labeled with its own FCC ID number, or use an electron display (see KDB Publication 784748).</p> <p>If using a permanently affixed label with its own FCC ID number, if the FCC ID is not visible when the module is installed inside another device, then the outside of the device into which the module is installed must also display a label referring to the enclosed module. This exterior label can use wording such as the following: "Contains Transmitter Module FCC ID: XYZMODEL1" or "Contains FCC ID: XYZMODEL1." Any similar wording that expresses the same meaning may be used. The Grantee may either provide such a label, an example of which must be included in the application for equipment authorization, or, must provide adequate instructions along with the module which explain this requirement. In the latter case, a copy of these instructions must be included in the application for equipment authorization.</p> <p>If the modular transmitter uses an electronic display of the FCC identification number, the information must be readily accessible and visible on the modular transmitter or on the device in which it is installed. If the module is installed inside another device, then the outside of the device into which the module is installed must display a label referring to the enclosed module. This exterior label can use wording such as the following: "Contains FCC certified transmitter module(s)." Any similar wording that expresses the same meaning may be used. The user manual must include instructions on how to access the electronic display. A copy of these instructions must be included in the application for equipment authorization. 15.212(a)(1)(vi)</p> <p>Details: Module is too small to properly contain the FCC ID with font at or above 4pt font size. <p>7. The modular transmitter must comply with all specific rule or operating requirements applicable to the transmitter, including all the conditions provided in the integration instructions by the grantee. A copy of these instructions must be included in the application for equipment authorization. For example, there are very strict operational and timing requirements that must be met before a transmitter is authorized for operation under Section 15.231. For instance, data transmission is prohibited, except for operation under Section 15.231(e), in which case there are separate field strength level and timing requirements. 3. Limited Module Procedures. KDB 996369 D03, Section 2.4 a. Describe alternative means that the grantee uses to verify the host meets the necessary limiting conditions b. When RF exposure evaluation is necessary, state how control will be maintained such		

that compliance is ensured, such as Class II for new hosts, etc.

8. Information on test modes and additional testing requirements. KDB 996369 D03, Section 2.9 a. Test modes that should be taken into consideration by host integrators including clarifications necessary for stand-alone and simultaneous configurations. b. Provide information on how to configure test modes for evaluation	
9. Additional testing, Part 15 Subpart B disclaimer. KDB 996369 D03, Section 2.10	and is approved <u>ONLY</u> for use by the grantee in <u>their own products</u> , and not intended for sale to 3 rd parties as provided in a separate cover letter. Therefore the information shown to the left is found in the theory of operation.
